

- ✓ Exports to the US increased to \$76.11 billion in 2021-22 from \$51.62 billion in previous fiscal year. Also, imports rose to \$43.31 billion as compared to about \$29 billion in 2020-21.
- ✓ India's two-way commerce with China aggregated at \$115.42 billion as compared to \$86.4 billion in 2020-21
- ✓ In 2021-22, the UAE with \$72.9 billion, was the third largest trading partner of India
- ✓ It was followed by Saudi Arabia (\$42,85 billion), Iraq (\$34.33 billion) and Singapore (\$30 billion).

- ✓ Union Bank of India was second with an 11.99 per cent growth in deposits (Rs 10,32,102 crore) while Indian Bank recorded a 10 per cent increase at Rs 5,84,661 crore.
- ✓ Total business growth of BoM was also the highest at 20 per cent at Rs 3,37,534 crore followed by Union Bank of India at 11.04 per cent at Rs 17,31,371 crore at the end of FY'22.

- ✓ This project is a part of the first construction facility by international banks in Adani Green with the capacity of 5.8 GW. The target of total renewable portfolio is 45 GW till 2030.

- ✓ A passbook of PM CARES for Children, and health card under Ayushman Bharat Pradhan Mantri Jan Arogya Yojana was handed over to the children during the programme.
- ✓ PM CARES for Children Scheme was launched by the Prime Minister on 29 May 2021.
- ✓ The aim was to support children who have lost both the parents or legal guardian or adoptive parents or surviving parent to Covid-19 pandemic, during the period from 11 March 2020 to 28 February 2022.
- ✓ Government has announced "PM-CARES for Children" scheme under which fixed deposits will be opened in the names of such children from the PM-CARES fund.
- ✓ The total corpus of fund will be Rs 10 lakh for each child.
- ✓ This corpus will be used to give a monthly financial support/ stipend when the child reaches 18 years of age, for the next five years to take care of his or her personal requirements.
- ✓ Upon reaching the age of 23 years, the child will get the corpus amount as one lump sum for personal and professional use.
- ✓ Each child will be enrolled as a beneficiary under Ayushman Bharat Scheme (PM-JAY) with a health insurance cover of Rs 5 lakh.
- ✓ The premium amount for these children will be paid by PM CARES, till they attain age of 18 years.

- ✓ Under NSM, till date 15 supercomputers have been installed across the nation with aggregate compute capacity of 24 petaflops.

- ✓ Till 2015, total resources of primary gold ore were estimated at 501.83 million tonnes with 654.74 tonnes of gold metal.
- ✓ Out of this Bihar is endowed with 222.885 million tonnes (44 per cent) of ore containing 37.6 tonnes of metal.
- ✓ GSI is a scientific agency of Government of India. It was founded in 1851. Its headquarter is in Kolkata.
