- ✓ The school will be advancing knowledge in the key thrust areas of climate change mitigation, artificial intelligence and space technology, energy transition and industrial transformation, circular and regenerative economy among others
- ✓ Greenko is working in consultation with the Ministry of Education, AICTE, NCERT, and NCVET to ensure GSSST both conforms to and advances learning in sustainable science and technology.

#### Answer : A

- Recently, the Indian Space Research Organisation (ISRO) achieved the feat of successfully launching the PSLV Orbital Experimental Module or 'POEM'.
- ✓ Besides this achievement, ISRO also launched three satellites from Singapore on the PSLV-C53.
- ✓ This was the second Polar Satellite Launch Vehicle(PSLV) mission of the year. In February 2022, ISRO launched PSLV-C52 with the Earth observation satellite EOS-04 and two smaller satellites.
- This was the second dedicated commercial mission of NewSpace India Limited (NSIL), the commercial arm of ISRO

#### ✓ What is POEM?

- ✓ The PSLV Orbital Experimental Module is a platform that will help perform in-orbit experiments using the final, and otherwise discarded, stage of ISRO's Polar Satellite Launch Vehicle (PSLV)
- ✓ PSLV: The PSLV is a four-stage rocket where the first three spent stages fall back into the ocean, and the final stage (PS4) — after launching the satellite into orbit — ends up as space junk.
- ✓ However, in the PSLV-C53 mission, the spent final stage will be utilised as a "stabilised platform" to perform experiments.
- Payloads : POEM is carrying six payloads, including two from Indian space start-ups Digantara (for making the map of space radiations, debris, and orbits) and Dhruva Space (for full-stack satellite development, launch, deployment, operation and maintenance services)
- ✓ Significance: The inclusion of the two laid the ground for more public-private partnerships, to be facilitated by the Indian National Space Promotion and Authorization Center (IN-SPACe).
- ✓ IN-SPACe is a nodal agency appointed by the Department of Space, which can authorize a nongovernment entity to use ISRO's infrastructure and resources, including ISRO's launch facilities.
- ✓ Has ISRO repurposed and used PS4 rocket junk earlier?
- ✓ The Indian space agency first demonstrated the capability of using PS4 as an orbital platform in 2019 with the PSLV-C44 mission
- PSLVs launch the satellites useful for Earth resources monitoring whereas GSLVs are designed mainly to launch communication satellites.
- ✓ Indian Space Research Organisation (ISRO)

- ✓ Udupi Ramachandra Rao : satellite Man of India
- ✓ Rakesh Sharma became the first Indian to orbit in space in the year 1984.
- ✓ Kalpana Chawla, the first Indian origin woman to go to space is related to Karnal district of Haryana.
- ✓ Yuri Gagarin was the first person to go into space.
- ✓ Neil Armstrong was the first person to land on the Moon.
- ✓ Rohini (RS-1) was an experimental satellite launched by the ISRO.
- ✓ It was launched by the Satellite Launch Vehicle-3 rocket (SLV-3) on July 18, 1980.
- ✓ Satish Dhawan Space Centre is located in Sriharikota in Andhra Pradesh.
- Vikram Sarabhai was the first chairman of the Indian Space Research Organisation (ISRO) from 1963 to 1972.

- ✓ The Cabinet Appointments Committee (ACC) has passed a government resolution to establish the Financial Services Institutions Bureau (FSIB) in place of the Banks Board Bureau (BBB).
- ✓ The new framework was proposed by the Department of Financial Service, Ministry of Finance.
- ✓ What is the Financial Services Institutions Bureau?
- The Financial Services Institutions Bureau will select the chiefs of public sector banks and insurance companies.

- The FSIB will have the clear mandate to issue guidelines and select general managers and directors of state-run non-life insurers, general insurers and Financial Institutions.
- ✓ FSIB will be the single entity for making recommendations for appointments of WTD (Whole-time Director) and NEC (Non-executive Chairman) in Public Sector Banks, India Private Limited company and Financial Institutions.
- The Department of Financial Services shall first carry out necessary modifications in the Nationalised Banks (Management and Miscellaneous Provisions) Scheme of 1970/1980 (as amended).
- Chairman of FSIB: The ACC has approved the appointment of Bhanu Pratap Sharma as Initial chairperson of FSIB for two years. He was the former Chairman of BBB.
- ✓ What is Financial Institution (FI)?
- ✓ A financial institution is an umbrella term for a company dealing with financial and monetary transactions, including loans, deposits, and/or investments.
- ✓ All India Financial Institutions (AIFIs) are regulated and supervised by the Reserve Bank of India.
- ✓ Examples:
- ✓ National Bank for Financing Infrastructure and Development (NaBFID)
- ✓ Export-Import Bank of India (EXIM Bank)
- ✓ National Bank for Agriculture and Rural Development (NABARD)
- ✓ National Housing Bank (NHB)
- ✓ Small Industries Development Bank of India (SIDBI)

- As per the agreement, AAI will operate and manage the airports and provide all necessary services. Communication Navigation Surveillance/Air Traffic Management (CNS/ATM) services will also be provided by AAI.
- ✓ AAI will also be responsible for obtaining and maintaining of aerodrome license for these five airports.
- At present, Uttar Pradesh has eight operational airports, while 13 airports and seven airstrips are being developed. The operational airports handling commercial flights in Uttar Pradesh are Lucknow, Varanasi, Kushinagar, Gorakhpur, Agra, Kanpur, Prayagraj and Hindon (Ghaziabad).
- ✓ Uttar Pradesh to become first Indian state to have 5 international airports
- ✓ Chaudhary Charan Singh International Airport (Amausi Airport) Lucknow, Uttar Pradesh
- ✓ Lal Bahadur Shastri International Airport (Babatpur Airport) : Varanasi, Uttar Pradesh
- ✓ Kushinagar International Airport : Kushinagar, Uttar Pradesh

- ✓ If the amount exceeds, the individuals will now have 3 months to inform the government against 30 days earlier.
- ✓ The amended rule also gives more time to the organizations to inform the government about opening of bank accounts for utilization of funds received under 'registration' or 'prior permission' category


