- ✓ India's largest floating Solar Power Project became fully operational at Ramagundam in Telangana (100 MW capacity)

- ✓ According to the 'Asia Pacific Sustainability Index 2021' released by Knight Frank, an international property consultant based in London, UK, four Indian cities made it to the top 20 of the Asia Pacific (APAC) Sustainably Led Cities Index Ranking.
- ✓ Bengaluru ranked 14th in the list of top 20 cities in the APAC region in the Gold standard category in terms of compliance with sustainability norms in the development of commercial real estate. Delhi is at 17th, Hyderabad at 18th and Mumbai 20th positions in Silver standard category.
- ✓ The top five green-rated cities in the APAC region are Singapore, Sydney (Australia), Wellington (New Zealand), Perth (Australia), and Melbourne (Australia). These five cities earned the Platinum category, the highest category of the index.
- ✓ The report also noted that India's green bond issuances increased 523% on a yearly basis, from \$1.1 billion in 2020 to \$6.8 billion in 2021.
- ✓ Green bond issuances that were negatively impacted by the pandemic in 2020 recovered in 2021, surpassing pre-pandemic levels and posting an increase of 116.9% from \$3.1 billion raised in 2019

- ✓ Two complementary loans totaling \$500 million each were authorized by the World Bank Board of Executive Directors to help and develop the health sector in India.
- ✓ Through this combined financing of \$1 billion, the World Bank is looking to assist the Pradhan Mantri-Ayushman Bharat Health Infrastructure Mission (PM-ABHIM), which was launched by the government in October 2021 for the development the public healthcare infrastructure across the country.
- ✓ Along with the involvement at the national level, one of the loans is meant to provide priority to the states of Andhra Pradesh, Kerala, Meghalaya, Odisha, Punjab, Tamil Nadu, and Uttar Pradesh for the improvement of their current medical infrastructure.
- ✓ Under health, two loans-Public Health Systems for Pandemic Preparedness Programme (PHSPP) and Enhanced Health Service Delivery Programme (EHSDP) are designed to be complementary and transformational in impact.
- ✓ PHSPP and EHSDP loans have a combined final term of 18.5 years, including a 5-year grace period.

- ✓ The investment in the plant will be made for 16 months and will directly or indirectly create over 2,000 employment opportunities with a majority of them being women employees.
- ✓ Tata Power also has a manufacturing unit in Bangalore, which has a production capacity of 635 megawatts of modules and 500 megawatts of cells.

- ✓ The PSLV Orbital Experimental Module is a platform that will help perform in-orbit experiments using the final, and otherwise discarded, stage of ISRO's Polar Satellite Launch Vehicle (PSLV)
- ✓ PSLV: The PSLV is a four-stage rocket where the first three spent stages fall back into the ocean, and the final stage (PS4) — after launching the satellite into orbit — ends up as space junk.
- ✓ However, in the PSLV-C53 mission, the spent final stage will be utilised as a "stabilised platform" to perform experiments.
- ✓ **Payloads** : POEM is carrying six payloads, including two from Indian space start-ups Digantara (for making the map of space radiations, debris, and orbits) and Dhruva Space (for full-stack satellite development, launch, deployment, operation and maintenance services)
- ✓ **Significance:** The inclusion of the two laid the ground for more public-private partnerships, to be facilitated by the Indian National Space Promotion and Authorization Center (IN-SPACe).
- ✓ IN-SPACe is a nodal agency appointed by the Department of Space, which can authorize a non-government entity to use ISRO's infrastructure and resources, including ISRO's launch facilities.
- ✓ Has ISRO repurposed and used PS4 rocket junk earlier?
- ✓ The Indian space agency first demonstrated the capability of using PS4 as an orbital platform in 2019 with the PSLV-C44 mission
