

- National Mission for Clean Ganga (NMCG) was registered as a society on 12th August 2011 under the Societies Registration Act 1860
- The mission was implemented by the National Council for Rejuvenation and the National Ganga Council.
- The National Mission for Clean Ganga under National Ganga Council is supported by the state-level programme management groups in the state of Uttar Pradesh, Uttarakhand, Bihar, Jharkhand, and West Bengal.
- ✓ Namami Gange Programme:
- ✓ It was launched as a 'Flagship Programme' in June 2014 by the Union Government.
- The aim of the mission was the effective abatement of pollution and conservation and rejuvenation of the National River Ganga.
- The mission comes under the aegis of the Department of Water Resources, River Development, and Ganga Rejuvenation, Ministry of Jal Shakti.


