

- ✓ Special Window for Affordable and Mid-Income (SWAMIH)
- ✓ In November 2019, the Union Finance Ministry announced creation of a Special Window for Affordable and Mid-Income Housing (SWAMIH) to provide debt financing for the completion of stressed, brownfield and residential projects registered with regulatory bodies that fall in the affordable, mid-income housing category.
- ✓ The corpus of the Fund is Rs 12,500 crore with a green shoe option of Rs 12,500 crore. Green Shoe options means that if required an additional Rs 12,500 crore fund will be raised for the SWAMIH scheme.
- The Sponsor of the Fund is the Secretary, Department of Economic Affairs, Ministry of Finance, and Government of India on behalf of the Government of India.
- ✓ The Investment Manager of the Fund is SBICAP Ventures Ltd which is owned by State Bank of India.

- ✓ As his last assignment, he was in charge of Strategy, Planning and Business Development at the Corporate Office of Canara Bank.
- ✓ He successfully handled the project of amalgamation of Syndicate Bank into Canara Bank.
- ✓ About the NABARD
- \checkmark It is a development bank focussing primarily on the rural sector of the country.
- It is a statutory body established in 1982 under National Bank for Agriculture and Rural Development Act, 1981.
- ✓ Established on the recommendations of Shivaraman Committee.

- ✓ Prime Minister Narendra Modi who is on a two day (11-12 December 2022) visit to Maharashtra , Goa and Gujarat inaugurated a number of projects in Maharashtra including the 6th Vande Bharat Express train on 11 December 2022.
- ✓ He inaugurated the 6th Vande Bharat Express which will run on Bilaspur (Chhattisgarh)-Nagpur (Maharashtra) route. This is the second Vande Bharat express in the state after the Mumbai-Ahmedabad Vande Bharat express.
- ✓ Vande Bharat is an indigenous semi-high speed train developed by Indian Railways. Government proposes to run 75 Vande Bharat express trains in the country by 15 August 2023.
- ✓ He inaugurated the Hindu Hrudaysamrat Balasaheb Thackeray Maharashtra Samruddhi Mahamarg connecting Nagpur and Shirdi. Built at a cost of ₹55,000 crore, it is one of the longest expressways in the country that passes through 10 Maharashtra districts, including Amravati, Aurangabad and Nashik.

 India is currently the President of the G-20 and it will hold the G-20 summit meeting in September 2023 in New Delhi

- India ranked 87 in the world's strongest passport list, while UAE ranked first in the rating of passports for 2022.
- ✓ UAE was followed by Germany, Sweden, Finland, Luxembourg, Spain and France.
- ✓ Afghanistan remained at the last position while Pakistan was ranked 94th
- ✓ Japan ranked 24th because it had easy access to 171 countries.
- Earlier this year, Japan's passport was ranked as the best passport in the world in a list released by Henley & Partners.
- ✓ Passport Index 2022 published by Arton Capital ranked the world's strongest and weakest passports.
- ✓ Travellers with UAE passports can enter 180 countries without any hassle.
- Except European countries like Germany and Sweden, there are more than 7 such countries which are in this index.
- ✓ The Passport Index is based on the 139 members of the United Nations. 6 different aspects have been considered to make this list.
- \checkmark The data for this list has been given by the governments of different countries.
- ✓ To make this list, work is done on 3 steps, which rates on the basis of Mobility Score (MS).
- ✓ This also includes the VF portion of Visa-free (VF), Visa on Arrival (VOA), eTA and eVisa (if issued within 3 days).

- The Ministry of New and Renewable Energy has advised that all residential consumers should not pay extra amount to any company for applying on the National Portal, nor should they pay more than the amount fixed by the concerned distribution company for metre and testing.
- ✓ Under this program, the central government gives a subsidy of Rs 14,588 per kilowatt to a person who installs solar panels on the roof of his house.
- ✓ About Rooftop Solar Scheme
- The Ministry of New and Renewable Energy is implementing the Grid Connected Rooftop Solar Scheme (Phase II) to generate solar power by installing solar panels on the roof of houses.
- Phase II aims to achieve a cumulative capacity of 40,000 MW from Rooftop Solar Projects by the year 2022.
- ✓ The objective of the programme is to promote the grid-connected SPV rooftop and small SPV power generating plants among the residential, community, institutional, industrial and commercial establishments.
- To ease the implementation of the scheme, a National Portal was developed, which was launched by PM Modi on 30 July 2022.
- ✓ The central government has set a target of 450 GW of renewable energy generation by 2030.
- ✓ Under this, many schemes are also going on, in which a target has been set to provide more than 17 lakh solar pumps to farmers in the country through Pradhan Mantri-Kusum Yojana.
- The government on 8 December said the rooftop solar programme has been extended till March 31, 2026, and therefore, subsidy under the programme will be available until the target for the scheme is achieved.

✓ The Government of India has appointed Tata Sons Chairman N Chandrasekaran as the chairman of the B20 to lead the business agenda during India's G20 presidency. India took over the presidency of

G-20 from Indonesia on 1 December 2022 and will hold the G-20 Summit meeting on 9-10 September 2023.

- ✓ The government has also appointed the Confederation of Indian Industry (CII) as the B20 India Secretariat. B20 is the voice of the G20 business community and helps in shaping economic policy statements by the G20 grouping over the years.
- ✓ B20 India work will be conducted through Task Forces and Action Councils, which will develop consensus-based policy recommendations to the G20. It will commence work on various task forces and action councils after the inception meeting, scheduled on 22-24 January 2023, culminating into the B20 India Summit in August 2023.
- ✓ B20 India has identified priorities for deliberations under the theme "R.A.I.S.E Responsible, Accelerated, Innovative, Sustainable, and Equitable Businesses. About 100 business policy initiatives will be organised by CII under the B20 calendar across the country during the presidency year.



- India also has the potential to reduce greenhouse gas emissions significantly and create nearly 3.7 million jobs.
- ✓ The report states that India is experiencing higher temperatures every year. India is likely to see a drastic reduction in the expected carbon-dioxide (CO2) levels over the next two decades.
- ✓ The report states that by 2030, more than 160-200 million people across the country could be exposed to deadly heat waves annually if alternative and innovative energy-efficient technologies are not adopted.
- The report states that around 34 million people in India will face job losses due to loss of productivity related to heat stress.

- The participants, who included more than 30 ministers and representatives of more than 40 countries from around the world in the fields of human, animal and environmental health, adopted the Muscat Manifesto to commit to working towards achieving three goals.
- The first of these is to reduce the total amount of antimicrobials used in the agri-food system by at least 30-50 percent from the current level by 2030
- The third goal is to ensure that antibiotics included in the Access group make up at least 60 percent of total antibiotic consumption in humans by 2030.
