- ✓ Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD)
- ✓ The Government of India launched the PRASAD scheme in the year 2014-2015 under the Ministry of Tourism. This scheme focuses on developing and identifying pilgrimage sites across India for enriching the religious tourism experience. Under this scheme the Central government provides assistance to the state government.
