- ✓ It started functioning from the premises of Gujarat Fisheries Research Center in 2018.
- ✓ NACP was established to provide intensive and high level training to Marine Police of nine Coastal States, five Union Territories as well as Central Police Forces.
- ✓ The Center has sanctioned Rs 441 crore to develop NACP with modern infrastructure, latest technology and state-of-the-art training facilities to enhance the security of the coastal borders.
- ✓ The establishment of the National Academy of Coastal Policing highlights the government's commitment to strengthening coastal security measures.

- ✓ The Reserve Bank of India has decided to withdraw the ₹2000 denomination banknotes from circulation but they will continue to remain as legal tender.
- ✓ It has advised banks to stop issuing ₹2000 denomination banknotes with immediate effect.
- ✓ The withdrawal of ₹2,000 banknote aligns with the RBI's Clean Note Policy, an initiative aimed at ensuring the circulation of clean and high-quality banknotes throughout India.
- ✓ The ₹2000 denomination banknote was introduced in November 2016 under Section 24(1) of RBI Act, 1934.
- ✓ Primarily to meet the currency requirement of the economy in an expeditious manner after the withdrawal of legal tender status of all ₹500 and ₹1000 banknotes in circulation at that time.
- ✓ ₹2000 currency note will remain legal tender after 30th September too. RBI expects that 4 month time is enough for people to exchange notes with the banks.
