- ✓ The Reserve Bank of India has issued revised classification, valuation and operation guidelines for the investment portfolio of commercial banks, which will be effective from April 1, 2024.
- ✓ Banks will have to categorize investments into three categories from the next financial year: available for sale (AFS), held to maturity (HTM), and a new category called 'fair value through profit and loss', or FVTPL.



- ✓ The existing held-for-trading (HFT) category will become a sub-category of the FVTPL.
- ✓ The revised directions include principle-based classification of the investment portfolio, tightening of regulations around transfers to/from held to maturity (HTM) category and sales out of HTM, inclusion of non-SLR (statutory liquidity ratio) securities in HTM subject to fulfillment of certain conditions and symmetric recognition of gains and losses.
- ✓ The revised Directions shall apply to all commercial banks (excluding Regional Rural Banks) from the financial year commencing on April 1, 2024.
