- ✓ The Union Ministry of Environment, Forest and Climate Change declared Veerangana Durgavati Tiger Reserve as the 7th Tiger Reserve of Madhya Pradesh.
- ✓ The primary objective is to ensure better conservation efforts for the wildlife of the area.
- ✓ There are now a total of 55 designated tiger reserves in India.
- ✓ Earlier the 54th Tiger Reserve was Dholpur-Karauli Tiger Reserve in Rajasthan.
- ✓ Madhya Pradesh was already home to six tiger reserves: Kanha, Bandhavgarh, Satpura, Pench, Panna and Sanjay-Dubri.
- ✓ Veerangana Durgavati Tiger Reserve:
- ✓ Veerangana Durgavati Tiger Reserve was established as per the conditions laid down by the Central Government while approving the Ken-Betwa River Linking Project.
- ✓ Madhya Pradesh was entrusted with the task of merging Nauradehi and Durgavati wildlife sanctuaries to create this sanctuary.
- ✓ In June 2023, the combined area spanning Sagar, Damoh and Narsinghpur districts was officially notified as the Veerangana Durgavati Tiger Reserve.
- ✓ The reserve covers approximately 2,339 square kilometers, comprising 1,414 square kilometers of core area and 925.12 square kilometers of the buffer zone.
- ✓ Tiger Population in India
- ✓ India is home to a significant portion, approximately 75%, of the global wild tiger population.
- ✓ Russia is second only to India in terms of the second-largest population of wild tigers.
- ✓ Tiger population in states
- ✓ Madhya Pradesh leads with the largest population of tigers in India with 785 tigers.
- ✓ Karnataka and Uttarakhand stand second with 563 and 560 tigers respectively.

- ✓ Jim Corbett Tiger Reserve has the highest tiger population with 260 tigers.
- ✓ Other notable reserves include Bandipur (150), Nagarhole (141), Bandhavgarh (135), Dudhwa (135), Mudumalai (114), Kanha (105), Kaziranga (104), Sunderbans (100), Tadoba (97), Sathyamangalam. (85), and screw (77).
- ✓ Largest and smallest tiger reserves in India
- ✓ Nagarjunasagar Srisailem Tiger Reserve in Andhra Pradesh is the largest tiger reserve in terms of area.
- ✓ Bor Tiger Reserve of Maharashtra holds the title of the smallest tiger reserve in terms of area.

TIGER RESERVE IN NEWS 2023

- Veerangana Durgavati Tiger Reserve becomes the 7th tiger reserve of Madhya Pradesh and 55th in India.
- India got its 54th tiger reserve in Rajasthan's Karauli and Dholpur districts with the National Tiger Conservation Authority (NTCA) approving a proposal
- A seven-month-old female tiger cub was found dead under suspicious circumstances at Bandhavgarh Tiger Reserve, Madhya Pradesh.
- Bihar government to constitute 'Rhino Task Force' for suggesting measures for the reintroduction of rhino conservation scheme in 'Valmiki Tiger Reserve' in West Champaran district.
- India's Tiger Population Reaches 3,925 with 6.1% Annual Growth Rate, Holds 75% of Global Wild Tiger Population.
- A photo of an elephant taken at the Anamalai Tiger Reserve (ATR) in Tamil Nadu has emerged as the winner of the Siena Drone Photo Awards 2023.
- According to the latest tiger census data released by Prime Minister Narendra Modi, the number of tigers in India is set to reach 3,167 in 2022.
- Bandipur Tiger Reserve, Karnataka completed 50 years as a Project Tiger Reserve 1 April 2023.

- It is located in Tamilnadu.
- Project Tiger is a tiger conservation programme launched on April 1, 1973 by the Government of India during Prime Minister Indira Gandhi's tenure.
- Madhya Pradesh has the most number of tiger reserves with six in total.
- The national animal of India is the magnificent Royal Bengal Tiger. Its scientific name is Panthera.

- ✓ The Reserve Bank of India (RBI) has cancelled the licence of Mumbai-based “The Kapol Co-operative Bank Limited.
- ✓ The bank with its present financial position would be unable to pay its present depositors in full; and public interest would be adversely affected if the bank is allowed to carry on its banking business any further.
- ✓ On liquidation, every depositor would be entitled to receive deposit insurance claim amount of his/her deposits up to a monetary ceiling of ₹5 lakh from Deposit Insurance and Credit Guarantee Corporation (DICGC) subject to the provisions of DICGC Act, 1961.
- ✓ As per the data submitted by the bank, 96.09 per cent of the depositors are entitled to receive full amount of their deposits from DICGC.
- ✓ As on July 24, 2023, DICGC has already paid ₹230.16 crore of the total insured deposits under the provisions of Section 18A of the DICGC Act, 1961 based on the willingness received from the concerned depositors of the bank, according to the central bank.



RBI CANCELED LICENSE IN NEWS 2023

- Reserve Bank of India (RBI) has cancelled the licence of Mumbai-based “The Kapol Co-operative Bank Limited.
- Reserve Bank of India (RBI) has canceled the license of United India Co-operative Bank, a bank in Uttar Pradesh.
- RBI Cancels Certificate of Registration of 7 NBFCs and Surrender Permits of 14 NBFCs.
- RBI Cancels Registration of Four NBFCs, 11 Surrender Certificates.
- RBI Grants Non-Banking Institution License to Mahalaxmi Cooperative Bank in Dharwad, Karnataka , Cancels Banking Permit.
- Equitas Holdings Ltd, a prominent non-banking financial company (NBFC) in India, has voluntarily surrendered its NBFC licence to the Reserve Bank of India (RBI).
- RBI cancelled the registration of Pune-based Kudos Finance and Investments and Mumbai-based Credit Gate for regulatory lapses in lending practices.
- Reserve Bank of India (RBI) due to insufficient capital and earning potential revoked the licence of Madhya Pradesh’s Garha Co-operative Bank, Guna.

- ✓ The central bank imposed Rs 1.30 crore on SBI, Rs 1.62 crore penalty on IB, Rs 1 crore on Punjab & Sind Bank, and Rs 8.80 lakh on Fedbank Financial Services.
- ✓ RBI has imposed a monetary penalty of ₹1.30 Crore on SBI for non-compliance with certain directions issued by RBI on ‘Loans and Advances – Statutory and Other Restrictions’ and ‘Guidelines on Management of Intra-Group Transactions and Exposures’. This penalty has been imposed in exercise of powers vested in RBI conferred under the provisions of Section 47A(1)(c) read with Sections 46(4)(i) and 51(1) of the Banking Regulation Act, 1949.

- ✓ RBI has imposed a monetary penalty of ₹1.00 crore on Punjab & Sind Bank for non-compliance with the provisions of sub-section (2) of Section 26A of the Banking Regulation Act, 1949 (BR Act) read with directions issued by RBI on 'The Depositor Education and Awareness Fund Scheme, 2014-Section 26A of Banking Regulation Act, 1949-Operational Guidelines'. This penalty has been imposed in exercise of powers vested in RBI under the provisions of Section 47A(1)(c) read with Sections 46(4)(i) and 51(1) of the BR Act.
- ✓ RBI has imposed a monetary penalty of ₹1.62 crore on Indian Bank for non-compliance with certain directions issued by RBI on 'Loans and Advances – Statutory and Other Restrictions', 'Reserve Bank of India [Know Your Customer (KYC)] Directions, 2016' and 'Reserve Bank of India (Interest Rate on Deposits) Directions, 2016'. This penalty has been imposed in exercise of powers vested in RBI conferred under the provisions of Section 47 A (1) (c) read with Sections 46 (4) (i) and 51(1) of the Banking Regulation Act, 1949.

RBI IMPOSED PENALTY IN NEWS 2023

- RBI has imposed monetary penalties on three banks, State Bank of India, Indian Bank and Punjab & Sind Bank, and Fedbank Financial Services for rule violations.
- RBI has imposed late submission fees amounting to ₹2,000 crore on four major public sector undertakings namely, ONGC Videsh Ltd, Indian Oil Corp. Ltd, GAIL (India) Ltd, and Oil India Ltd for failing to promptly report their overseas investments.
- RBI has imposed penalties on Standard Chartered Bank, four credit bureaus, and seven cooperative banks for various violations. Standard Chartered Bank was fined ₹30 lakh for non-compliance with KYC directions.
- RBI has imposed a monetary penalty of Rs 2.5 crore on Jammu & Kashmir Bank for non-compliance with certain directions issued by the RBI.
- Reserve Bank of India (RBI) has imposed a monetary penalty of Rs 2.20 crore on Indian Overseas Bank (IOB) for violating various rules and regulations.
- Reserve Bank of India (RBI) imposed a monetary penalty of Rs 1.73 crore on the Hongkong and Shanghai Banking Corporation Ltd (HSBC Bank) for violating the Credit Information Companies Rules, 2006.
- RBI Imposes Rs 84.50 Lakh Penalty on Central Bank of India for Non-Compliance with Fraud Reporting Norms.

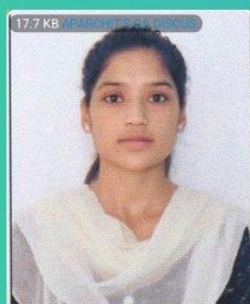
