- ✓ The central government has increased the minimum support price (MSP) of wheat by Rs 150 to Rs 2,275 per quintal for the 2024-25 marketing season.
- \checkmark This is the biggest increase in the minimum support price of wheat since 2014.
- This decision was taken in the meeting of the Cabinet Committee on Economic Affairs (CCEA) chaired by Prime Minister Modi.
- ✓ Besides, the Minimum Support Price (MSP) for five other rabi crops -- gram, barley, lentil (masur), rapeseedmustard seed and safflower -- have been hiked
- ✓ Among rabi pulses, the MSP of gram has been increased by Rs 105 to Rs 5,440 per quintal for 2024-25 as against Rs 5,335 per quintal in 2023-24 while that of lentil (masur) has been hiked by Rs 425 to Rs 6,425 per quintal from Rs 6,000 per quintal.
- ✓ In order to promote oilseeds cultivation, the government increased rapeseed-mustard seed MSP by Rs 200 to Rs 5,650 per quintal for 2024-25 marketing season, from Rs 5,450 per quintal in 2023-24 season.
- ✓ The MSP of safflower has been increased by Rs 150 to Rs 5,800 per quintal for 2024-25 from Rs 5,650 per quintal

- ✓ India wants to push developed nations to become carbon negative rather than carbon neutral by 2050, arguing that would allow emerging market economies more time to use fossil fuels for development needs.

- ✓ India, which is resisting calls to commit to a deadline for phasing out its own use of coal and other fossil fuels, is set to make its proposal at the COP28 climate summit in Dubai later this year.
- ✓ The rich countries should become net negative emitters before 2050 to enable the world to achieve the target of global net-zero by that year while allowing developing nations to use the available natural resources for growth.
- Developed countries including the United States, Britain, Canada, and Japan are targeting net zero by 2050.
 China has committed to net zero by 2060 while India has committed to reaching that goal by 2070.
- ✓ India has committed to operating half of its installed power capacity with non-fossil sources and cutting the ratio of greenhouse emissions to gross domestic product to 45% of its 2005 level by 2030.
- ✓ COP28 is scheduled to take place between Nov 30 and Dec 12.

- ✓ The RBI has imposed a penalty of ₹1 crore on Union Bank of India for non-compliance with directions on 'Loans and Advances - Statutory and Other Restrictions.
- ✓ Examination of the financials for FY21 revealed that the bank sanctioned a term loan to a corporation in lieu of or to substitute budgetary resources envisaged for certain projects, and without undertaking due diligence on the viability of the projects.
- ✓ It also fined RBL Bank for an amount of ₹64 lakh for violation of norms on regulatory approval for the acquisition of shares or voting rights in private sector banks.
- ✓ The lender failed to obtain the annual declaration in Form B from one of its major shareholders, within one month of the close of FY18, FY19, and FY20.
- ✓ It also did not furnish certificates to RBI regarding continuance of the 'fit and proper' status of one of its major shareholders, by the end of September, for all three years.
- ✓ Pune-based Bajaj Finance has also been levied a penalty of ₹8.50 lakh for breach of regulatory norms on the extent of not reporting and delay in reporting of certain frauds to RBI.

RBI IMPOSED PENALTY IN NEWS 2023

- RBI has imposed a penalty of ₹1 crore on Union Bank of India for non-compliance with directions on
 'Loans and Advances Statutory and Other Restrictions.
- RBI has imposed monetary penalties on three banks, State Bank of India, Indian Bank and Punjab & Sind Bank, and Fedbank Financial Services for rule violations.
- ➤ RBI has imposed late submission fees amounting to ₹2,000 crore on four major public sector undertakings namely, ONGC Videsh Ltd, Indian Oil Corp. Ltd, GAIL (India) Ltd, and Oil India Ltd for failing to promptly report their overseas investments.
- ➤ RBI has imposed penalties on Standard Chartered Bank, four credit bureaus, and seven cooperative banks for various violations. Standard Chartered Bank was fined ₹30 lakh for non-compliance with KYC directions.
- RBI has imposed a monetary penalty of Rs 2.5 crore on Jammu & Kashmir Bank for non-compliance with certain directions issued by the RBI.
- Reserve Bank of India (RBI) has imposed a monetary penalty of Rs 2.20 crore on Indian Overseas Bank (IOB) for violating various rules and regulations.
- Reserve Bank of India (RBI) imposed a monetary penalty of Rs 1.73 crore on the Hongkong and Shanghai Banking Corporation Ltd (HSBC Bank) for violating the Credit Information Companies Rules, 2006.
- RBI Imposes Rs 84.50 Lakh Penalty on Central Bank of India for Non-Compliance with Fraud Reporting Norms.
- Reserve Bank of India (RBI) has levied penalties of Rs 44 lakhs on four cooperative banks for violating various norms.
- > Baran Nagrik Sahkari Bank.
- Janata Sahakari Bank, Pune.
- > Bombay Mercantile Co-operative Bank.
- > Apex Co-operative Bank, Chennai.
- Reserve Bank of India imposed a Rs 5,000 cap on withdrawals by individual customers from Tamil Nadu-based Musiri Urban Co-operative Bank as part of several restrictions slapped on the lender due to its deteriorating financial condition.

- ✓ Investor Participation : The offer for sale will commence on October 18 for non-retail investors, with retail investors being able to bid on the following day.
- ✓ Green Shoe Option : The government intends to divest 7% equity, including a green shoe option of 3.5%.
- ✓ Floor Price : The floor price for the offer is set at ₹79 per share, which is 12% lower than the closing price of ₹89 on the BSE as of the previous.
- ✓ Number of Shares : Approximately 140 million shares will be put up for sale, with a total value of around ₹1,106 crore.
- ✓ Retail Discount : Notably, there will be no retail discount offered for the OFS, as confirmed by Hudco in a War filing with the BSE.
- ✓ Compliance with SEBI Norms :
- ✓ One of the primary reasons for the OFS is to ensure compliance with the Securities and Exchange Board of India's (SEBI) minimum public shareholding norms. Currently, the government holds an 81.8% stake in Hudco. By divesting 7% of its shares, the government's ownership will decrease to 74.8%, which is below the maximum permissible limit of 75%.
- ✓ <u>Utilization of Proceeds</u> :
- ✓ The revenue generated from this stake sale will be channeled to the government's treasury, contributing to its goal of raising ₹51,000 crore from disinvestment in the fiscal year 2024.
- As of October 17, the government had already raised ₹6,950 crore from disinvestment activities. This amount primarily resulted from selling a 3% stake in Coal India Ltd, a 5.36% stake in Rail Vikas Nigam Ltd, and a 4.92% share sale in SJVN Ltd.


