- ✓ The gross GST for September, collected in October, rose 13% annually to Rs 1,72,003 crore. The growth in India's gross Goods and Services Tax (GST) revenues bounced back in October with tax collections rising at a 10-month high pace of 13.4%.

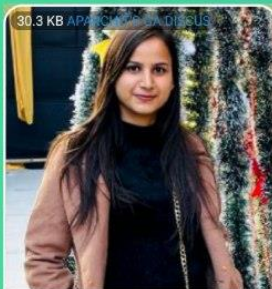

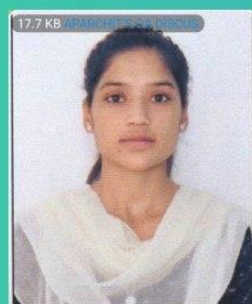
