- ✓ The Government of India has authorised the State Bank of India SBI, in the 29th Phase of sale, to issue and encash Electoral Bonds through its 29 Authorised Branches with effect from 6th to 20th of this month.
- ✓ The Electoral Bonds shall be valid for 15 calendar days from the date of issue and no payment shall be made to any payee Political Party if the Electoral Bond is deposited after expiry of the validity period.
- ✓ The Electoral Bond deposited by an eligible Political Party in its account shall be credited on the same day.
- ✓ Those political parties registered under RP Act 1951 shall be eligible to accept electoral bonds.
- ✓ What are Electoral Bonds?
- ✓ About:
- ✓ The electoral bonds system was introduced in 2017 by way of a Finance bill and it was implemented in 2018.
- ✓ They serve as a means for individuals and entities to make donations to registered political parties while maintaining donor anonymity.
- ✓ Features:
- ✓ State Bank of India (SBI) issues the bonds in denominations of Rs 1,000, Rs 10,000, Rs 1 lakh, Rs 10 lakh, and Rs 1 crore.
- ✓ Payable to the bearer on demand and interest-free.
- ✓ Purchased by Indian citizens or entities established in India.
- ✓ Can be bought individually or jointly with other individuals.
- ✓ Valid for 15 calendar days from the date of issue.
- ✓ Authorized Issuer:
- ✓ State Bank of India (SBI) is the authorized issuer.
- ✓ Electoral Bonds are issued through designated SBI branches.
- ✓ Eligibility of Political Parties:

- ✓ Only the political parties registered under Section 29A of the Representation of the People Act, 1951 and have secured not less than 1% of the votes polled in the last general election to the House of the People or the Legislative Assembly, are eligible to receive electoral bonds.
- ✓ Purchase and Encashment:
- ✓ Electoral Bonds can be purchased digitally or through cheques.
- ✓ Encashment only through an authorized bank account of the political party.

- ✓ The project cost is estimated to be in the Rs 2,500-5,000 crore range.
- ✓ The project will initially be developed to handle 6 MPA (million passengers per annum) capacity to be further enhanced to the capacity of 12 MPA.
- ✓ The key development works include cut & fill works, terminal works with airport systems, ATC tower, airfield development works (south runway 3,800 m length, apron, taxiways, airfield ground lighting, fuel

hydrant works and other facilities), landside facilities (roads, landscapes, etc.), utilities & other support facilities.

✓ Larsen & Toubro is presently executing the construction works of major airports in Delhi, Hyderabad, Bangalore, Chennai, and Navi Mumbai.

AIRPORT IN NEWS 2023

- Larsen and Toubro (L&T) Construction have secured a large order to construct the greenfield Bhogapuram International Airport project in Andhra Pradesh.
- ➤ The largest airport in the world is the king Fahd International Airport, located in Dammam, Saudi Arabia which covers an area of about 300 sq.
- Minister of Civil Aviation, Shri Jyotiraditya M Scindia inaugurated Utkela Airport owned by the Government of Odisha.
- > Guwahati's Lokpriya Gopinath Bordoloi International Airport became the first airport in the northeast to get 'Digi Yatra' facility.
- Prime Minister Narendra Modi will inaugurate Gujarat's first greenfield airport at Hirasar near Rajkot.
- ➤ Government of India has given 'in-principle' approval for setting up 21 new greenfield airports.
- ➤ Bangalore International Airport Limited (BIAL) has launched a new app called BLR Pulse to provide hassle-free experience to the commuters at Kempegowda International Airport.
- > Delhi's Indira Gandhi International (IGI) Airport has launched a new facility called 'DigiYatra' which enables passengers to avail of its services without downloading a mobile application.
- ➤ Lal Bahadur Shastri International Airport is the first in India to offer a free reading lounge to the passengers, with a huge collection of litreature.
- ➤ Indira Gandhi International Airport in New Delhi ranked 9th busiest airports globally in 2022, as per Airports Council International (ACI). United States-based Atlanta airport has retained its position as the world's busiest airport.
- According to the Airport Council International (ACI), Delhi International Airport has been ranked among the cleanest airports in Asia-Pacific.
- ➤ Prime Minister Narendra Modi on 27 February 2023 launched the newly built Shivamogga airport along with various development projects worth over Rs 3,600 crore in Shivamogga, Karnataka.

- Bangalore's Kempegoda International Airport and Delhi's Indira Gandhi International (IGI) Airport both ranked second and seventh in Cirium's list of the world's best-performing airports for 2022.
- Mopa International Airport Goa named after former CM Manohar Parrikar.
- > Jaipur International Airport Limited has received the Aerodrome licence from the Directorate General of Civil Aviation (DGCA).
- ▶ Union Cabinet has given its approval for the naming of the new Greenfield Airport at Hollongi, Itanagar, the State Capital of Arunachal Pradesh as "Donyi Polo Airport, Itanagar".

- ✓ Prime Minister Narendra Modi has announced that the Pradhan Mantri Garib Kalyan Anna Yojana will be extended for the next five years.
- ✓ Under this scheme, about 80 crore poor people across the country are being given 5 kg of free food grains every month. This scheme was ending in December this year. Warriors
- ✓ PM Garib Kalyan Anna Yojana was launched in April 2020.
- ✓ Pradhan Mantri Garib Kalyan Food Yojana (PMGKAY):
- ✓ Introduction :
- ✓ 'Pradhan Mantri Garib Kalyan Anna Yojana' was launched as part of the 'Pradhan Mantri Garib Kalyan Package '(PMGKP) to assist the poor and vulnerable in the fight against COVID -19.
- ✓ Under this scheme, in addition to the 5 kg subsidized food grains already being provided through the Public Distribution System (PDS), each person will be provided 5 kg additional food grains (wheat or rice) free of cost under the National Food Security Act (NFSA), 2013. The target has been set to provide.
- ✓ Initially this scheme was launched for a period of three months (April, May and June 2020), covering a total of 80 crore ration card holders. Later it was extended till September 2020.
- ✓ Finance Ministry is its nodal ministry.
- ✓ Any migrant worker or beneficiary can avail free ration through portability under the One Nation One Ration Card (ONORC) scheme from around 5 lakh ration shops across the country.



- ✓ Cost: The total expenditure of PMGKAY for all phases will be approximately Rs 91 lakh crore.
- ✓ Challenges : A key issue is that beneficiaries under the National Food Security Act are based on the last census (2011), although since then there has been an increase in the number of food-insecure people who are no longer covered under the scheme.
