


✓ The NPCI has set the daily payment limit for UPI transactions to a maximum of Rs. 1 lakh starting from January 1, 2024. However, RBI raised the transaction limit for UPI payments to hospitals and educational institutions to Rs 5 lakh on December 8, 2023, to broaden the use of UPI payments.

#### **RBI IN NEWS 2023**

- Reserve Bank of India (RBI) made a noteworthy move, revealing an elevation in UPI payment limits from Rs 1 lakh to Rs 5 lakh, specifically focusing on healthcare and education sectors.
- The Reserve Bank of India (RBI) released its latest Financial Stability Report (FSR), highlights a shift in India's household savings, with a decline to 10.9% of GDP in FY23.
- Tata Pay, the digital payments app under Tata Digital, has been granted a payment aggregator (PA) license by the Reserve Bank of India (RBI).
- RBI has increased the bulk deposit limit for large urban co-operative banks (UCBs) from ₹15 lakh to ₹1 crore and above. This adjustment applicable to Tier 3 and Tier 4 UCBs.
- The enhanced bulk deposit limit is specifically applicable to UCBs falling within the Tier 3 category, characterized by deposits ranging from ₹1,000 crore to ₹10,000 crore, and Tier 4 category, encompassing UCBs with deposits exceeding ₹10,000 crore.
- Reserve Bank of India (RBI) has granted approval to ICICI Prudential Asset Management Company Ltd (ICICI AMC) for the acquisition of up to 9.95% stake in Federal Bank.
- Simultaneously, the RBI has also approved ICICI AMC to acquire a 9.95% stake in RBL Bank and Equitas Small Finance Bank.

#### RBI INCREASE LIMIT IN NEWS 2023

- RBI Governor Shaktikanta Das announced that the UPI payment limits for hospitals and educational institutions will be raised to Rs 5 lakh from Rs 1 lakh per transaction.
- Reserve Bank of India (RBI) recently raised the minimum amount for offering non-callable Fixed Deposits (FDs) of banks from Rs 15 lakh to Rs 1 crore.
- Reserve Bank of India (RBI) took a significant step by announcing an increase in the UPI payment limits from Rs 1 lakh to Rs 5 lakh.
- RBI has conducted a review of bulk deposit limits for financial institutions, specifically focusing on Regional Rural Banks (RRBs). As a result, the bulk deposit limit for RRBs has been significantly increased from Rs 15 lakh to Rs 1 crore.

#### **RBI IMPOSED PENALTY IN NEWS 2023**

- RBI took regulatory action imposing penalties on Bank of America, N.A. and HDFC Bank Ltd. For violations of specific norms.
- RBI has imposed a penalty of Rs. 10,000 on Bank of America, N.A. for violating the reporting requirements under the liberalized Remittances Scheme of FEMA 1999.
- HDFC Bank Ltd also faced a penalty of Rs.10,000 for violating directions related to the acceptance of deposits from non-residents.
- RBI Imposes ₹2.5 Crore Penalty On L&T Finance For Non Compliance.
- This penalty has been levied due to non-compliance with specific provisions of the Non-Banking Financial Company.
- RBI Imposes ₹5.4 Crore Penalty On Paytm Payments Bank.
- Paytm Payments Bank was penalized for "non-compliance with certain provisions of the 'Reserve Bank of India (Know Your C ustomer (KYC)) Directions, 2016'."
- Reserve Bank of India (RBI) has imposed a penalty or ₹12.19 crore on ICICI Bank and ₹3.95 crore on Kotak Mahindra Bank for non-compliance of certain regulatory norms.
- RBI Imposes Monetary Penalty On State Bank Of India, Indian Bank, Punjab & Sind Bank.
- The RBI imposed a monetary penalty of ₹1.30 Crore on the State Bank of India (SBI) for its failure to comply.
- Punjab & Sind Bank faced a penalty of ₹1.00 Crore for non-compliance with the provisions of sub-section (2) of Section 26A of the Banking Regulation Act, 1949.


