- ✓ In another feat, Lieutenant Jamyang Tsewang became the first Commissioned Naval Officer from the Union Territory of Ladakh to graduate as a qualified helicopter pilot at the same ceremony.
- ✓ A passing out parade was held on Friday to mark the graduation of the 102nd Helicopter Conversion Course (HCC) and completion of stage I training of the 4th Basic Helicopter Conversion Course (BHCC) at Naval Air Station – INS Rajali, Arakkonam, Tamil Nadu.

- Sub Lieutenant Anamika B. Rajeev became the Indian Navy's first woman helicopter pilot.
- Claudia Sheinbaum Elected As Mexico's First Woman President.
- Idashisha Nongrang has been named first woman Director General of Police (DGP) of Meghalaya state.
- Professor Naima Khatoon has been appointed as the Vice Chancellor of Aligarh Muslim University (AMU).
- Democratic Republic Of Congo Appoints Judith Suminwa Tuluka As African Nation's First Woman Prime Minister.
- Suman Kumari has become the first woman sniper of the Border Security Force (BSF).
- Maryam Nawaz was sworn in as the first woman Chief Minister (CM) of Pakistan's Punjab province.
- Justice Ritu Bahri was today sworn in as the first woman Chief Justice of the Uttarakhand High Court.
- Nina Singh becomes first woman to be appointed as DG of CISF.



- Captain Fatima Wasim has become the first woman medical officer to be posted at the operational post of Siachen Glacier.

- ✓ Debutant Tomar eked out a 30-27, 27-30, 29-28 split-decision win over Brazil's Rayanne dos Santos in the straw-weight (52kg) bout.
- ✓ The 30-year-old, known as "cyclone", signed a contract with the UFC last year in October to become the first woman from India to compete in the biggest Mixed Martial Arts promotion.
- ✓ Anshul Jubli and Bharat Kandare have represented India on the world stage in the UFC, as has Canada-based Arjan Singh Bhullar.

- ✓ His closest rival, Hikaru Nakamura (USA) was beaten by R. Praggnanandhaa, also in Armageddon.

- Magnus Carlsen and Ju Wenjun emerged as the champions at the Norway Chess tournament at Stavanger.
- World No 1, Magnus Carlsen won the Casablanca Chess Variant tournament .
- P Shyaamnikhil of Tamil Nadu becomes India's 85th Chess Grandmaster.
- International Chess Federation Awards Grandmaster Title To Indian Chess Prodigy Vaishali Ramesh Babu.
- Indian young chess player Rameshbabu Praggnanand has defeated world chess champion Ding Liren in the 'Tata Steel Masters' held in Netherlands.
- Vaishali Rameshbabu has become the 84th Grandmaster of India.
- Raunak Sadhwani (Maharashtra) won FIDE World Junior Rapid Chess Championship.
- India's Karthikeyan Murali became the third Indian chess player to defeat World No 1 Magnus Carlsen in classical chess after he prevailed over the Norwegian at the Qatar Masters tournament.

- ✓ Market regulator SEBI fines 11 individuals for pump and dump scheme
- ✓ The Securities and Exchange Board of India (SEBI) has slapped a fine of Rs 7.75 crore on 11 individuals for allegedly operating a 'pump and dump' scheme in scrip of Svarnim Trade Udyog .
- ✓ The markets regulator has also debarred them from the securities market and ordered disgorgement of Rs 92.37 lakh with 12 per cent annual interest.
- ✓ The pump and dump scheme was operated through recommendations shared through Telegram channels, resulting in public shareholders purchasing the stock at an inflated price



PENALTY IN NEWS 2024

- SEBI has slapped a fine of Rs 7.75 crore on 11 individuals for allegedly operating a 'pump and dump' scheme in scrip of Svarnim Trade Udyog.
- ICICI Bank faced a penalty of ₹1 crore for contravening RBI's directions on 'loans and advances — statutory and other restrictions.'
- YES Bank incurred a penalty of ₹91 lakh for failing to adhere to RBI's directives on 'customer service in banks' and the 'unauthorised operation of internal/office accounts'.
- SEBI imposes ₹11.90 crore fine on 19 entities for Superior Finlease 'pump and dump'
- IRDAI imposes a fine of Rs 1 crore on IPO-bound Go Digit Insurance
- RBI has imposed a penalty of ₹1 crore on IDFC First Bank for non-compliance with certain directions on 'Loans and Advances – Statutory and Other Restrictions'.
- RBI imposes Rs 1.31 cr fine on Tamilnad Mercantile Bank for non-compliance.
- Reserve Bank of India (RBI) has imposed a penalty of Rs 1.4 crore on Bank of India for non-compliance with certain regulatory norms.
- Paytm's trouble escalated further with the Financial Intelligence Unit-India slapping a ₹5.49 crore penalty on Paytm Payments Bank Ltd (PPBL) for violating Prevention of Money Laundering Act (PMLA) obligations
- Reserve Bank of India (RBI) has decided to waive the ₹5 crore penalty that was previously imposed on Bank of Baroda.

- ✓ The Export-Import Bank of India (India Exim Bank) recently opened its East Africa Representative Office in Nairobi, Kenya, aiming to expand India's business footprint in the resource-rich and demographically young continent of East Africa.



- ✓ This is part of a plan to grow its business around the world. The goal of this project is to improve India's trade and business ties with East Africa, which is known for having a lot of resources and young people.
- ✓ India Exim Bank has provided over 200 Lines of Credit exceeding US\$12 billion to 42 African countries on behalf of the Indian Government

Q.8. What change is the Reserve Bank of India (RBI) proposing regarding the definition of bulk deposits for scheduled commercial banks (excluding regional rural banks), small finance banks, and local area banks?

- ✓ RBI plans to raise bulk deposit limit to ₹3 crore from ₹2 crore.
- ✓ With deposit growth lagging credit growth, the Reserve Bank of India (RBI) said it plans to revise upwards the definition of bulk deposits for scheduled commercial banks (excluding regional rural banks), small finance banks and local area banks.
- ✓ RBI is proposing to revise the definition of bulk deposits as 'single Rupee term deposit of ₹3 crore and above' for scheduled commercial banks/SCBs (excluding regional rural banks/RRBs) and Small Finance Banks. Currently, 'single Rupee term deposit of ₹2 crore and above' are classified as bulk deposits by these banks.
- ✓ Further, the central bank also plans to define the bulk deposit limit for Local Area Banks as 'Single Rupee term deposits of ₹1 crore and above', as applicable in case of RRBs

INCREASE LIMIT IN NEWS

- Reserve Bank of India raised the bulk fixed deposit threshold from Rs 2 crore to Rs 3 crore, enhancing liquidity management.
- Reserve Bank of India (RBI) took a significant step by announcing an increase in the UPI payment limits from Rs 1 lakh to Rs 5 lakh.
- RBI has conducted a review of bulk deposit limits for financial institutions, specifically focusing on



Regional Rural Banks (RRBs). As a result, the bulk deposit limit for RRBs has been significantly increased from Rs 15 lakh to Rs 1 crore.

- RBI Raises Offline Payment Transaction Upper Limit to ₹500 from ₹200.
- RBI has raised the Additional Factor of Authentication (AFA) limit from Rs 5,000 to Rs 15,000 per transaction for e-mandates on cards, Prepaid Payment Instruments (PPIs) and Unified Payments Interface (UPI) for recurring transactions.
- RBI has decided to increase the existing limit for gold loans under a scheme called “bullet repayment” from Rs 2 lakh to Rs 4 lakh for urban cooperative banks.
- Reserve Bank of India has increased the limit of fund transfer under the Indo-Nepal Remittance Facility Scheme from Rs 50,000 per transaction to Rs 2 lakh per transaction.
- Union Cabinet approved the enhancement in the limit of the Emergency Credit Line Guarantee Scheme (ECLGS) by Rs 50,000 crore to Rs 5 lakh crore.
- Reserve Bank of India has increased the maximum amount outstanding in respect of full-KYC PPIs (KYC-compliant PPIs) from Rs. 1 lakh to Rs. 2 lakh

- ✓ In a move to spur economic development in states, Finance Ministry has released an additional instalment of tax devolution to states for June 2024. The total amount released to states for June now stands at Rs 1,39,750 crore.
- ✓ The biggest chunk of the fund went to Uttar Pradesh at Rs 25,069.88 crore, followed by Bihar at Rs 14,056.12 crore, Madhya Pradesh got Rs 10,970.44 crore, and West Bengal was devolved Rs 10,513.46 crore.

- ✓ The National Human Rights Commission (NHRC) has issued a notice to four states- Uttar Pradesh, Madhya Pradesh, Rajasthan, and Gujarat. This notice follows a 2020 case in which a father sold his daughter for 2.5 lakhs and later filed a complaint with the commission upon discovering her dead body.
- ✓ The NHRC has expressed serious concern over the social practice of Nata Pratha, where girls are sold by their family members under the guise of marriage in parts of Rajasthan, Madhya Pradesh, Uttar Pradesh, and Gujarat

- ✓ Bihar, Uttar Pradesh and Rajasthan lead the chart of 1.16 lakh farmers who have voluntarily given up the benefits of the annual Rs 6,000 Pradhan Mantri Kisan Samman Nidhi (PM-Kisan) scheme across the country from June 2023 to May 2024, according to data available with the Ministry of Agriculture & Farmers Welfare.
