

- ✓ Promoted by Clearing Corporation of India Limited (CCIL), CCIL IFSC is the proposed entity to build and operate a real-time foreign currency settlement system at GIFT City. The entity will act as a clearing house and system operator at GIFT City.

- > The naval forces of China, Iran, and Russia recently launched a joint exercise called the "Maritime Security Belt-2024" near the Gulf of Oman.

- ✓ 1st BRICS Ministerial meeting held with expanded membership in Russia.
- ✓ The first ministerial meeting of the BRICS group of countries with the newly added members took place in the Russian city of Nizhny Novgorod on 10 June 2024.
- ✓ The two-day (10 and 11 June 2024) meetings of the BRICS Ministers of Foreign Affairs/International Relations was hosted by Russia, as it is the current chairman of the BRICS.
- ✓ Egypt, Iran, UAE, Saudi Arabia & Ethiopia Join first BRICS Ministerial meeting.
- ✓ Argentina declined to join the group, while Egypt, Ethiopia, Iran, Saudi Arabia, and the United Arab Emirates joined the group on 1 January 2024.
- ✓ Brazil, Russia, India, China, and South Africa were already members of the group.

- ✓ Russia took over the chairmanship of BRICS from South Africa on 1 January 2024.
- ✓ Russia will host the 16th annual BRICS summit from 22 to 24 October 2024
- ✓ About BRICS
- ✓ BRICS is an intergovernmental organisation that originally consisted of four countries: Brazil, Russia, India, and China.
- ✓ British economist Jim O'Neill, working for Goldman Sachs, coined the acronym BRIC (Brazil, Russia, India, and China) in 2001. He believed that these countries would dominate global economic growth by 2050.
- ✓ The first foreign minister's meeting of the BRIC countries was held in New York in 2006.
- ✓ The first summit meeting of the leaders of the BRIC countries was held in June 1996 in Yekaterinburg, Russia.
- ✓ The group's name was changed to BRICS after South Africa joined the group in 2010.
- ✓ With the addition of Egypt, Ethiopia, Iran, Saudi Arabia, and the United Arab Emirates, the total number of BRICS members has reached 10.
- ✓ The BRICS countries are economically an important group in the world. Around half of the world's population lives in BRICS countries.
- ✓ Their contribution in world crude oil production and export is around 40 per cent.
- ✓ They contribute to around 25 percent of the global economy and their contribution in global trade in goods is around two-fifth.

- ✓ Following successful agreements for Chabahar Port in Iran and Sittwe in Myanmar, India is set to operate a terminal at Mongla port in Bangladesh. This will be the third overseas port operation by India as New Delhi rapidly sheds reticence in foraying abroad to expand its commercial interests in the ports and shipping sector.
- ✓ The terminal at Mongla will be managed by India Ports Global Ltd (IPGL). A senior official from the Ministry of Ports, Shipping and Waterways said that IPGL will henceforth be the preferred entity for India's international port operations.
- ✓ Mongla is Bangladesh's second-largest port. It lies close to the shore of the Bay of Bengal and the Pashur River.

- ✓ Presently, the UPI Lite app can only hold a maximum of Rs 2000 at a time.

- ✓ This will further enhance the ease of making small value digital payments, he said while announcing the bi-monthly monetary policy.
- ✓ This will enable customers to automatically replenish the balances in Fastag, NCMC, etc

- ✓ SBI identified the micro, small and medium enterprise (MSME) line of business as the focal point for the bank's growth and profitability over the next five years.
- ✓ The proposition eliminates the need for traditional credit underwriting and lengthy appraisal processes, ushering in a new era of simplicity, speed, and accessibility in MSME lending.
- ✓ Notably, for loans up to Rs 50 lakh, SBI has waived the requirement for financial statements, relying instead on transaction history and GST returns for appraisal

- ✓ Mohan Charan Majhi: BJP's first Chief Minister of Odisha.
- ✓ Mohan Charan Majhi of the Bharatiya Janata Party (BJP) was sworn in as the chief minister of Odisha by the state Governor, Raghubar Das, in a ceremony at the Janata Maidan, Bhubaneswar, on 12 June 2024.
- ✓ He is the first BJP leader to become the chief minister of Odisha.
- ✓ He is also the third tribal after Giridhar Gamang and Hemananda Biswal (both from the Congress party) to become the chief minister of Odisha.
- ✓ The Mohan Charan Majhi government has two deputy chief ministers, K V Singh Deo and Pravati Parida.
- ✓ Pravati Parida is Odisha's first female deputy chief minister.
- ✓ Mohan Charan Maji is the 15th chief minister of Odisha after the promulgation of the constitution.

- Mohan Charan Majhi of the Bharatiya Janata Party (BJP) was sworn in as the 15th chief minister of Odisha.
