- ✓ SEBI recently proposed to increase the flexibility of minimum public shareholding (MPS) and minimum public offer (MPO) for companies aspiring to get listed, aimed at “simplifying fund-raising by issuers in India.
- ✓ **About Minimum Public Shareholding (MPS):**
- ✓ The Minimum Public Shareholding (MPS) rule is a regulatory requirement laid out by SEBI under the Securities Contracts (Regulation) Rules, 1957, and reinforced by the Listing Obligations and Disclosure Requirements (LODR) Regulations.
- ✓ It is applicable to all listed companies in India.
- ✓ As per these rules, all listed companies must ensure that at least 25% of their total issued and paid-up equity share capital is held by public shareholders—i.e., non-promoters and non-promoter group entities.
- ✓ Where promoters are holding more than 75%, they have to mandatorily divest additional shares to the public to comply with the MPS rule.
- ✓ **The objective is to:**
- ✓ Enhance liquidity in the market
- ✓ Promote fair price discovery
- ✓ Ensure broader participation and corporate governance
- ✓ Newly listed companies are expected to meet this requirement within three years from the date of listing.
- ✓ For issuers with a post-issue market cap of over ₹1 trillion, the deadline for 25% MPS is five years.
- ✓ If the public shareholding falls below 25% at any time, such company shall bring the public shareholding to 25% within a maximum period of 12 months from the date of such fall.

## SEBI IN NEWS 2025

- SEBI to Launch Centralised Compliance Platform for Brokers from August 1, 2025.
- SEBI renewed the recognition of Multi Commodity Exchange Clearing Corporation Ltd (MCXCCL) as a clearing corporation for a three-year term, effective from July 31, 2025 to July 30, 2028.
- SEBI Unveiled 'VCF Settlement Scheme 2025' for VCF Liquidation.
- SEBI has announced the formation of a six- member high level committee headed by Pratyush Sinha , a retired IAS officer and former chief vigilance commissioner to review conflict of interest rules
- SEBI has directed all its regulated and registered entities to exclusively use the 1600 phone number series for service and transactional voice calls to their customers
- SEBI issued a framework for recognition and operationalisation of a performance validation agency, to be called Past Risk and Return Verification Agency (PaRRVA).
- Eligibility Criteria for PaRRVA:-
  - (i)Number of years of existence of the CRA(Credit Rating Agencies )should be minimum 15 years
  - (ii)Minimum net worth of the CRA should be INR 100 crores
  - (iii)Number of issuers which have obtained ratings of listed or proposed to be listed debt securities from the CRA should be 250 or more; and
  - (iv)CRA should have Investor grievance redressal mechanism including Online Dispute Resolution ("ODR") Mechanism
- The eligibility criteria for a SE to act as PaRRVA Data Centre ("PDC") :-
  - (i)Number of years of existence of the SE should be minimum 15 years
  - (ii)Minimum net worth of the SE should be INR 200 crores
  - (iii)The SE should have nation-wide terminals
  - (iv)SE should have Investor grievance redressal mechanism including Online Dispute Resolution ("ODR") Mechanism
- Aye Finance, an Alphabet-backed non-banking financial company (NBFC), has received final observations from the Securities and Exchange Board of India (SEBI) for its proposed ₹1,450 crore IPO.
- SEBI extends suspension of trading in 7 commodity derivatives until Mar 2026
- (moong, wheat, paddy(non-basmati), chana, mustard, soyabean, crude palm oil)

- SEBI has extended the limit for advance fee collection by Investment Advisers (IAs) and Research Analysts (RAs) to up to one year. Previously, IAs could collect fees in advance for up to two quarters, and RAs for a quarter.
- SEBI has eased disclosure norms for foreign portfolio investors (FPIs) by raising the asset threshold for granular beneficial ownership disclosures from Rs 25,000 crore to Rs 50,000 crore
- SEBI Partners with DigiLocker to Reduce Unclaimed Assets and Strengthen Investor Protection.
- Tuhin Kanta Pandey, has been appointed as the 11th chairperson of the SEBI for a three-year term.
- He will succeed Madhabi Puri Buch.
- SEBI asset management companies (AMC) should deploy the funds garnered from investors in a new fund offering (NFO) within 30 days form the date of allotment of units.
- SEBI introduced a digital platform called MITRA (Mutual Fund Investment Tracing and Retrieval Assistant) to help investors find inactive or unclaimed mutual fund folios.
- SEBI has proposed a minimum investment of Rs 1 crore for RBI-regulated originators and unregulated entities involved in securitization
- SEBI is working on a secure Unified Payments Interface (UPI) mechanism for registered market intermediaries.
- Currently, UPI transactions for capital markets are capped at ₹2 lakh per day.
- SEBI proposes increasing this limit to ₹5 lakh per day.
- Reserve Bank of India (RBI) has allowed SEBI-registered non-bank brokers to participate in the Negotiated Dealing System-Order Matching (NDS-OM).
- Securities and Exchange Board of India (SEBI):
  - It is the regulatory body for securities and commodity markets in India established in 1988.
  - It is the regulator of the Capital market and Commodities market in India.
  - The first SEBI chairman was Dr S A Dave (1988-90)
  - Headquarters : Mumbai
  - 11th Chairperson : Tuhin Kanta Pandey

- ✓ Earlier in 1961 and 1983, four Venera probes of the Soviet Union took important photographs of the surface of Venus.
- ✓ Russia is set to launch Venera-D mission to revisit Venus before 2036.
- ✓ According to Oleg Korablev of the Space Research Institute (IKI), preliminary design work will begin in January 2026 as part of the country's new national space program.
- ✓ The mission will consist of a lander, a balloon probe and an orbital spacecraft, with launch expected between 2034 and 2036.
- ✓ **Indian initiative**
- ✓ India's space agency, ISRO, plans to launch a Venus orbiter mission called Shukrayaan. Although the original plan was to launch it in 2024, recent reports indicate that the launch may be delayed, possibly to 2028 or even later and the most suitable launch window for it would be 2031.

- ✓ The National Payments Corporation of India (NPCI) has announced that peer-to-peer 'collect requests' on UPI will be discontinued starting October 1, 2025.
- ✓ This feature, which allowed one user to request payment approval from another, had become a major loophole exploited by fraudsters, despite transaction caps and limits.
- ✓ By mandating only payer-initiated (push) transactions such as QR code scans or manual entry of recipient details, NPCI aims to strengthen digital payment security.
- ✓ The move affects all UPI apps including PhonePe, Google Pay, and Paytm, and is expected to enhance trust, reduce fraud risks, and ensure safer digital transactions nationwide.

- NPCI will start delinking UPI IDs linked to the mobile number revocation list (MNRL) and the digital intelligence platform (DIP) from April 1, 2025.
- NPCI has extended the deadline for implementing transaction volume cap on Unified Payments Interface (UPI) apps by two years till December 31, 2026.
- NPCI removed the user onboarding limit for WhatsApp Pay on January 6, 2025.
- WhatsApp Pay must continue to comply with all existing UPI guidelines and regulations for Third-Party Application Providers (TPAPs).
- NPCI approved 20 third-party Unified Payments Interface (UPI) applications, a record since UPI's launch in 2016.
- NPCI eyes Rupay, UPI expansion to 10 countries.
- For UPI, we have signed up with three countries With Namibia, Trinidad and Tobago, and Peru, the commercial agreements have been signed.
- Currently, UPI is available in seven countries — France, the UAE, Singapore, Bhutan, Sri Lanka, Mauritius and Nepal.
- NPCI has launched a UPI Safety Awareness Campaign, Main Moorkh Nahi Hoon.
- As the campaign's brand ambassador, renowned actor Pankaj Tripathi will star in a series of six and films .
- India's Unified Payments Interface (UPI) technology set a new record in October 2024 with 16.58 billion transactions worth ₹23.50 lakh crore.
- NPCI has granted approval to Paytm to onboard new UPI users, subject to the adherence to all procedural guidelines and circulars.
- Maldivian President Mohamed Muizzu has decided to take the necessary steps to introduce India's Unified Payment Interface (UPI) in the Maldives.
- National Payments Corporation of India is already operational in several international locations, including UAE, Sri Lanka, France, Malaysia, Singapore, Nepal, the UK, and Mauritius.
- NPCI and The Times of India (TOI) have announced a partnership to launch a nationwide campaign to promote digital payment safety.

- ✓ When the Vice President assumes the role or duties of the President under Article 65 of the Constitution of India, he shall not discharge the duties of the Chairman of the Rajya Sabha and shall not receive the salary or allowances specified for the Chairman under Article 97.
- ✓ **Qualifications for the post:**
- ✓ Article 66 specifies the qualifications required for the post of Vice President which are as follows-
- ✓ Must be an Indian citizen.
- ✓ Must be at least 35 years of age.
- ✓ Must be eligible for election as a member of the Rajya Sabha.
- ✓ **Election:**
- ✓ Article 68 of the Constitution provides that an election to fill the vacancy in the office of Vice-President due to expiry of his term of office must be held before the expiry of the current term.
- ✓ Article 324 of the Constitution empowers the Election Commission of India to supervise, direct and control the process of election of the Vice-President.
- ✓ Article 66 states that the Vice-President must be elected by an electoral college consisting of the elected and nominated members of both Houses of Parliament.
- ✓ The original Constitution provided that the Vice-President would be elected by a joint sitting of both Houses of Parliament. This cumbersome process was abolished by the 11th Constitutional Amendment Act, 1961.
