



- ✓ SEBI announced the extension of the implementation timeline for the margin pledge-repledge framework.
- ✓ The new date for compliance has been shifted from September 1, 2025 to October 10, 2025, providing additional time for market participants to adapt.
- ✓ SEBI issued this revised deadline through a circular under powers granted by Section 11(1) of the SEBI Act, 1992, read with Regulation 30 of Chapter VII of SEBI (Stock Brokers) Regulations, 1992.

SEBI IN NEWS 2025

- > SEBI to Launch Centralised Compliance Platform for Brokers from August 1, 2025.
- ➤ SEBI renewed the recognition of Multi Commodity Exchange Clearing Corporation Ltd (MCXCCL) as a clearing corporation for a three-year term, effective from July 31, 2025 to July 30, 2028.
- ➤ SEBI Unveiled 'VCF Settlement Scheme 2025' for VCF Liquidation.
- > SEBI has announced the formation of a six- member high level committee headed by Pratyush Sinha, a retired IAS officer and former chief vigilance commissioner to review conflict of interest rules
- > SEBI has directed all its regulated and registered entities to exclusively use the 1600 phone number series for service and transactional voice calls to their customers
- > SEBI issued a framework for recognition and operationalisation of a performance validation agency , to be called Past Risk and Return Verification Agency (PaRRVA).
- ➤ Eligibility Criteria for PaRRVA:-
- (i)Number of years of existence of the CRA(Credit Rating Agencies)should be minimum 15 years
- (ii)Minimum net worth of the CRA should be INR 100 crores



- > (iii)Number of issuers which have obtained ratings of listed or proposed to be listed debt securities from the CRA should be 250 or more; and
- > (iv)CRA should have Investor grievance redressal mechanism including Online Dispute Resolution ("ODR") Mechanism
- ➤ The eligibility criteria for a SE to act as PaRRVA Data Centre ("PDC"):-
- ➤ I)Number of years of existence of the SE should be minimum 15 years
- (ii)Minimum net worth of the SE should be INR 200 crores
- (iii)The SE shouldhavenation-wide terminals
- > (iv)SE should have Investor grievance redressal mechanism including OnlineDispute Resolution ("ODR") Mechanism
- ➤ Aye Finance, an Alphabet-backed non-banking financial company (NBFC), has received final observations from the Securities and Exchange Board of India (SEBI) for its proposed ₹1,450 crore IPO.
- > SEBI extends suspension of trading in 7 commodity derivatives until Mar 2026
- (moong, wheat, paddy(non-basmati), chana, mustard, soyabean, crude palm oil)
- > SEBI has extended the limit for advance fee collection by Investment Advisers (IAs) and Research Analysts (RAs) to up to one year. Previously, IAs could collect fees in advance for up to two quarters, and RAs for a quarter.
- > SEBI has eased disclosure norms for foreign portfolio investors (FPIs) by raising the asset threshold for granular beneficial ownership disclosures from Rs 25,000 crore to Rs 50,000 crore
- > SEBI Partners with DigiLocker to Reduce Unclaimed Assets and Strengthen Investor Protection.
- Tuhin Kanta Pandey, has been appointed as the 11th chairperson of the SEBI for a three-year term.
- ➤ He will succeed Madhabi Puri Buch.
- > SEBI asset management companies (AMC) should deploy the funds garnered from investors in a new fund offering (NFO) within 30 days form the date of allotment of units.
- > SEBI introduced a digital platform called MITRA (Mutual Fund Investment Tracing and Retrieval Assistant) to help investors find inactive or unclaimed mutual fund folios.
- > SEBI has proposed a minimum investment of Rs 1 crore for RBI-regulated originators and unregulated entities involved in securitization
- > SEBI is working on a secure Unified Payments Interface (UPI) mechanism for registered market



intermediaries.

- ➤ Currently, UPI transactions for capital markets are capped at ₹2 lakh per day.
- ➤ SEBI proposes increasing this limit to ₹5 lakh per day.
- > Reserve Bank of India (RBI) has allowed SEBI-registered non-bank brokers to participate in the Negotiated Dealing System-Order Matching (NDS-OM).
- > Securities and Exchange Board of India (SEBI):
- ➤ It is the regulatory body for securities and commodity markets in India established in 1988.
- ➤ It is the regulator of the Capital market and Commodities market in India.
- The first SEBI chairman was Dr S A Dave (1988-90)
- > Headquarters : Mumbai
- > 11th Chairperson : Tuhin Kanta Pandey

- ✓ IIT Madras Signs Rs 1 Crore Licensing Deal with Indrarka Quantum Technologies for India's First Silicon Photonics-Based High-Speed QRNG.
- ✓ Technology Transfer Office (TTO) of the Indian Institute of Technology Madras (IIT-M) signed a licensing agreement worth Rs 1 crore with Indrarka Quantum Technologies Pvt. Limited to transfer India's first indigenously developed silicon (Si) photonics-based high-speed Quantum Random Number Generator (QRNG) technology for commercial deployment.
- ✓ The licensing agreement is a significant step in advancing India's quantum innovation ecosystem. It allows Indrarka Quantum Technologies Pvt. Limited to commercially deploy the QRNG technology, which was indigenously developed at IIT-M's Centre for Programmable Photonic Integrated Circuits and Systems (CPPICS).

IIT IN NEWS 2025

- > IIT Guwahati researchers developed a bamboo-polymer composite as an eco-friendly alternative to plastic in vehicle interiors.
- > IIT Madras has made India's lightest wheelchair called YD One.
- ➤ Kerala State Electricity Board (KSEB), in partnership with IIT Bombay, has launched a pilot V2G project to test its feasibility in the state.
- Coal India joins hands with IIT Hyderabad for R D in clean coal tech.
- ➤ DRDO and IIT Hyderabad unveiled India's largest metal 3D printing machine for rocket components. It was developed at the DRDO-Industry-Academia Centre of Excellence (DIA-CoE) at IIT Hyderabad.
- ➤ IIT Bombay has partnered with the Centre for Development of Telematics (C-DOT) to develop an "Optical Transceiver Chipset for High-Bandwidth 6G Wireless Links."
- > IIT Madras has announced a collaboration with the Ministry of Agriculture and Farmers' Welfare on Project VISTAAR (Virtually Integrated System to Access Agricultural Resources).
- > IIT-Madras has successfully commissioned Asia's largest shallow wave basin at its Discovery campus in Thaiyur.
- > IIT Madras, in collaboration with the startup TuTr, completed India's first 410-meter Hyperloop test track, marking a significant step forward in vacuum-based train technology.
- > Indian Institute of Technology Bombay (IIT Bombay) have developed water-pollutant detecting

device called 'AroTrack'.

- ➤ IIT Madras Partners with IDBI To Launch Cybersecurity Lab
- > The Centre for Development of Telematics (C-DOT) partners with IIT Roorkee and Mandi to boost 6G standardization, connectivity.
- > TCS And IIT Bombay Collaborate To Create India's First Semiconductor Chip Imaging Tool.
- ➤ Alliance of Digital India Foundation (ADIF) and IIT Guwahati incubation center sign MoU to boost startup ecosystem
- Experimental Licence Module for 100 5G Labs' launched at IIT Madras
- President of India Draupadi Murmu launched India's first domestic gene therapy for cancer at IIT Bombay.
- ➤ French aerospace and defence firm Starburst Accelerator SARLhas partnered with the Indian Institute of Technology Madras (IIT Madras) to set up an innovative hub for start-ups with €100 million in funding support.
- > IIT Madras has developed an indigenous electric standing wheelchair called 'NeoStand,' claimed to be India's most customizable wheelchair for the benefit of wheelchair users
- Ministry of Heavy Industries (MHI) and the Indian Institute of Technology, Roorkee (IIT Roorkee) have collaborated to establish a Centre of Excellence and Industry Accelerator in the automotive and electric vehicle (EV) sector.

✓ Parliament has passed a bill to "ban the offering, operation, facilitation, advertising, promotion and participation in online money games". It will be banned under the Information Technology Act, 2000.



- ✓ The online money games currently operating in the country will be banned under the Information Technology Act, 2000.
- ✓ The bill proposes imprisonment of up to three years and a fine of up to ₹1 crore for entities involved in or promoting online money gaming.
- ✓ Advertising such games will attract a fine of up to ₹50 lakh or imprisonment of up to two years. Repeat offences will attract enhanced punishment including 3-5 years imprisonment and a fine of up to ₹2 crore.
- ✓ The move will impact India's \$3.8 billion gaming industry, which has attracted global investors and boosted fantasy sports apps such as Dream11, Games24X7 and Mobile Premier League.
- ✓ The Bill has been introduced in the House on the recommendation of the President under Articles 117(1) and 117(3) of the Indian Constitution.

- ✓ The announcement was made from Pune, Maharashtra.
- ✓ Suzlon has already achieved 92.87% carbon neutrality at its Dhule rotor blade plant.
- ✓ It aims for Scope 1 & 2 carbon neutrality by 2035 and Net Zero (Scope 1, 2 & 3) by 2040.
- ✓ Suzlon is also India's first Gold Member in RE100, recognized for sustainable manufacturing leadership

- The 14th India-Singapore bilateral military exercise, code-named "Bold Kurukshetra", commenced at Jodhpur Military Station of the Indian Army in Rajasthan, on 27 December 2025.
- ➤ Indian Navy will participate in the 32nd edition of the Singapore India Maritime Bilateral Exercise (SIMBEX), earlier known as Exercise Lion King.
- ➤ 'Jaa Mata', a Joint Exercise, was held from July 7–12, 2025, off the Chennai coast, marking deeper India–Japan Coast Guard cooperation.
- ➤ The eighth edition of the Indo-French army exercise, 'Shakti 2025', that started on June 18 concluded in France .
- ➤ The 6th edition of Exercise DUSTLIK, a bilateral joint military drill between India and Uzbekistan, commenced on April 16, 2025, at the Foreign Training Node, Aundh, Pune, Maharashtra.
- ➤ The eighth edition of the bilateral Indo-French military exercise 'Shakti' begins on June 18, 2025, Camp Larzac, La Cavalerie in France.
- ➤ The first-ever joint special operations exercise between the Indian Air Force and the US Air Force, named "Tiger Claw," took place from May 26 to June 10, 2025.
- ➤ The Indian Army participated in Exercise Khaan Quest 2025, a multinational peacekeeping exercise held in Mongolia. The exercise, co-hosted by the Mongolian Armed Forces and the U.S.
- The 3rd edition of the India, Egypt military 'Exercise Cyclone' 2025 commenced at the Mahajan Field Firing Range, Rajasthan on the 10th of February 2025.
- ➤ The sixth edition of Exercise Dharma Guardian is scheduled to take place from February 25 to March 9, 2025, at Mount Fuji, Japan.
- > The 18th edition of the India-Nepal joint military exercise "Surya Kiran" has commenced at Saljhandi, Nepal.
- ➤ Indian Army contingent departed for 17th edition of India- Mongolia Joint Military Exercise NOMADIC ELEPHANT which is scheduled to be conducted in Ulaanbaatar, Mongolia.
- ➤ Bangladesh is participating with India in the 6th edition of the Coordinated Patrol (CORPAT) and the 4th edition of the bilateral exercise 'BONGOSAGAR' in 2025.
- > The 12th edition of the India-Kyrgyzstan Joint Special Forces Exercise Khanjar-XII is set to take place in Kyrgyzstan
- ➤ The Indian Army and Indian Air Force conducted EX Winged Raiders in the Eastern Theater.



- ➤ The 13th edition of the joint India-Maldives military exercise 'Ekuverin' is being hosted by Maldives from 2-15 February 2025.
- The indigenously designed and built guided missile destroyer INS Mumbai is participating in the Exercise LA PEROUSE.
- ➤ It is the fourth edition of the multinational naval exercise
- ➤ The 12th edition of the India-Kyrgyzstan Joint Special Forces Exercise KHANJAR-XII is set to take place in Kyrgyzstan from 10 March to 23 March 2025.

- > Cochin International Airport Limited (CIAL) is recognised as the first Indian airport developed under the Public-Private Partnership (PPP) model.
- Mumbai's Chhatrapati Shivaji Maharaj International Airport (CSMIA) has secured the ninth spot among the top-10 international airports in the prestigious Travel + Leisure World's Best Awards 2025.
- ➤ Singapore Changi Airport has been named the World's Best Airport 2025 by air transport rating organization Skytrax.



- ➤ Hubballi Airport in Karnataka earned Platinum Recognition under the ACI Green Airports Recognition (GAR) 2025 for its 8 MW solar power plant.
- > PM Modi laid the foundation stone of the Rs 410 crore second terminal building of the Maharaja Agrasen Airport at Hisar, Haryana.
- ➤ Delhi International Airport, operated by GMR Airports Infrastructure Limited, won the ASQ Airport Experience Award 2024 for the Best Airport Over 40 Million Passengers in the Asia-Pacific region.

- ✓ Government of India (GoI) has revised its target to add an additional 97 Giga Watt (GW) of coal and lignite-based power generation capacity by Financial Year 2034-35 (FY35), up from the earlier projection of 90 GW by FY32.
- ✓ The revised target aims to achieve a total of 307 GW of coal and lignite-based thermal power installed capacity by FY35.



- ✓ This coal capacity addition is aligned with India's larger energy roadmap that seeks to achieve 500 GW of Renewable Energy (RE) capacity by 2030 and the Net Zero emissions target by 2070.
- ✓ According to the National Electricity Plan (NEP) 2023 (Generation), India's total installed capacity is expected to reach 874 GW by FY32.

- ✓ NCERT Launches Educational Modules on Operation Sindoor for Classes 3–12.
- ✓ National Council of Educational Research and Training (NCERT) introduced two educational modules for Classes 3-12 to educate students about Operation Sindoor, India's strategic response to the Pahalgam terror attack.
- ✓ Operation Sindoor was launched in May 2025 as a response to the April 22, 2025, Pahalgam terrorist attack, which killed 26 tourists.
- ✓ It targeted terrorist camps in Pakistan and Pakistan-occupied Jammu and Kashmir (PoJK), coordinated by Lashkar-e-Taiba, and planned with intelligence from the Indian Armed Forces.
- ✓ NCERT created two modules: "Operation Sindoor A Saga of Valour" for Classes 3-8 using stories and activities to engage young learners, and "Operation Sindoor A Mission of Honour and Bravery" for Classes 9-12 with detailed analysis of strategy, execution, and operational outcomes.

- ✓ India and Saudi Arabia Establish Joint Working Group to Strengthen Maritime Trade, Logistics, and Sustainable Infrastructure.
- ✓ Bilateral trade between India and Saudi Arabia stood at approximately USD 42 billion in FY 2024–25. The maritime cooperation initiative aligns India's Maritime India Vision 2030 and Amrit Kaal Vision



2047 with Saudi Vision 2030, offering synergistic pathways in logistics, sustainability, and trade infrastructure.

- ✓ India invited Saudi investment into its maritime ecosystem through its Maritime Development Fund, with a corpus exceeding USD 3 billion. Major projects like Vadhavan Port (Maharashtra) and the Outer Harbour Project at VO Chidambaranar Port (Tamil Nadu) were presented as prime investment opportunities.
