- ✓ 2nd tranche increased from ₹20,000 to ₹25,000
- ✓ 3rd tranche remains ₹50,000
- ✓ Digital Integration:
- ✓ UPI-linked RuPay Credit Cards for beneficiaries after successful repayment of the second loan.
- ✓ Cashback incentives of up to ₹1,600 on retail and wholesale digital transactions.
- ✓ **Expanded Coverage:**
- ✓ Now includes census towns and peri-urban areas, beyond statutory towns.
- ✓ Capacity Building & Support:
- ✓ Focus on entrepreneurship, financial literacy, digital skills, and marketing.
- ✓ Street food vendors to receive FSSAI-certified hygiene and food safety training.
- ✓ SVANidhi se Samridhi component to be strengthened with monthly Lok Kalyan Melas for saturation of other government welfare schemes.
- ✓ **PM Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) Scheme.**
- ✓ Launched on June 1, 2020 by the Ministry of Housing and Urban Affairs (MoHUA).
- ✓ Part of the Atmanirbhar Bharat Abhiyan.

- ✓ 1st loan: up to ₹10,000.
- ✓ 2nd loan: up to ₹20,000.
- ✓ 3rd loan: up to ₹50,000.
- ✓ Includes incentives for digital transactions and timely repayment.
- ✓ Promotes formalization of street vendors into the banking and digital ecosystem.

## EXTENDED TIMELINE IN NEWS 2025

- The Cabinet has approved the extension and revamp of the Prime Minister Street Vendors AtmaNirbhar Nidhi (PM SVANidhi) scheme till March 31, 2030, with an outlay of ₹7,332 crore
- The PM E-DRIVE scheme, initially set to conclude in March 2026, has been extended by two years, now ending on March 31, 2028.
- The PM E- Drive scheme , with an outlay of Rs.10,900 crore , shall be implemented from October 1,2024 to March 31,2028
- Revamped Distribution Sector Scheme (RDSS) by two years till March 2028.
- Initiative of: Ministry of Power
- Duration: 5 years i.e., from FY 2021-22 to FY 2025-26. Extended by two years till FY 2027-28.
- The Finance Ministry has extended the deadline to opt for the Unified Pension Scheme (UPS) till September 30, 2025, giving central government employees three extra months to decide whether to switch from the National Pension System (NPS).
- The earlier deadline was June 30, 2025.
- NPCI has extended the deadline for implementing the 30% UPI market share cap for Third-Party App Providers (TPAPs) to December 31, 2026
- The government of India has extended the free import of Urad pulses till 31st March 2026 to control the price of the essential pulses in the country.
- Finance Minister Nirmala Sitharaman's announcement to extend the deadline for incorporation of startups by five years until April 1, 2030.

- ✓ The process is overseen by the Department of Investment and Public Asset Management (DIPAM).
- ✓ GoI currently holds over 89% stake in each bank.

- Divya Deshmukh of Maharashtra became the first Indian chess player to win the FIDE Women's Chess World Cup title by beating compatriot Grandmaster (GM) Koneru Humpy.
- Divya Deshmukh becomes the first Indian woman to reach the FIDE Women's World Cup Final and secures a spot in the 2026.
- FIDE has announced that India will host the Chess World Cup from 30 October to 27 November 2025.
- Harikrishnan A. Ra has become India's 87th Grandmaster.
- Magnus Carlsen, the world number one chess player, secured victory in the SuperUnited Rapid and Blitz 2025 tournament held in Zagreb, Croatia
- L.R. Srihari became the 86th chess Grandmaster of India by securing his third Grandmaster norm at the Asian Individual Men's Chess Championship 2025.
- Indian Grandmaster Pranav Venkatesh, aged 18, won the FIDE World Junior Chess Championship 2025
- Grandmaster R Praggnanandhaa clinched the Tata Steel Masters 2025 title in Netherlands by defeating World Champion D Gukesh.
