- ✓ Ministry of New and Renewable Energy of the Government of India notified its first national policy on geothermal energy, which laid out a framework for exploration, resource assessment, and project development across the country.
- ✓ According to the Ministry of New and Renewable Energy (MNRE), the Geological Survey of India (GSI) has so far identified 381 hot springs spread across 10 geothermal areas including Ladakh, Himachal Pradesh, Uttarakhand, Arunachal Pradesh, Sikkim, Jharkhand, Chhattisgarh, Gujarat, Odisha, Maharashtra, and Telangana, with surface temperatures ranging from 35°C to 89°C.
- ✓ MNRE said that 100 percent foreign direct investment (FDI) is allowed in the geothermal energy sector, with the main focus on indigenous technology development to reduce dependence on imports.
- ✓ This policy has been designed to make geothermal energy an important part of the country's renewable energy mix and to achieve India's ambitious goal of net-zero emissions by 2070.
- ✓ **About geothermal energy**
- ✓ India has a capacity of 10,600 megawatts of electricity generation as assessed by the Geological Survey of India (GSI), which is enough to power 10 million homes.
- ✓ Major projects include a 20-kilowatt pilot plant at Manuguru, Telangana, and a 1-megawatt project by ONGC in Puga Valley, Ladakh.

- ✓ India has signed agreements for geothermal energy cooperation with countries like Iceland (2007), Saudi Arabia (2019), and with the USA (2023) under the Renewable Energy Technology Action Platform (RETAP).
- ✓ Geothermal energy is heat derived from the Earth (Geo = Earth, Thermal = Heat).
