



- ✓ He won the National Film Award for Best Actor in 1991 for his performance in Bharatham
- ✓ He has previously received Padma Shri (2001), Padma Bhushan (2019), five National Film Awards, and nine Kerala State Film Awards.
- ✓ About Dadasaheb Phalke Award:
- ✓ It is given by the Indian government for lifetime contribution to Indian cinema.
- ✓ It was instituted in 1969 the birth centenary year of Dadasaheb Phalke.
- ✓ It is the highest award in the field of cinema in India.
- ✓ The award's inaugural recipient was Devika Rani, aptly titled "the first lady of Indian cinema".
- ✓ The recipients are recognized for their 'outstanding contribution to the growth and development of Indian cinema'.
- ✓ Award includes: The award comprises a Swarna Kamal (Golden Lotus) medallion, a shawl, and a cash prize of ₹15 lakh.
- ✓ The Dadasaheb Phalke Award's prize money has been raised from Rs 10 lakh to Rs 15 lakh.
- ✓ It is presented by the President of India.
- ✓ Key Facts about Dadasaheb Phalke:
- ✓ He was born on April 30, 1870, in Trimbak, Maharashtra.
- ✓ He was a film director who is considered the father of Indian cinema.
- ✓ He directed India's first full-length feature film, Raja Harishchandra in 1913.

- ✓ Neeraj Ghaywan's Hindi film Homebound has officially been selected as India's entry in the Best International Feature Film category at the Oscars 2026.
- ✓ The 98th Academy Awards will be held on March 15, 2026, at the Dolby Theatre in Los Angeles.
- ✓ Story of Hindi film Homebound
- ✓ Homebound is inspired by journalist Basharat Peer's New York Times article "Taking Amrit Home", which explores themes of friendship, caste, and mortality during the Covid-19 pandemic.
- ✓ Set against the backdrop of rural India, Homebound portrays the friendship and struggles of a Dalit, Chandan (Jethwa), and a Muslim, Shoaib (Khattar), who are determined to face every hardship in pursuit of a better life.
- ✓ India's first film for the Oscars
- ✓ India has been sending its films to the Oscars since 1957, when Mehboob Khan's Mother India became the country's first film to go to the Oscars. Last year, Kiran Rao's Laapataa Ladies was India's entry, though it failed to make it to the Top 15 shortlist.
- ✓ Oscar winners
- ✓ At the 95th Academy Awards in 2023, three Indian films received Oscar nominations: the song "Naatu Naatu" from the film RRR was nominated for Best Original Song, the documentary feature All That Breathes was nominated for Best Documentary Feature, and the short documentary The Elephant Whisperers was nominated for Best Documentary Short.

- ✓ This selection marks another milestone in director Neeraj Ghaywan's journey, who is known for his critically acclaimed debut film Masaan (2015).

- ✓ The Comptroller and Auditor General (CAG) of India has released its first-of-its-kind State Finance 2022-23 report on public debt of all 28 states.
- ✓ According to the report, states' debt has increased from ₹17.57 lakh crore in 2013-14 to ₹59.60 lakh crore in 2022-23.
- ✓ This report presents a decadal analysis of the fiscal position of the states. It was released by CAG K. Sanjay Murthy during the Conference of State Finance Secretaries.
- ✓ According to the report, at the end of the financial year 2022-23, the total public debt of 28 states was 22.96 percent of their combined Gross State Domestic Product (GSDP) of ₹2,59,57,705 crore. GSDP is the value of all finished goods and services produced within the geographical boundaries of a state.
- ✓ The report said, "Compared to the total public debt of states at ₹17,57,642 crore in 2013-14, the debt in the financial year 2022-23 has increased 3.39 times, from 16.66 percent of GSDP to 22.96 percent."
- ✓ States are required to achieve a fiscal deficit of 3.5% of GSDP in the financial year 2022-23.
- ✓ Comptroller and Auditor General
- ✓ Currently, the Comptroller and Auditor General (CAG) of India is Shri K. Sanjay Murthy.
- ✓ CAG, constitutional provisions are mainly mentioned in Articles 148 to 151 of the Constitution, which relate to the appointment, oath, duties, powers, and reports of the CAG. Article 148 provides for an independent office of the CAG.



- ✓ The CAG can be removed in the same manner and on the same grounds as a judge of the Supreme Court, ensuring his independence

- ✓ CAG's first State Finance 2022-23 Report Key Facts
- ✓ According to the report, at the end of 2022-23, the highest debt-to-GSDP ratio was recorded in Punjab at 40.35 percent, followed by Nagaland (37.15 percent) and West Bengal (33.70 percent).
- ✓ The lowest ratios were recorded in Odisha (8.45 percent), Maharashtra (14.64 percent), and Gujarat (16.37 percent).
- ✓ States' public debt includes borrowings from the open market through securities, treasury bills, bonds, etc.; borrowings from the State Bank of India and other banks; Ways and Means Advances (WMA) from the Reserve Bank of India; and loans from financial institutions such as the Life Insurance Corporation (LIC) and the National Bank for Agriculture and Rural Development (NABARD).
- ✓ Wide disparity in revenue capacity: The share of States' Own Tax Revenue (SOTR) is 70% in Haryana and only 9% in Arunachal Pradesh

- ✓ It represents a significant milestone in benchmarking logistics performance across States and Union Territories.
- ✓ It was conceived on the lines of the Logistics Performance Index of World Bank in 2018
- ✓ It is prepared by the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry.
- ✓ LEADS 2025 Framework is as follows
- ✓ Objective Indicator: It consists of regulatory and institutional support and logistics enablers.
- ✓ Perception indicators: It consists of Logistics Infrastructure, Logistics Services, Operating and Regulatory Environment, introduced Sustainable Logistics.
- ✓ Two major features of LEADS 2025:
- ✓ Performance assessment of 5–7 key corridors based on journey time, truck speed, and waiting periods.
- ✓ API-enabled evaluation of section-wise speeds on major road corridors

- ✓ It is supported by United Nations India.
- ✓ It is a first-of-its-kind programme designed to empower tribal youth through structured learning, mentorship, and career development.
- ✓ Features of Adi Yuva Fellowship:



- ✓ Under this initiative selected tribal youth will undertake a 12-month paid Fellowship, with a tailored learning plan that balances knowledge-building, on-the-job experience, and reflective practice.
- ✓ **Allowances:** Fellows will receive monthly allowances, comprehensive health and life insurance, and access to high-quality UN and commercial learning platforms.
- ✓ This programme will link Fellows to national skilling and employability schemes such as PMKVY 4.0, NAPS, and PM Viksit Bharat Rozgar Yojana.
- ✓ **Selection process:** The fellows will be selected through a competitive process and placed with UN agencies at the national, state, and district levels.

- ✓ Praveen Kumar
- ✓ The former Special Director of the Intelligence Bureau has been appointed as the Director General of the Indo-Tibetan Border Police. IPS officer Mukesh Singh will serve as Additional Director General of ITBP.
- ✓ Praveen Kumar, Special Director of the Intelligence Bureau, has been appointed as DG of ITBP till 30 September, 2030, which is his date of retirement.
- ✓ Indo-Tibetan Border Police (ITBP)
- ✓ It was established on 24 October, 1962.
- ✓ It guards the 3,488 km long India-China border stretching from Ladakh to Arunachal Pradesh.
- ✓ It is a mountain force specializing in high-altitude operations.
- ✓ Its motto is: "Shaurya-Dridhata-Karm Nishtha" (Valour-Determination-Devotion to Duty).

- ✓ According to an order issued by the Ministry of Personnel, the Appointments Committee of the Cabinet has approved his appointment as DG of CISF till 31 July, 2029, which is his date of retirement.
- ✓ He will replace the current chief Rajwinder Singh Bhatti, who will retire at the end of this month
- ✓ About CISF
- ✓ The CISF was established in 1969 by the Indian government under the Central Industrial Security Force Act, 1968

- ✓ Israel successfully tested missile defense laser system 'Iron Beam'
- ✓ The Ministry of Defense of Israel has announced the successful test of "Iron Beam." It is a high-power laser system designed to destroy incoming missiles.
- ✓ Developed by Elbit Systems and Rafael, it will complement existing missile defense systems like Iron Dome.
- ✓ Developed by Rafael Advanced Defense Systems, "Iron Beam" will complement Israel's Iron Dome, David's Sling, and Arrow anti-missile systems, which have been used to intercept thousands of rockets fired by Hamas terrorists from Gaza, Hezbollah from Lebanon, and Houthis from Yemen.
- ✓ 'Iron Dome'
- ✓ It is a short-range surface-to-air "air defense system." This system tracks and neutralizes any incoming rocket or missile. To do this, the defense system is equipped with radar and Tamir interceptor missiles.

#### **MISSILE IN NEWS 2025**

- ➤ Israel successfully tested missile defense laser system 'Iron Beam'
- > Swedish defense company Saab recently announced the development of a new missile named Nimbrix
- Russia is preparing for new tests of its much-discussed and feared 9M730 Burevestnik nuclear-powered cruise missile, a "one-of-a-kind" weapon in Moscow's arsenal
- ➤ Iran may have developed or prepared for testing its first intercontinental ballistic missile (ICBM), called Khorramshahr-5.



- Turkey recently unveiled its first hypersonic ballistic missile, the Tayfun Block-4, in Istanbul.
- Russia has reportedly offered the R-37M missile, one of the world's best air-to-air missiles, to India.
- ➤ Iran recently unveiled two missiles, named Etemad and Ghadr-380.
- ➤ India has successfully tested the Bhargavastra, its first micro-missile system designed to counter swarm drones.
- ➤ About Bhargavastra:
- It is India's first indigenous micro-missile system designed to take on the threat of swarm drones.
- ➤ It was developed by the Economic Explosives Ltd.
- ➤ It can quickly deploy on a mobile platform and hit targets over 2.5 km.
- Turkey has successfully tested the firing of the supersonic missile UAV-122 from the Bayraktar Akinci drone.
- ➤ DRDO successfully test-fired a long-range hypersonic missile from Dr. APJ Abdul Kalam Island, off the coast of Odisha, on November 16, 2024. The missile was designed to carry payloads over 1,500 kilometers.
- > Tu-22M3 missile carriers of the Russian Aerospace Forces recently struck Snake Island in the Black Sea with Kh-22 cruise missiles.
- ➤ Indian Air Force has given its green signal for the production of 200 Astra mark-1 (Mk-1) missiles for its Su-30 MKI and the indigenously developed Light Combat Aircraft Tejas.
- The DRDO developed the Astra Mk-1, which is being manufactured by Bharat Dynamics Limited.
- ➤ The Astra is an air-to-air beyond visual range (BVR) missile. Astra Mk-1 has a range of 80-110 km with a maximum speed of 4.5 Mach.
- ➤ Indian "Iron-Dome" Akash Surface-to-Air Missile (SAM) is competing against Chinese-made Sky Dragon-50 air defense systems to secure an order from Brazil.
- ➤ India has successfully test-fired its first indigenous anti-radiation missile, the Rudram-1 (air-to-surface missile), developed by the DRDO for the Indian Air Force (IAF)
- ➤ India's Strategic Forces Command has successfully tested a new model of its Medium-Range Ballistic Missile, Crystal Maze 2.
- Russia will supply the remaining two units of the S-400 Triumf surface-to-air missile system in the next year.

- ✓ India Opens 1st Overseas Defence Plant in Morocco under Atmanirbhar Bharat.
- ✓ Defence Minister Rajnath Singh went on a two-day official visit to Morocco starting from September 22, 2025.
- ✓ This will be the first visit by an Indian Defence Minister to the North African country, highlighting the growing strategic cooperation between India and Morocco.
- ✓ During the visit, the Defence Minister will also inaugurate Tata Advanced's newly developed manufacturing facility for Wheeled Armored Platforms in Casablanca, Morocco.
- ✓ This facility is the first Indian defense manufacturing plant on foreign soil and in Africa, marking a significant milestone that reflects the growing global presence of India's defense industry under the Atmanirbhar Bharat initiative.
- ✓ Mr. Singh will lead a delegation to inaugurate the Tata Advanced Systems Limited (TASL) plant, established in partnership with the Royal Armed Forces of Morocco
- ✓ This Morocco facility will become operational within the next 12 months, and the first batch of vehicles is expected to be ready in 2027.
- ✓ Geographically, Morocco is located in North Africa along the Atlantic Ocean and the Mediterranean Sea. It is bordered by Algeria and Western Sahara.

- ➤ India, Japan to Co-Develop Advanced UNICORN Naval Antenna System for Indian Navy Platforms
- ➤ India and Kuwait have agreed to expand their bilateral air travel capacity by 50 per cent.
- ➤ Telecom Egypt signed an MoU with KareXpert during the Africa Health ExCon 2025 in Cairo, Egypt.
- Indian Railways has signed an agreement with the Dedicated Freight Corridor Corporation of India Limited (DFCCIL) to deploy AI-based Machine Vision Inspection Systems (MVIS).



- ➤ India & Chile Sign Terms of Reference for to start CEPA negotiation
- > Chile signed multiple Memorandums of Understanding (MoUs) with India to strengthen cooperation in innovation and entrepreneurship.
- > India and Argentina have signed a memorandum of understanding (MoU) to deepen collaboration in the exploration and development of lithium mines in Argentina.
- > India and Oman have signed a protocol to amend the Double Taxation Avoidance Agreement (DTAA).
- > India and Spain have signed two memorandum of understanding (MoU) to strengthen and deepen the bilateral relations between the two countries.
- ➤ Union Cabinet has approved the Memorandum of Understanding (MoU) signed by the Union Ministry of Cooperation and the Ministry of Trade of Indonesia.
