- ✓ SRO-FT (Fintech) : A minimum net worth of ₹2 crore is required.
- ✓ General Financial Market SROs: For example, the FIMMDA, a recognized SRO in the financial markets, requires a minimum net worth of ₹10 crore.
- ✓ For a SRO within the Account Aggregator (AA) ecosystem, the minimum net worth requirement is ₹2 crore.
- ✓ The first self-regulatory organization (SRO) in India's fintech sector, as recognized by the RBI, is the Fintech Association for Consumer Empowerment (FACE).
- ✓ The Fixed Income Money Market and Derivatives Association of India (FIMMDA) was officially recognized by the RBI as a Self-Regulatory Organization (SRO) for financial markets in May 2025.
- ✓ An SRO must be a not-for-profit company with a minimum net worth of Rs.10 crore and diversified shareholding (no single entity holding more than 10% of the paid-up share capital).
