- ✓ RBI Revises Norms for Settlement of Deceased Customers' Bank Accounts and Lockers, Prescribes 15-Day Timeline.
- ✓ Reserve Bank of India (RBI) issued revised norms for the settlement of deceased customers' bank accounts and lockers, mandating banks to settle claims within 15 days and specifying compensation for delays.
- ✓ The new directives aim to streamline the claims process, enhance accountability, and ensure timely compensation to nominees.
- ✓ RBI has set the threshold limits at ₹15 lakh for deposit accounts (any other bank) and ₹5 lakh for co-operative banks.
- ✓ Banks can request additional documents such as a succession certificate or legal heir certificate if the aggregate amount exceeds these limits.
- ✓ In case of delays, banks are mandated to pay interest at the bank rate + 4% per annum for deposits.
- ✓ For safe deposit lockers or articles in safe custody, banks must compensate claimants at the rate of ₹5,000 per day of delay.
- ✓ Banks are required to implement the revised instructions at the earliest and not later than March 31, 2026.
- ✓ The norms were issued under the "RBI (Settlement of Claims in respect of Deceased Customers of Banks) Directions, 2025."

- ✓ Bank of Baroda (BOB) signed a Memorandum of Understanding (MoU) with Tata Power Renewable Energy Limited (TPREL), a subsidiary of Tata Power, to provide financial support to Micro, Small, and Medium Enterprises (MSMEs) and Commercial & Industrial (C&I) customers for the adoption of solar energy.
- ✓ The collaboration aims to enhance BOB's lending capabilities, expand solar adoption, and increase efficiency in India's bullion and renewable energy markets.
- ✓ Under this MoU, BOB will offer collateral-free loans up to ₹10 crores for solar projects.
- ✓ Loans will have flexible repayment tenure up to 120 months (10 years), with interest rates starting at 7.75%, via TPREL or its authorized partners for projects up to 10 Megawatt (MW) capacity.
- ✓ With this MoU, BOB becomes the second Public Sector Bank (PSB) after the State Bank of India (SBI) to receive TCM status, enabling it to access international and domestic clients for gold and silver contracts on IIBX.

- ✓ **About PM E-DRIVE Scheme:**
- ✓ The PM E-DRIVE (Electric Drive Revolution in Innovative Vehicle Enhancement) scheme is a flagship initiative launched in October 2024 with a financial outlay of Rs.10,900 crore.
- ✓ It came into effect from October 1, 2024, and will remain in force until March 31, 2026.
- ✓ Its primary aim is to accelerate the adoption of electric vehicles (EVs), establish charging infrastructure, and build a robust EV manufacturing ecosystem in the country.
- ✓ It promotes mass mobility through the support of public transportation systems.
- ✓ The key objective is to speed up the transition to EVs by offering upfront incentives for EV purchases and encouraging the development of charging infrastructure.
- ✓ The PM E-DRIVE scheme to be implemented through the following key components:
- ✓ Subsidies: Demand incentives to be provided for electric vehicles such as e-2 wheelers (e-2W), e-3 wheelers (e-3W), e-ambulances, e-trucks, and other emerging categories of EVs.
- ✓ Grants for creation of capital assets: Funding to be provided for the acquisition of electric buses (e-buses), the establishment of a comprehensive network of charging stations, and the upgrading testing facilities of the Ministry of Heavy Industries (MHI).
- ✓ To qualify for the PM E-DRIVE incentives, vehicles must be registered as “Motor Vehicles” under the Central Motor Vehicle Rules (CMVR) and equipped with advanced battery technology.

- ✓ The facility has been set up with an investment of ₹13.5 crore, with support from the A.P. Moller Foundation, which contributed about ₹6.5 crore (750,000 USD) to the project, further strengthening the collaboration of more than 25 years between AMET and Maersk

- India's first Central Tissue Bank and a new cashless "We-Office" for the Delhi Dental Council were inaugurated at the Maulana Azad Institute of Dental Sciences (MAIDS), Delhi.
- Agnikul Cosmos Launches India's First Large-Format 3D Printing Facility for Rocket Systems at IIT-Madras.
- India's first overseas Atal Innovation Centre was inaugurated at the IIT Delhi campus in Abu Dhabi, United Arab Emirates.
- An Assam-based foundation has developed India's first portal for vulture conservation, called The Vulture Network.
- The portal was launched on September 2, 2025, by We Foundation India in collaboration with Gauhati University's Department of Zoology.
- BharatPe and Unity Small Finance Bank (Unity Bank) recently launched the Unity Bank BharatPe Credit Card—India's first EMI-driven credit card on the RuPay network.
- Kerala has become India's first 100% digitally literate state.
- Banaras Locomotive Works (BLW) installs India's first detachable solar panels between railway tracks, a milestone in Indian Railways.
- Gujarat has become the first Indian state to launch a Tribal Genome Sequencing Project.
- India's first digital nomad village was launched in Yakten, located in the Pakyong district of Sikkim.
- Fintech firm Slice has pioneered India's first fully UPI-powered bank branch in Bengaluru's Koramangala area.
- Indore Municipal Corporation (IMC) in Madhya Pradesh launched India's first digital house address project.
- India's first wildlife corridor on the Delhi-Mumbai Expressway features the country's longest animal underpass and five overpasses near Ranthambore.
- India's first AI-powered traffic system comes up on Dwarka Expressway in Delhi.
- The ATMS implementation spans the Dwarka Expressway and also a 28-km section of NH-48.
- Union Minister for Ports, Shipping and Waterways, Sarbananda Sonowal, inaugurated India's first Non-Banking Financial Company-NBFC in the maritime sector, Sagarmala Finance Corporation Limited-SMFCL.

- India's first manned deep ocean mission 'Samudrayaan' into a 6,000-metre depth using the manned submersible vehicle 'Matsya' is expected to be launched by the end of 2026.
- India's first privately built geostationary orbit (GSO) communication satellite is expected to be ready by 2028. Ananth Technologies, an Indian private firm, is developing this satellite.
- Rajasthan is indeed joining Madhya Pradesh in India's first cheetah reintroduction project.
- This corridor will link Palpur Kuno National Park and Gandhi Sagar Sanctuary in Madhya Pradesh with Mukundara Hills Tiger Reserve in Rajasthan.

- ✓ Currently, India is the sixth largest exporter of seafood globally and the second largest producer of fish through aquaculture. In the financial year 2023–24, India exported 1.78 million tonnes of seafood worth ₹60,523.89 crore (approximately 7.38 billion USD).
