Q.1. The Reserve Bank of India (RBI) recently proposed a draft framework allowing banks to finance corporate acquisitions up to a 70% cap. This financing, along with other investments in the sector, will fall under prudential limits related to which key term?

Answer : C

- ✓ **RBI proposes 70% cap on financing for acquisitions and limits on CME .**
- ✓ Reserve Bank of India (RBI) issued the draft circular on acquisition financing that proposes to allow banks to finance as much as 70% of the acquisition value, provided the rest 30% comes from acquirer.
- ✓ The RBI also released a draft circular proposing limits on banks' exposure to capital markets and acquisition finance
- ✓ The draft framework, "RBI (Commercial Banks – Capital Market Exposure CME)) Directions, 2025" has proposed to allow banks to finance corporate acquisitions in India and abroad.
- ✓ New Norms: Under the proposed framework, banks will be permitted to fund up to 70% of the acquisition value, with the remaining 30% to be contributed by the acquiring company.
- ✓ This means if the acquisition cost is Rs 10,000 crore (cr), banks can lend up to Rs 7,000 cr to fund the acquirer.
- ✓ The RBI has proposed that the aggregate exposure of a bank to acquisition finance shall not exceed 10% of its Tier-1 Capital.
- ✓ It must be a listed entity with a satisfactory net worth and a profit-making track record for the last three years.
- ✓ The acquisition value of the target company be determined by two independent valuations in accordance with Securities and Exchange Board of India (SEBI) regulations.
- ✓ The RBI proposed the framework, "The Capital Market Exposure Directions, 2025" seeking to redefine how banks engage with capital markets while ensuring prudential risk control.
- ✓ Effective: These directions will come into effect from April 1, 2026, or an earlier date when adopted by a bank in entirety.

- ✓ The RBI in the draft guidelines, stated that banks' total direct investments in capital markets and acquisition finance must not exceed 20% of their tier 1 capital.
- ✓ Additionally, the RBI proposed that the aggregate capital market exposure of banks should not exceed 40% of their tier 1 capital.

- ✓ The RBI's draft framework is titled the "RBI (Commercial Banks – Capital Market Exposure (CME)) Directions, 2025". The key limits proposed are:
- ✓ A bank's aggregate CME (both direct and indirect) must not exceed 40% of its Tier-1 capital.
- ✓ Within this overall limit, the direct capital market exposure (which includes acquisition finance) is capped at 20% of Tier-1 capital.
- ✓ The bank financing for a single acquisition deal is limited to 70% of the acquisition value, with the acquiring company funding the remaining 30% from its own funds.

- ✓ RBI to implement ECL framework, Full Basel – III Norms.
- ✓ The Expected Credit Loss (ECL) framework model moves away from the traditional incurred-loss approach to a forward-looking method, requiring banks to provision for possible future losses based on detailed credit risk assessment and broader data signals.

- ✓ The RBI proposed that the framework is proposed to be made applicable to all Scheduled Commercial Banks (excluding Small Finance Banks (SFBs), Payment Banks (PBs), Regional Rural Banks(RRBs)) and All India Financial Institutions (AIFIs) with effect from April 1, 2027.
- ✓ It also gives a glide path of nearly four years to smoothen any impact from higher provisioning.
- ✓ Basel –III: It is proposed to make the revised Basel III capital adequacy norms effective for commercial banks (excluding SFBs, PBs and RRBs) from April 1, 2027.
- ✓ India's Basel III capital ratios are higher than the global minimum Basel III norms. Under the Basel III framework globally, the minimum capital adequacy ratio (CAR) is 8%, plus a capital conservation buffer of 2.5%, totaling 10.5%. In contrast, the RBI mandates a higher minimum CAR of 9% and including CCB it is 11.5%.

RBI IN NEWS 2025

- RBI has significantly revised its lending norms for IPO financing and Loans Against Shares (LAS), increasing the IPO limit from ₹10 lakh to ₹25 lakh and the LAS limit from ₹20 lakh to ₹1 crore per person.
- FACE appoints ex-RBI executive Manoranjan Mishra as independent director.
- Fintech Association for Consumer Empowerment (FACE), a self-regulatory body for fintechs in the country.
- RBI extended the period for foreign currency payment or expenditure for Merchanting Trade Transactions (MTT) from four months to six months.
- The Reserve Bank of India (RBI) is taking important steps to make the Indian Rupee (INR) more global with India's neighbouring countries like Bangladesh, Bhutan, Nepal, and Sri Lanka.
- Reserve Bank of India (RBI) has decided to give a glide path of four years starting 1 April, 2027 for

expected credit loss (ECL) norms.

- ECL norms will not be applicable for Small Finance Banks (SFBs), Payment Banks (PBs), Regional Rural Banks (RRBs) and All India Financial Institutions (AIFIs).
- Reserve Bank of India (RBI) has withdrawn its 2016 circular, the "Guidelines on Enhancing Credit Supply for Large Borrowers through Market Mechanism,".
- The withdrawal took effect on April 1, 2026.
- As per the circular, the threshold of credit exposure to a borrower by the banking system was reduced from Rs 25,000 cr in FY18 to Rs 15,000 cr in FY19, and to Rs 10,000 cr from FY20.
- RBI has ordered Simpl, a Bengaluru based buy -now- pay- later(BNPL) firm, to shut its payment operations with immediate effect.
- Reserve Bank of India (RBI) issued new authentication rules for digital payments, effective April 1, 2026, which mandate two-factor authentication (2FA).
- Outward remittances by Indian residents under the Reserve Bank of India's (RBI) Liberalised Remittance Scheme (LRS) decreased by nearly 11% year-on-year in July 2025, reaching \$2,452.93 million from \$2,754.05 million in July 2024.
- Indian government will route funds for all Centrally Sponsored Schemes (CSS), with a total annual budget of Rs 5 lakh crore, directly through the Reserve Bank of India (RBI) to State Nodal Agencies (SNA).
- RBI has constituted a Regulatory Review Cell (RRC) as part of its efforts to strengthen the institutional mechanism for review of regulations.
- The mandate of the RRC, headed by State Bank of India Managing Director Rana Ashutosh Kumar Singh.
- DBS Bank India is the first wholly-owned subsidiary of a foreign bank in India to be authorized by the Reserve Bank of India (RBI) to collect Goods and Services Tax (GST) payments.
- The 32nd meeting of the sub-committee of the Financial Stability and Development Council (FSDC) was chaired by the Reserve Bank of India (RBI) governor, Sanjay Malhotra, to discuss economic challenges due to US tariffs, KYC simplification, and measures for financial inclusion.
- Former Reserve Bank of India (RBI) Governor Urjit Patel has been appointed as executive director at the International Monetary Fund(IMF).
- Urjit Patel served as the 24th Governor of the Reserve Bank of India (RBI) from September 2016 to

- The RBI's FREE-AI (Framework for Responsible and Ethical Enablement of Artificial Intelligence) Committee recommends that the Indian financial sector adopt a dual approach to AI, fostering innovation and mitigating risks together rather than in opposition.

- ✓ This linkage will connect India's Unified Payments Interface (UPI) with Bahrain's Electronic Fund Transfer System (EFTS), specifically, Fawri+ service, allowing users in both countries to send and receive money instantly and securely.

- NPCI Bharat Billpay integrates Bandhan Bank on Bharat connect.
- NPCI International Payments Ltd (NIPL), the international arm of India's National Payments Corporation of India (NPCI), has partnered with Qatar National Bank (QNB) to introduce QR code-based Unified Payments Interface (UPI) in Qatar.
- Qatar is now the eighth country to adopt India's UPI network, following in the footsteps of Bhutan, France, Mauritius, Nepal, Singapore, Sri Lanka, and the UAE.
- The new Unified Payments Interface (UPI) guidelines issued by the National Payments Corporation of India (NPCI) in May 2025 became effective on August 1, 2025.
- Balance inquiry limit: You can now check your bank balance a maximum of 50 times per day per UPI app.

- According to NPCI data, the Unified Payments Interface (UPI) recorded a record-breaking 20.01 billion transactions in August 2025, marking the first time it crossed the 20 billion monthly transaction milestone.

 - Total Value: ₹24.85 lakh crore.

- ✓ Total cost Rs.57,613 crore, with Rs.20,000 crore from the central government; supports bus operations for 10 years or until March 2037.
