- ✓ It shows how repeated disasters have affected countries over the last 30 years.
- ✓ **Published by:** It is published by Germanwatch, (a Bonn-based environmental and development organization).
- ✓ **First Published in:** It was first published in 2006.
- ✓ **It uses data from:**
 - ✓ EM-DAT international disaster database
 - ✓ International Monetary Fund
 - ✓ World Bank
- ✓ **3 Hazard Categories**
 - ✓ **Hydrological:** It includes Floods, glacial lake outbursts
 - ✓ **Meteorological:** It includes Storms, cyclones
 - ✓ **Climatological:** It includes Heatwaves, wildfires
- ✓ **Ranking:** A higher rank indicates greater vulnerability and damage from extreme weather events linked to human-induced climate change.
- ✓ **Key Findings**
 - ✓ **Total global impact between 1995 and 2024:**
 - ✓ Extreme weather caused over 832,000 deaths,
 - ✓ Affected 5.7 billion people, and
 - ✓ Produced losses over \$4.5 trillion..

- ✓ **Most Affected countries:** Dominica, Myanmar, and Honduras are the most affected in the long-term index.
- ✓ **Continuous threats:** The report places India, the Philippines, Nicaragua, and Haiti in a “continuous threats” category
- ✓ **Top countries:** All of the top ten countries on the list are in the Global South.
- ✓ The report also acknowledges gaps in data available for the Global South on extreme weather events
- ✓ **Findings related to India**
- ✓ Rank: India ranks 9th among the most affected countries.
- ✓ In terms of the number of people most affected by extreme weather in 2024, India ranked third behind Bangladesh and the Philippines.
- ✓ **In the last three decades (1995–2024):**
- ✓ India faced around 430 extreme weather events, which affected more than a billion people in the country, and more than 80,000 people were reported killed in these events, with losses of around \$170 billion.
- ✓ Flooding was the worst disaster overall, followed by heat waves, and droughts.

- ✓ The Union Cabinet, chaired by the Prime Minister, Shri Narendra Modi has approved introduction of Credit Guarantee Scheme for Exporters (CGSE) for providing 100% credit guarantee coverage by National Credit Guarantee Trustee Company Limited (NCGTC) to Member Lending Institutions (MLIs) for extending additional credit facilities upto Rs.20,000 crore to eligible exporters, including MSMEs.
- ✓ The scheme shall be implemented by Department of Financial Services (DFS) through National Credit Guarantee Trustee Company Limited (NCGTC) to provide additional credit support by MLIs to the eligible exporters including MSMEs.
- ✓ The Scheme is expected to enhance the global competitiveness of Indian exporters and support diversification into new and emerging markets.
- ✓ Exports are a critical pillar of the Indian economy, accounting for nearly 21% of GDP in FY 2024-25 and contributing significantly to foreign exchange reserves.
- ✓ Export-oriented industries directly and indirectly employ over 45 million people and MSMEs contributing nearly 45% of total exports.

- ✓ A flagship, outcome-based initiative aimed at creating a unified, technology-driven framework to promote exports, reduce trade barriers, and enhance India's competitiveness in global markets.
- ✓ **Launched in:** Announced in the Union Budget 2025–26 and approved by the Cabinet in November 2025.
- ✓ **Implemented by:** the Directorate General of Foreign Trade (DGFT) under the Ministry of Commerce and Industry.
- ✓ **Term :** To be implemented during FY 2025–26 to FY 2030–31, with a total financial outlay of ₹25,060 crore.
- ✓ **Aim:** To boost exports through financial and non-financial interventions, consolidate existing export schemes under one mission, and ensure inclusive, sustainable, and regionally balanced export growth aligned with Viksit Bharat @2047.
- ✓ **Key Features:**
- ✓ **Two Sub-schemes:**
- ✓ **Niryat Protsahan** – Enhances access to affordable trade finance via interest subvention, export factoring, and credit guarantees for MSMEs.
- ✓ **Niryat Disha** – Provides non-financial support such as export quality improvement, branding, packaging, logistics, trade fairs, and capacity building.
- ✓ The EPM consolidates several existing export support initiatives, such as the Interest Equalisation Scheme (IES) and the Market Access Initiative (MAI), into a single, comprehensive framework administered by the Directorate General of Foreign Trade (DGFT).

- ✓ It has successfully validated the parachute system which is crucial for safe landing of astronauts during the re-entry and touchdown phase of Gaganyaan mission, India's maiden human spaceflight mission.
- ✓ For the test, ISRO dropped a simulated mass equivalent to the Crew Module from an altitude of 2.5 kilometer (km) using the Indian Air Force (IAF)'s Ilyushin(IL)-76 aircraft.
- ✓ Parachutes: The parachute system consists of 10 parachutes of 4 types for the Gaganyaan crew module.
- ✓ The test was conducted with active participation from Vikram Sarabhai Space Centre (VSSC), Aerial Delivery Research and Development Establishment (ADRDE), Defence Research and Development Organisation (DRDO), IAF and Indian Army.

- ✓ The beach recorded over 5.5 lakh visitors in the previous year (2024-25), which reflects its rising popularity as an eco-beach destination model.
- ✓ TN has selected 10 other beaches across the state for the global certification.
- ✓ **4 beaches in Chennai:** Marina Beach, Palavakkam Beach, Thiruvanmiyur Beach and Uthandi Beach;
- ✓ **2 in Cuddalore:** Silver Beach and Saamiyarpettai Beach;
- ✓ **Remaining 4 beaches:** Keelapudhupattu Beach (in Villupuram) , Kameshwaram Beach (in Nagapattinam), Ariyaman (in Ramanathapuram) and Kulasekarapattinam (in Tuticorin).

- ✓ It is a globally recognised eco-label awarded by Denmark's Foundation for Environmental Education (FEE) across 3 main categories: beaches, marinas, and sustainable tourism operators.
- ✓ This global certification is subject to annual renewal following detailed inspections by national and international committees, assesses compliance based on 33 parameters across 4 main categories namely: environmental education and information, water quality, environmental management, and safety & services.
- ✓ Total Blue Flag-Certified Indian Beaches: In October 2025, 5 beaches from Maharashtra received the International Blue Flag Certification, bringing the total number of Blue Flag-Certified beaches from India to 18

- ✓ GI tags are issued as per the Geographical Indications of Goods (Registration and Protection) Act, 1999.
- ✓ This tag is issued by the Geographical Indication Registry under the Department of Industry Promotion and Internal Trade, Ministry of Commerce and Industry
- ✓ A Geographical Indication (GI) tag is valid for 10 years and must be renewed after that period upon payment of a renewal fee

- ✓ In many EU nations, GI is classified in two basic categories Protected GI (PGI) and Protected Destination of Origin (PDO). India only has the PGI category.

GI TAG IN NEWS 2025

- Meghalaya's indigenous textile 'Ryndia' has received the GI tag for its organic, handwoven, and naturally dyed fabric.
- Warangal Chapata Chilli, also known as Tomato Chilli, has been granted a Geographical Indication (GI) tag, recognizing its unique qualities and regional significance in Telangana.
- Kannadippaya, a traditional tribal handicraft from Kerala, has been awarded the Geographical Indication (GI) tag.
- Kumbakonam betel leaf, grown in the fertile Cauvery river basin of Thanjavur, has been granted a Geographical Indication (GI) Tag by the Government of India.
- The Saudagari block print, a traditional textile art form, has been officially granted a Geographical Indication (GI) tag.
- This craft is practised by artisans in Jamalpur, Ahmedabad, and has been preserved for nearly 300 years
- A consignment of 30 tonnes of Geographical Indication (GI)-tagged jaggery from Muzaffarnagar, Uttar Pradesh, has been shipped to Bangladesh.
- Meghalaya's Eri Silk, known locally as Ryndia silk, recently received a Geographical Indication (GI) tag in 2025.
- Rajasthan's famous sangri bean from the Thar Desert received the prestigious Geographical Indication (GI) tag.
- Rajasthan's famous dish, Ker Sangri, has recently received a Geographical Indication (GI) tag.
- Chanderi sarees and Maheshwari sarees from Madhya Pradesh have received Geographical Indication (GI) tag.
- The Government of India has set a target of 10,000 Geographical Indication (GI) tags for the Indian products by 2030.

- ✓ The Sustainable Harnessing of Fisheries in the EEZ Rules, 2025, notified under the Territorial Waters, Continental Shelf, Exclusive Economic Zone and Other Maritime Zones Act, 1976, came into force on 4 November 2025.
- ✓ The rules aim to boost seafood exports, empower local fishing communities, and focus on the Andaman & Nicobar(A&N) and Lakshadweep Islands, which together account for 49% of India’s EEZ.
- ✓ The Rules apply to all fishing and related activities in India’s EEZ, prioritizing Fishermen Cooperative Societies and Fish Farmer Producer Organizations (FFPOs) for deep-sea fishing and advanced vessel operations.
- ✓ Mechanized and motorized fishing vessels measuring 24 meters(m) or more must obtain an Access Pass via Registration And Licensing of Fishing Craft (ReALCRaft) to operate in the EEZ. It is issued under the Merchant Shipping Act, 1958.
- ✓ The Access Pass is valid for three years and must be renewed at least 30 days before expiration.
- ✓ 2.38 lakh vessels registered; 64,187 mechanized vessels need Access Pass; 1.72 lakh smaller vessels are exempt.
- ✓ ReALCRaft is being integrated with Marine Products Export Development Authority (MPEDA) and the Export Inspection Council (EIC) to issue Fish Catch and Health Certificates, essential for exporting seafood to premium international markets.
- ✓ Harmful fishing methods like Light Emitting Diode (LED) light fishing, pair trawling, and bull trawling prohibited.
- ✓ Minimum legal sizes are prescribed for all fish species, state-consulted Fisheries Management Plans aim to restore declining stocks, and mariculture is promoted as an alternative livelihood.
