- ✓ India's first privately built PSLV (Polar Satellite Launch Vehicle) is likely to launch in early 2026, with two additional missions planned during the year.
- ✓ The manufacturing contract was awarded to a HAL-L&T consortium, responsible for producing at least five PSLV launch vehicles for ISRO.
- ✓ The first mission, PSLV-N1, will carry the Earth-observation satellite EOS-10, though earlier timelines were delayed due to satellite unavailability.
- ✓ ISRO originally aimed for a 2025 launch, and one mission could have taken place this year if the payload had been ready.
- ✓ Polar Satellite Launch Vehicle (PSLV) is the third generation launch vehicle of India.
- ✓ The vehicle successfully launched two spacecraft "Chandrayaan-1 in 2008 and Mars Orbiter Spacecraft in 2013" that later travelled to Moon and Mars respectively

- Agnikul Cosmos Launches India's First Large-Format 3D Printing Facility for Rocket Systems at IIT-Madras.

- The portal was launched on September 2, 2025, by We Foundation India in collaboration with Gauhati University's Department of Zoology.
- BharatPe and Unity Small Finance Bank (Unity Bank) recently launched the Unity Bank BharatPe Credit Card—India's first EMI-driven credit card on the RuPay network.
- Kerala has become India's first 100% digitally literate state.

- India's first e-waste recycling park is indeed being developed in Delhi, specifically in Holambi Kalan, North Delhi.
- Andhra Pradesh govt has signed an MoU with the world's largest AI chip maker, NVIDIA, for the establishment of the Artificial Intelligence (AI) University in Amaravati.
- Kashmir researchers Sher-e-Kashmir University of Agricultural Sciences and Technology (SKUAST) have successfully developed India's first gene-edited sheep.
- EnKash has launched India's first unified payment gateway specifically designed for small and medium businesses (SMBs) and startups. This new platform, called the EnKash Payment Gateway.
- India's first manned deep ocean mission 'Samudrayaan' into a 6,000-metre depth using the manned submersible vehicle 'Matsya' is expected to be launched by the end of 2026.
- India's first privately built geostationary orbit (GSO) communication satellite is expected to be ready by 2028. Ananth Technologies, an Indian private firm, is developing this satellite.

- ✓ The proposed UPI-TIPS interlinkage aims to facilitate cross-border remittances between India and the Euro Area and is expected to benefit users of both jurisdictions.

- ✓ Reserve Bank of India and NPCI International Payments Limited (NIPL) have been engaging with European Central Bank on the initiative to connect UPI with the TARGET Instant Payment Settlement (TIPS), the instant payment system operated by the Eurosystem.
- ✓ Reserve Bank of India has been actively pursuing interlinking of Unified Payments Interface (UPI) with fast payment systems of other jurisdictions to promote crossborder payments.
- ✓ These initiatives are aligned with the G20 Roadmap for enhancing cross-border payments, with a focus on cheaper, efficient, more transparent and more accessible remittances.
- ✓ Reserve Bank of India and NIPL will continue to collaborate closely with European Central Bank to operationalise the UPI-TIPS link, including technical integration, risk management and settlement arrangements.
- ✓ NIPL and the Central Reserve Bank of Peru (BCRP) had first announced a landmark partnership to introduce the real-time payments system in Peru in 2024.
- ✓ Peru the first South American country to adopt the Unified Payment Interface (UPI) technology.
- ✓ The UPI is currently available in seven countries -- Bhutan, France, Mauritius, Nepal, Singapore, Sri Lanka and the UAE.

- NPCI International Payments Ltd (NIPL), the international arm of India's National Payments Corporation of India (NPCI), has partnered with Qatar National Bank (QNB) to introduce QR code-based Unified Payments Interface (UPI) in Qatar.
- Qatar is now the eighth country to adopt India's UPI network, following in the footsteps of Bhutan, France, Mauritius, Nepal, Singapore, Sri Lanka, and the UAE.
- The new Unified Payments Interface (UPI) guidelines issued by the National Payments Corporation of India (NPCI) in May 2025 became effective on August 1, 2025.
- Balance inquiry limit: You can now check your bank balance a maximum of 50 times per day per UPI app.
- The initiative you're referring to is the UPI-UPU Integration, which connects India's Unified Payments Interface (UPI) with the Universal Postal Union (UPU)'s Interconnection Platform (IP) to make cross-border remittances faster, safer, and more affordable by leveraging the global postal network.
- NPCI grants TPAP approval to Viyona Fintech - The Economic TimesViyona Fintech, a Hyderabad-based digital payments platform, received approval from the National Payments Corporation of India (NPCI) in September 2025 to become a Third-Party Application Provider (TPAP).
- According to NPCI data, the Unified Payments Interface (UPI) recorded a record-breaking 20.01 billion transactions in August 2025, marking the first time it crossed the 20 billion monthly transaction milestone.

- Meghalaya's indigenous textile 'Ryndia' has received the GI tag for its organic, handwoven, and naturally dyed fabric.
- Warangal Chapata Chilli, also known as Tomato Chilli, has been granted a Geographical Indication (GI) tag, recognizing its unique qualities and regional significance in Telangana.
- Kannadippaya, a traditional tribal handicraft from Kerala, has been awarded the Geographical Indication (GI) tag.
- Kumbakonam betel leaf, grown in the fertile Cauvery river basin of Thanjavur, has been granted a Geographical Indication (GI) Tag by the Government of India.
- The Saudagari block print, a traditional textile art form, has been officially granted a Geographical Indication (GI) tag.
- This craft is practised by artisans in Jamalpur, Ahmedabad, and has been preserved for nearly 300 years
- A consignment of 30 tonnes of Geographical Indication (GI)-tagged jaggery from Muzaffarnagar, Uttar Pradesh, has been shipped to Bangladesh.
- Meghalaya's Eri Silk, known locally as Ryndia silk, recently received a Geographical Indication (GI) tag in 2025.
- Rajasthan's famous sangri bean from the Thar Desert received the prestigious Geographical Indication (GI) tag.
- Rajasthan's famous dish, Ker Sangri, has recently received a Geographical Indication (GI) tag.
- Chanderi sarees and Maheshwari sarees from Madhya Pradesh have received Geographical

- The Government of India has set a target of 10,000 Geographical Indication (GI) tags for the Indian products by 2030.
- Virgin Coconut Oil (VCO) from Nicobar district in the Andaman and Nicobar Islands was recently awarded the prestigious Geographical Indication (GI) tag.
- Marble mined in Gujarat's Ambaji has recently been awarded the Geographical Indication, or GI tag, by the Central Government.
- **GEOGRAPHICAL INDICATIONS (GI) :-**
- GI tags are issued as per the Geographical Indications of Goods (Registration and Protection) Act, 1999. This tag is issued by the Geographical Indication Registry under the Department of Industry Promotion and Internal Trade, Ministry of Commerce and Industry.
- Darjeeling Tea was the first Indian product to get the geographical indication tag in 2004.
- The second GI tag in India was given to Aranmula Kannadi (Handicraft) which is a mirror and made in Kerala.
- A GI is registered for an initial period of ten years, which must be renewed after 10 years.

- ✓ **The Industrial Relations Code, 2020:** Deals with industrial disputes, trade unions, and conditions of employment, introducing provisions for fixed-term employment.
- ✓ **The Code on Social Security, 2020:** Expands social security coverage to include workers from the unorganised sector, gig workers, and platform workers.
