

- ✓ Fátima Bosch Fernández from Mexico was crowned Miss Universe 2025 at the 74th Miss Universe pageant held at the Impact Challenger Hall in Nonthaburi in Bangkok, Thailand.
- ✓ She was crowned by her predecessor Victoria Kjaer Theilvig (Denmark) who held the Miss Universe title in 2024.
- ✓ With this win, Fátima Bosch becomes the fourth Mexican to claim the Miss Universe crown, following Lupita Jones (1991), Ximena Navarrete (2010), and Andrea Meza (2020).
- ✓ Theme for the 2025 Miss Universe pageant, organised by the Miss Universe Organization(MUO), was 'The Power of Love', focusing on unity, empowerment and resilience.
- ✓ Indian origin Miss Thailand Praveenar Singh secured the 1st runner-up spot, followed by Miss Venezuela.
- ✓ Puerto Rico will host the 75th, silver jubilee edition of Miss Universe pageant in 2026.

- ✓ Geographical Indication (GI) Registry under the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry (MoC&I) conferred GI status on two Uttar

- ✓ The Meerut Bugle originated in the late 19th century when Nadir Ali & Company set up a small manufacturing unit in Meerut's Jali Kothi area, marking the city's first bugle-making factory.
- ✓ **About Zari Poshak.**
- ✓ Zari Poshak has its roots in India's centuries-old weaving and embroidery traditions, known for the use of fine metallic threads (zari) crafted by skilled artisans.

GI TAG IN NEWS 2025

- Mathura Poshak and Meerut Bugle Recognized as GI tag Products in Uttar Pradesh.
- Gujarat's Ambaji white marble receives GI tag, enhancing its global recognition and market potential for its unique quality.
- GoI Granted GI Tag to Sikkim's Lepcha Musical Instruments 'Tungbuk' and 'Pumtong Pulit'.
- Meghalaya's indigenous textile 'Ryndia' has received the GI tag for its organic, handwoven, and naturally dyed fabric.
- Warangal Chapata Chilli, also known as Tomato Chilli, has been granted a Geographical Indication (GI) tag, recognizing its unique qualities and regional significance in Telangana.
- Kannadippaya, a traditional tribal handicraft from Kerala, has been awarded the Geographical Indication (GI) tag.
- Kumbakonam betel leaf, grown in the fertile Cauvery river basin of Thanjavur, has been granted a Geographical Indication (GI) Tag by the Government of India.
- The Saudagari block print, a traditional textile art form, has been officially granted a Geographical Indication (GI) tag.
- This craft is practised by artisans in Jamalpur, Ahmedabad, and has been preserved for nearly 300 years
- A consignment of 30 tonnes of Geographical Indication (GI)-tagged jaggery from Muzaffarnagar, Uttar Pradesh, has been shipped to Bangladesh.
- Meghalaya's Eri Silk, known locally as Ryndia silk, recently received a Geographical Indication (GI)

- Rajasthan's famous sangri bean from the Thar Desert received the prestigious Geographical Indication (GI) tag.
- Rajasthan's famous dish, Ker Sangri, has recently received a Geographical Indication (GI) tag.
- Chanderi sarees and Maheshwari sarees from Madhya Pradesh have received Geographical Indication (GI) tag.
- The Government of India has set a target of 10,000 Geographical Indication (GI) tags for the Indian products by 2030.
- Virgin Coconut Oil (VCO) from Nicobar district in the Andaman and Nicobar Islands was recently awarded the prestigious Geographical Indication (GI) tag.
- Marble mined in Gujarat's Ambaji has recently been awarded the Geographical Indication, or GI tag, by the Central Government.
- **GEOGRAPHICAL INDICATIONS (GI) :-**
- GI tags are issued as per the Geographical Indications of Goods (Registration and Protection) Act, 1999. This tag is issued by the Geographical Indication Registry under the Department of Industry Promotion and Internal Trade, Ministry of Commerce and Industry.
- Darjeeling Tea was the first Indian product to get the geographical indication tag in 2004.
- The second GI tag in India was given to Aranmula Kannadi (Handicraft) which is a mirror and made in Kerala.
- A GI is registered for an initial period of ten years, which must be renewed after 10 years.

- ✓ Ministry of Finance notified the Capital Gains Accounts (2nd Amendment) Scheme (CGAS), 2025, which revises the 1988 framework by allowing taxpayers to temporarily deposit capital gains in a designated bank account to retain eligibility for tax exemption while purchasing or constructing a new property.
- ✓ The amendment, effective from 19 November, 2025.
- ✓ The amendment broadens the definition of a “Deposit Office” to include 19 private sector and small finance banks, in addition to Public Sector Banks(PSBs) and IDBI Bank. These authorised banks can now accept CGAS deposits at all non-rural branches.
- ✓ The banks are: HDFC Bank, ICICI Bank, Axis Bank, City Union Bank(CUB), DCB Bank, Federal Bank Limited, IDFC FIRST Bank, IndusInd Bank, Jammu & Kashmir(J&K) Bank, Karnataka Bank, Karur Vysya Bank(KVB), Kotak Mahindra Bank(KMB), RBL Bank, South Indian Bank(SIB), Yes Bank, Dhanlaxmi Bank, Bandhan Bank, CSB Bank, and Tamilnad Mercantile Bank(TMB).
- ✓ Effective April 1, 2027, CGAS accounts can be closed solely through electronic filing, authenticated via digital signature or electronic verification code.
- ✓ These amendments mark a major shift towards digitalisation, broader applicability and streamlined compliance for taxpayers, NRIs (Non-Resident Indians) and businesses reinvesting capital gains under Sections 54, 54B, 54D, 54F, 54G, 54GA and 54GB of the Income-tax Act, 1961.
- ✓ CGAS has been expanded to include Section 54GA, which will allow exemption on depositing unutilised capital gains from shifting an industrial undertaking from an urban area to an SEZ (Special Economic Zone).
- ✓ **About Capital Gains Accounts Scheme (CGAS).**
- ✓ The scheme exists to ensure that taxpayers who intend to claim capital gain exemptions but are unable to invest the amount immediately can deposit the unutilised funds into a designated account.

- ✓ A key reform is the inclusion of electronic payment modes: credit and debit cards, net banking, Immediate Payment Service (IMPS), Unified Payment Interface (UPI), Real Time Gross Settlement (RTGS), National Electronic Funds Transfer (NEFT) and Bharat Interface for Money (BHIM) Aadhaar Pay, for making deposits into CGAS accounts.
- ✓ The CGAS forms have also been upgraded to include fields for RTGS, IMPS and NEFT information for electronic transactions.

- ✓ Defence Research & Development Organization (DRDO), India, and the Directorate General of Armaments (DGA), France, signed a Technical Agreement to strengthen long-term collaboration in defence research, innovation, and advanced technology development.
- ✓ The pact aims to deepen the strategic partnership between India and France by enabling structured cooperation across multiple high-technology domains.

- ✓ The cooperation spans aeronautical platforms, unmanned systems, advanced defence materials, cyber security, Artificial Intelligence(AI), space tech, navigation, and propulsion, enabling joint development of next-generation systems.
- ✓ Both nations are also considering declaring 2026 as the 'India–France Year of Innovation', marking the continuation of their strategic partnership initiated on 26 January 1998

DRDO IN NEWS 2025

- DRDO in collaboration with the Strategic Forces Command (SFC), has carried out the successful launch of Intermediate Range Agni-Prime Missile from a Rail based Mobile launcher system.
- This next-generation missile is designed to travel up to 2000 kilometers.
- DRDO conducted two consecutive successful flight-tests of Pralay missile from Dr APJ Abdul Kalam island off the coast of Odisha.
- The missile has a range of 150-500 km and can be launched from a mobile launcher.
- The Air Defence unit of the Indian Army conducted a successful user trial of the DRDO developed air defence system, Akash Prime, in Ladakh at an altitude of 15,000 feet.
- DRDO has successfully conducted the final user trial of the indigenously developed Extended Range Anti-Submarine Rocket (ERASR) from the Indian Naval Ship (INS) Kavaratti.
- The Defence Research and Development Organisation (DRDO) has successfully tested its Long-Range Glide Bomb, Gaurav, off the coast of Odisha. The smart bomb was dropped from the Indian Air Force's Su-30 MK-I fighter plane.
- DRDO has successfully carried out flight-trials of Unmanned Aerial Vehicle Launched Precision Guided Missile (ULPGM)-V3 at the National Open Area Range (NOAR) test range in Kurnool, Andhra Pradesh.
- DRDO and Indian Air Force (IAF) successfully conducted the flight-test of indigenous Beyond Visual Range Air-to-Air missile (BVRAAM) 'Astra' equipped with indigenous Radio Frequency (RF) Seeker from Su-30 Mk-I platform off the coast of Chandipur, Odisha, on 11 July 2025.
- Astra is a Beyond-Visual-Range Air-to-Air missile (BVRAAM) with a range exceeding 100 kms.
- Defence Research and Development Organisation (DRDO)
- Founded : 1 January 1958

- ✓ Indian Navy commissioned Indian Naval Ship (INS) Mahe, the first indigenously designed and built Mahe-class Anti-Submarine Warfare Shallow Watercraft (ASW-SWC) at the Naval Dockyard in Mumbai, Maharashtra.
- ✓ The vessel INS Mahe is named after the historic coastal town of Mahe in Puducherry, reflecting India's Maritime heritage.
- ✓ INS Mahe, developed by Cochin Shipyard Limited (CSL), is the lead ship of eight vessels in Mahe class.
- ✓ INS Mahe will serve as a "Silent Hunter" on the Western Seaboard with over 80% indigenous content, reflecting the Government of India (GOI)'s vision of Aatmanirbhar Bharat.
- ✓ It is approximately 78 metres (m) long, with a displacement of 1,100 tonnes.

- ✓ **Key facts about 'INS Mahe'**

INS IN NEWS 2025

- Indian Navy has received the second indigenously built anti-submarine warfare-shallow watercraft INS Andorth.
- It draws its name from Androth Island in the Lakshadweep archipelago.
- It is the second of eight anti-submarine warfare-shallow watercraft (ASW-SWC) built by Garden Reach Shipbuilders and Engineers (GRSE), Kolkata.
- INS Tamal, the Indian Navy's newest stealth frigate, commissioned in Russia on 1 July 2025, concluded a three-day port visit to Casablanca, Morocco, from 6–9 August 2025.
- INS Himgiri (Yard 3022) was delivered to the Indian Navy at GRSE, Kolkata.
- It is the third ship of Nilgiri Class (Project 17A) and the first of the class built at Garden Reach Shipbuilders & Engineers (GRSE).
- INS Nistar is India's first indigenously designed and built Diving Support Vessel (DSV), commissioned by the Indian Navy at Visakhapatnam.
- Indian Navy's INS Sandhayak made her maiden port call at Port Klang, Malaysia, for hydrographic cooperation.
- It is the first of the indigenously designed and built Sandhayak-class hydrographic survey ship, which was commissioned in February 2024.
- It was constructed at Garden Reach Shipbuilders & Engineers (GRSE), Kolkata.
- Yard 12652 (Udaygiri) being built at Mazagon Dock Shipbuilders Limited (MDSL), was delivered to the Indian Navy.
- It is the second among the seven Project 17A (P-17A) frigates under construction at Mazagon Dock Shipbuilders Limited (MDSL) in Mumbai and Garden Reach Shipbuilders and Engineers in Kolkata.
- Prime Minister Narendra Modi commissioned three frontline naval warships and submarines - INS Surat, INS Nilgiri and INS Vagsheer at the Mazagon Dock Shipbuilders Limited (MDL), Mumbai, Maharashtra on 15 January 2025.

- INS Nilgiri is a stealth frigate and is the lead ship of the Indian Navy's Project 17A, to develop stealth frigates .
- INS Surat is the last of the four guided missile destroyer class ships to be constructed under Project 15B and INS Vaghsheer is the the sixth and final submarine of the Kalvari class built under Project 75 of the Indian Navy
- Larsen & Toubro (L&T) launched the second multi-purpose vessel (MPV) INS Utkarsh for the Indian Navy.
