

- ✓ Funding & Tenure: The first initiative, Punjab Outcomes-Acceleration in School Education Operation (POISE), is backed by a USD 286 million loan with a 19-year maturity, including a 5-year grace period, aimed at enhancing educational outcomes in the state.
- ✓ **Development Projects in Maharashtra:**
- ✓ Funding & Tenure: The second initiative, Maharashtra Project on Climate Resilient Agriculture (POCRA) Phase II, is funded with USD 490 million, featuring a 24-year maturity and a 6-year grace period, to promote climate-resilient and technology-driven agriculture in the state

WORLD BANK IN NEWS 2025

- World Bank approved funding of USD 776 million (around Rs. 6,467 crore) for two projects in India focused on improving education in Punjab and advancing climate-resilient agriculture in Maharashtra.
- World Bank has approved a \$280 million loan to strengthen Kerala's health system.
- The World Bank has cleared a \$212.64 million loan for the Strengthening Coastal Resilience and the Economy (SHORE) project in Tamil Nadu and Karnataka.
- The loan comes from the World Bank's International Bank for Reconstruction and Development (IBRD). It has a final maturity of 23 years, with a grace period of 6.5 years.
- World Bank has approved a \$426 million (approximately Rs 3,700 crore) loan for the Karnataka Water Security and Resilience Programme.

- ✓ Union Cabinet chaired by the Prime Minister (PM) Narendra Modi approved the 'Scheme to Promote Manufacturing of Sintered Rare Earth Permanent Magnets(REPM)' with a financial outlay of Rs 7,280 crores (cr).



- ✓ The scheme aims to establish 6,000 Metric Tons per Annum (MTPA) of integrated REPM manufacturing in India, covering the full value chain from rare earth oxides to metals, metals to alloys, and alloys to finished REPMs.
- ✓ **Implementation:** This scheme is implemented by the Ministry of Heavy Industries (MHI).
- ✓ **Participation:** Both public and private sector companies are eligible to take part.
- ✓ **Financial Outlay:** The total financial outlay of the scheme is Rs 7280 cr, comprising a sales-linked incentives of Rs 6450 cr on REPM sales for five (5) years.
- ✓ The scheme provides a capital subsidy of Rs 750 cr for setting up an aggregate of 6,000 MTPA of REPM manufacturing facilities.
- ✓ **Scheme Duration:** The total duration of the scheme will be 7 years from the date of award
- ✓ India's first integrated REPM facilities will boost employment, enhance self-reliance, and support the nation's Net Zero 2070 goal.

- ✓ International Monetary Fund (IMF) released its latest 'India: 2025 Article IV Consultation' report projecting India's real Gross Domestic Product (GDP) to grow at 6.6% in Financial Year 2025-26(FY26).
- ✓ The report noted that India's latest Goods and Services Tax (GST 2.0) reforms are expected to mitigate the impact of the United States of America (USA's) 50% tariffs.
- ✓ The report has also projected that India's real GDP will moderate to 6.2% in FY27, compared to 6.5% in FY25 and 7.8% in the 1st quarter (Q1: April to June) of FY26.
- ✓ IMF has reclassified India's 'de facto' exchange rate regime as 'crawl-like arrangement' from its previous 'stabilized classification'.
- ✓ Previously, India was moved from a 'floating' category to 'stabilized arrangement' in 2023.
- ✓ A "crawl-like arrangement" is an exchange rate system with gradual, small periodic currency adjustments.

- International Monetary Fund (IMF) released its latest 'India: 2025 Article IV Consultation' report projecting India's real Gross Domestic Product (GDP) to grow at 6.6% in Financial Year 2025-26(FY26).
- Government of India has approved the appointment of Dr. Urjit Ravindra Patel, ex-Governor of the Reserve Bank of India (RBI), as the Executive Director (ED) for India at the International Monetary Fund (IMF).
- He replaced Krishnamurthy Subramanian.
- Indian-American economist Gita Gopinath will leave the IMF by the end of August 2025 to rejoin Harvard as the inaugural Gregory and Ania Coffey Professor of Economics in the Department of Economics.
- Gopinath, who had joined the IMF in January 2019 as chief economist and was promoted to first

- ✓ Recently, the Prime Minister of India unveiled Skyroot Aerospace's first orbital rocket, Vikram-I.
- ✓ It is developed by Skyroot Aerospace.
- ✓ It is India's new private orbital-class launch vehicle named after the notable space pioneer Vikram Sarabhai.
- ✓ **Features of Vikram-I Rocket**
- ✓ **Thrust:** It produces 1,200 kN of thrust using an all-carbon composite structure for enhanced lightweight strength and efficiency.
- ✓ **Design:** The design emphasises simplicity, reliability, and the ability to launch within 24 hours from any location.
- ✓ **Stages:** It has four stages and the first three stages are solid-fuelled, providing robust initial thrust, topped by a hypergolic liquid upper stage for precise orbital adjustments.
- ✓ Stage 4 uses a cluster of four Raman engines. These are hypergolic engines, (meaning they ignite instantly when two chemicals, MMH fuel and NTO oxidiser, come into contact).
- ✓ It is built to target the small-satellite segment and is capable of placing multiple satellites into orbit in a single mission.
- ✓ **Payload Capacity:** It can deploy up to 350 kg into low Earth orbit (LEO) and 260 kg into a sun-synchronous orbit (SSO).
- ✓ **Innovation:** Other key innovations include 3D-printed engines, ultra-low-shock pneumatic separation systems, and advanced avionics for real-time guidance.

- JSW Energy Limited has commissioned its 1st and India's largest green hydrogen manufacturing plant at Vijayanagar in Karnataka.
- India's first Central Tissue Bank and a new cashless "We-Office" for the Delhi Dental Council were inaugurated at the Maulana Azad Institute of Dental Sciences (MAIDS), Delhi.
- Agnikul Cosmos Launches India's First Large-Format 3D Printing Facility for Rocket Systems at IIT-Madras.
- India's first overseas Atal Innovation Centre was inaugurated at the IIT Delhi campus in Abu Dhabi, United Arab Emirates.

- Kashmir researchers Sher-e-Kashmir University of Agricultural Sciences and Technology (SKUAST) have successfully developed India's first gene-edited sheep.
- EnKash has launched India's first unified payment gateway specifically designed for small and medium businesses (SMBs) and startups. This new platform, called the EnKash Payment Gateway.
- India's first manned deep ocean mission 'Samudrayaan' into a 6,000-metre depth using the manned submersible vehicle 'Matsya' is expected to be launched by the end of 2026.
- India's first privately built geostationary orbit (GSO) communication satellite is expected to be ready by 2028. Ananth Technologies, an Indian private firm, is developing this satellite.
