- ✓ India's first incubator-linked deep tech VC fund is the Y-Point Venture Capital Fund, launched by IIT Bombay's SINE (Society for Innovation and Entrepreneurship) with a ₹250 crore corpus, backing early-stage startups in AI, space, climate tech, and more from research institutions.
- ✓ This fund aims to bridge the gap from lab research to market, supporting 25-30 companies with up to ₹15 crore each, focusing on high-impact areas like AI, advanced manufacturing, healthcare, and defence tech.

- India's first "Quantum City" (Q-City) was unveiled in Bengaluru, Karnataka.
- Ananth Technologies has received permission from IN-SPACe to launch India's first private satellite broadband service.
- India's first privately built PSLV rocket by HAL-L&T is ready to launch the Oceansat satellite in early 2026.
- Bannerghatta Biological Park (BBP) in Bengaluru is set to become India's first fully solar-powered zoo

- CotoPay powered by NPCI's e-RUPI platform launches India's First e-RUPI Voucher Issuance Stack for Businesses
- Muse Wearables, an IIT-Madras incubated startup, has partnered with NPCI to launch India's first wearable payments ecosystem, featuring a smart ring called "Ring One".
- Indore is the first city in India to use a 60-megawatt (MW) solar power plant, funded by green bonds, to power its water supply system
- Chhattisgarh government declared Balod district as the first in India to be officially free of child marriages under the 'Child Marriage-Free India' campaign.
- India's first dedicated space astronomy observatory, AstroSat, completed 10 years of operation on 28 September 2025. It was launched on 28 September 2015 by PSLV-C30 (Polar Satellite Launch Vehicle-C30) XL from Satish Dhawan Space Centre, Sriharikota.

- India's first state-of-the-art Animal Stem Cell Biobank and Laboratory has been established at the National Institute of Animal Biotechnology (NIAB) in Hyderabad.
- Skyroot Aerospace has achieved a crucial milestone for its Vikram-1 rocket by successfully static-firing the Kalam-1200 booster stage.
- India's first Prime Minister, Jawaharlal Nehru, holds the record for the longest-serving PM in consecutive terms, at 16 years and 286 days, from August 15, 1947, to May 27, 1964.
- Narendra Modi overtook Indira Gandhi to become the second longest serving prime minister of India in consecutive terms.
- India's first dedicated wildlife corridor has been built by NHAI on the Delhi-Mumbai Expressway, near the Ranthambore Tiger Reserve
- India's first AI-powered traffic system, the Advanced Traffic Management System (ATMS), has been launched on the Dwarka Expressway in Delhi.
- Adani New Industries Limited (ANIL) has commissioned India's first off-grid 5-megawatt green hydrogen pilot plant in Kutch, Gujarat

- ✓ Location: Namo Ghat, Varanasi — the vessel's maiden commercial run began here along the Ganga.
- ✓ Developed by: Cochin Shipyard Ltd (CSL), showcasing indigenous excellence in clean marine engineering.
- ✓ Capacity & Speed: The catamaran measures 24 meters, can accommodate 50 passengers in an air-conditioned cabin, and has a service speed of 6.5 knots.
- ✓ Initiative: The project is part of the central government's "Harit Nauka" initiative and aligns with India's broader goal of achieving net-zero emissions by 2070.

- ✓ Uttar Pradesh Clean Air Management Program (UPCAMP): Financed with approximately \$299.66 million.
- ✓ Haryana Clean Air Project for Sustainable Development Operation: Financed with \$300 million.

- World Bank has approved approximately \$600 million in financing for clean air programmes in Uttar Pradesh and Haryana
- World Bank approved a total of \$776 million for two projects in India on November 25, 2025: \$286 million for an education project in Punjab and \$490 million for an agriculture project in Maharashtra.

- World Bank has approved a \$280 million loan for the Kerala Health System Improvement Programme, which aims to enhance the life expectancy and quality of life for 11 million elderly and vulnerable people.
- The World Bank has cleared a \$212.64 million loan for the Strengthening Coastal Resilience and the Economy (SHORE) project in Tamil Nadu and Karnataka.
- World Bank has approved a \$426 million (approximately Rs 3,700 crore) loan for the Karnataka Water Security and Resilience Programme.
- A new World Bank report in collaboration with the Union Ministry of Housing and Urban Affairs estimates that Indian cities will need to invest \$2.4 trillion by 2050 to develop climate-resilient infrastructure and services.
- The World Bank launched the Business Ready (B-READY) report, replacing the paused Ease of Doing Business report.
- According to a World Bank report, India has been recognized as the fourth most equal country globally in terms of income. This ranking is based on the Gini Index, where India scored 25.5 in 2022-23, indicating a significant improvement from 28.8 in 2011-12.
- The Slovak Republic, Slovenia, and Belarus are the only countries with lower Gini Index scores than India.
- According to the World Bank, India has significantly reduced its extreme poverty rate, dropping from 27.1% in 2011-12 to 5.3% in 2022-23.

- India is a member of IBRD, IFC, IDA and MIGA. The country is not a member of the ICSID

Q.5. India's second spaceport, from which rockets are expected to be launched starting in early 2027, is located in which district of Tamil Nadu?

- ✓ India's second spaceport at Kulasekarapattinam in the Thoothukudi district of Tamil Nadu is currently under construction as of December 2025.
- ✓ The foundation stone was laid by Prime Minister Narendra Modi in February 2024, and the facility is targeted to be operational by December 2026 or fiscal year 2026-27.
- ✓ **Location:** The new spaceport is located in the coastal village of Kulasekarapattinam, Thoothukudi district, Tamil Nadu.
- ✓ **Purpose:** It is primarily dedicated to launching Small Satellite Launch Vehicles (SSLVs), which are designed for cost-effective, quick-assembly launches of small satellites (up to 500 kg).
- ✓ **Geographical Advantage:** Its coastal location provides a direct southward launch trajectory over the Indian Ocean. This eliminates the need for the "dogleg" maneuver required at the existing Sriharikota spaceport to avoid Sri Lankan airspace, saving significant fuel and increasing the SSLV's payload capacity.
- ✓ **Capacity:** Once fully operational, the spaceport is expected to handle 20-25 launches annually, boosting India's launch capacity and supporting private space ventures in line with the Indian Space Policy 2023.
- ✓ **First Spaceport:** The existing primary spaceport is the Satish Dhawan Space Centre (SDSC) in Sriharikota, Andhra Pradesh, which handles larger launch vehicles like PSLVs and GSLVs.

- ✓ The Reserve Bank of India (RBI) has removed all restrictions on banks opening and maintaining cash credit accounts under new transaction account rules.
- ✓ Cash credit acts as a short-term, flexible business loan for working capital. The regulator adopted the changes following industry feedback on draft rules issued October 1, 2025.
- ✓ Banks may now maintain current accounts without restriction for customers with banking exposures under 10 crore
- ✓ For exposures exceeding 10 crore, banks holding at least 10% exposure to a borrower may provide current and overdraft facilities
- ✓ Current accounts serve businesses and individuals with high transaction volumes. The RBI classifies current, overdraft, and cash credit accounts collectively as "transaction accounts."

- ✓ Reserve Bank of India (RBI) imposed a penalty of ₹99.3 lakh on Jammu & Kashmir Bank for multiple regulatory compliance failures, including lapses in grievance handling, KYC norms, and timely transfer of unclaimed deposits.
- ✓ The bank was late in transferring eligible unclaimed deposits to the Depositor Education and Awareness (DEA) Fund within the stipulated period, a contravention of Section 26A of the Banking Regulation Act, 1949.

RBI IMPOSED PENALTY IN NEWS 2025

- State Bank of India (SBI) was penalised with a fine of 1.73 Crore by the RBI for various charges due to non-compliance with its policies regarding loans, customer protection and account opening regulations under the 'Banking Regulations Act 1949'.
- RBI imposed a penalty of Rs 1 crore on Jana Small Finance Bank for violating provisions of the

Banking Regulation Act, 1949.

- ICICI Bank has been penalized ₹75 lakh by the Reserve Bank of India (RBI) for non-compliance with regulatory directives.
- IRDAI has imposed a penalty of ₹5 crore on Policybazaar for multiple violations of insurance regulations.
- 11 Public sector banks (PSBs) collected almost Rs 9,000 crore as penalties on the same over a five-year period.
- IRDAI has imposed a penalty of Rs 3.39 crore on Star Health and Allied Insurance Co. Ltd. The penalty was levied for violations of the Information & Cyber Security Guidelines, 2023.
- RBI has imposed a Rs 4.88 lakh penalty on HDFC Bank for contravention of certain norms relating to foreign investment in India while granting a term loan to its client.
- RBI has imposed a penalty of Rs 2.70 lakh on Shriram Finance Limited for non-compliance with certain provisions of the "Reserve Bank of India (Digital Lending) Directions, 2025".
- RBI has imposed a Rs 29.60 lakh penalty on Fino Payments Bank for breaching the regulatory ceiling on end-of-day balances.
- RBI imposed 353 penalties totalling Rs 54.78 crore on regulated entities (REs) for non-compliance with various statutory provisions and directions during the financial year 2024-25.
- SEBI has imposed a Rs 25 lakh penalty on the Multi Commodity Exchange of India (MCX) for failing to adequately disclose substantial payments made to 63 Moons Technologies
- Reserve Bank of India has levied a penalty of Rs 63.6 lakh on Union Bank of India for non-compliance with the Banking Regulation Act and directions related to collateral-free agricultural loans.
- IRDAI has imposed a penalty of ₹1 crore on Acko General Insurance for violations of certain regulations. The action pertains to payments the insurer made, to a company during 2019-20 and 2020-21, in violation of Section 40(1) of the Insurance Act, 1938.
- RBI has levied penalties on Deutsche Bank AG, India, and Yes Bank for regulatory non-compliance.
- Deutsche Bank faces a Rs 50 lakh penalty for lapses in creating a central repository for large common exposures across banks.
- Yes Bank is penalized Rs 29.60 lakh for non-compliance with financial statement presentation and disclosure norms.

- ✓ **Origin & Geography:** It is handcrafted in Kolhapur (Maharashtra) and nearby districts like Sangli, Satara, and Solapur, dating back to the 12th–13th century, and was originally made for royalty.
- ✓ **GI Tag Recognition:** It was granted Geographical Indication (GI) status in 2019, covering eight districts in Maharashtra and Karnataka
