- ✓ Government of India unveiled 'DHRUV64', India's 1st indigenous built 1.0 Giga Hertz (GHz), 64-bit dual-core microprocessor, marking a significant milestone in strengthening India's self-reliant microprocessor ecosystem.
- ✓ **About DHRUV64.**
- ✓ This newly launched semiconductor chip was developed by the Centre for Development of Advanced Computing (C-DAC), Research and Development (R&D) organisation under the Ministry of Electronics and Information Technology (MeitY), under the Microprocessor Development Programme (MDP).
- ✓ DHRUV64 has been developed with modern architectural features that offer higher efficiency, improved multitasking capability and enhanced reliability.
- ✓ The DHRUV64 processor is designed for seamless integration with diverse hardware and, with modern fabrication technologies, is suitable for Fifth Generation(5G), automotive, consumer electronics, industrial automation, and Internet of Things (IoT) applications.
- ✓ The launch of DHRUV64 is part of the GoI's Digital India RISC-V(Reduced Instruction Set Computer) (DIR-V) programme which aims to create a complete portfolio of RISC-V-based microprocessors in India.
- ✓ DHRUV64 is the 3rd processor to be fabricated under DIR-V, following the THEJAS32, 1st chip fabricated at Silterra facility in Malaysia; and THEJAS64, manufactured locally at Semiconductor Lab (SCL) in Mohali, Punjab.

- ✓ **Other Indigenous Microprocessors.**
- ✓ **SHAKTI (2018):** It was developed by Indian Institute of Technology-Madras (IIT-M), Chennai, Tamil Nadu(TN). It is specifically designed for strategic, space, and defence applications;
- ✓ **AJIT(2018):** It was developed by IIT-Bombay (IIT-B),Mumbai(Maharashtra), is a microprocessor designed for industrial and robotics applications;
- ✓ **VIKRAM (2025):** It was developed by Indian Space Research Organisation (ISRO) in partnership with SCL, is designed for space applications like: navigation, guidance, and mission operations;
- ✓ **THEJAS64 (2025):** It was developed by C-DAC for industrial automation.
- ✓ **Next-Gen Variants:** After the successful launch of DHRUV64, C-DAC is currently working on the development of Dhanush and Dhanush+, System on a Chip (SoC) variants which are under development.

- ✓ RBI Approves HDFC Bank Group to Acquire Up to 9.5% Stake in IndusInd Bank.
- ✓ Reserve Bank of India (RBI) approved HDFC Bank Limited, along with its group entities, to acquire an aggregate holding of up to 9.5% of the paid-up share capital or voting rights in IndusInd Bank Limited.
- ✓ The approval has been granted under the RBI (Commercial Banks – Acquisition and Holding of Shares or Voting Rights) Directions, 2025, with non-compliance leading to automatic lapse of permission.
- ✓ The approval is valid for one year, from 15 December 2025 to 14 December 2026, and the aggregate holding must not exceed 9.50% at any time.

- SBI and Amundi India Holding hold 61.91% and 36.36% stake in SBIFML respectively.
- Mahindra & Mahindra sold its entire 3.5% stake in RBL Bank for Rs. 6.78 billion

- Life Insurance Corporation (LIC) increased its holdings in Tata Consumer Products to 8.65% and in Dabur India to 6.99%.
- Punjab National Bank (PNB) sold a 10% stake in Canara HSBC Life Insurance through an Offer for Sale (OFS) during the company's IPO, reducing its stake from 23% to 13%.
- New York-based Blackstone is set to invest approximately ₹6,197 crore (around \$705 million) to acquire a 9.99% stake in Federal Bank.
- Abu Dhabi's International Holding Company (IHC) is acquiring a 41.2% stake in the Indian company Sammaan Capital (formerly Indiabulls Housing Finance) for ₹8,850 crore (\$1 billion).
- Japanese bank SMBC increased its stake in YES Bank from 20% to 24.22% by acquiring an additional 4.22% through an off-market purchase from CA Basque Investments, a Carlyle Group affiliate.
- Swiggy has sold its entire 12% stake in Rapido for ₹2,399 crore to two existing investors, Prosus and WestBridge Capital.
- Saudi Aramco is likely to take a 20% stake in Bharat Petroleum Corporation's (BPCL) planned Ramayapatnam refinery-cum-petrochemical complex (RcPC) in Andhra Pradesh
- JSW Paints will acquire a 75% stake in Akzo Nobel India for approximately Rs 9,000 crore, which includes brands like Dulux.
- Carlyle Group sold a 2.6% stake in YES Bank for ₹1.775 crore in June 2025.

- ✓ The funding supports the “Supporting Pradhan Mantri Skilling and Employability Transformation through Upgraded ITIs Program (PM-SETU)”. It aims to build a future ready workforce for manufacturing and emerging technology sectors, aligned with Skill India and Make in India priorities.
- ✓ The programme aims to modernise 650 Industrial Training Institutes (ITIs) across 12 states using a hub-and-spoke cluster model. It focuses on upgrading infrastructure, training equipment, and digital systems to deliver industry-aligned, demand-driven courses.
- ✓ It proposes to upgrade 5 National Skill Training Institutes (NSTIs) into Centres of Excellence for advanced trainer development, thereby improving the quality and capacity of instructors nationwide.

- ✓ SEBI Approves NCDEX to Launch a Mutual Fund Platform.
- ✓ National Commodity and Derivatives Exchange Limited (NCDEX) received in-principle approval from the Securities and Exchange Board of India (SEBI) to launch a Mutual Fund (MF) transaction platform.
- ✓ SEBI's approval allows NCDEX to set up a platform where investors can easily buy and sell MF units, after meeting regulatory requirements.
- ✓ The National Commodity Clearing Limited (NCCL), a wholly owned subsidiary of NCDEX, will handle the backend processing such as Clearing through validating trade details and Settlement which ensures money moves from investor to MF and units are allocated appropriately.
- ✓ The MF platform will be independent of the trading infrastructure of NCDEX for commodities or future stock trading systems. It can roll out faster without depending on the equity system.

SEBI IN NEWS 2025

- SEBI has suggested the exclusion of zero-coupon zero principal (ZCZP) bonds for determining the eligibility of basic services demat accounts (BSDA) of small investors.

- SEBI has overhauled RPT norms, shifting from a flat ₹1,000 crore limit to tiered, turnover-based thresholds capped at ₹5,000 crore, while easing disclosures for smaller transactions.
- The government has appointed Sandip Pradhan as a whole-time member of SEBI for three years, replacing Ashwani Bhatia.
- SEBI extended the deadline for the complete roll out of algorithm trading rules for retail investors to April 01, 2026.
- SEBI introduced special relaxations for Public Sector Undertakings (PSUs) in which the government already holds 90% or more equity.
- SEBI has revised the norms for InvITs, primarily by lowering the minimum investment for privately placed InvITs from ₹1 crore to ₹25 lakh
- SEBI was held in Mumbai, Maharashtra, where the board approved compliance relaxations for Foreign Portfolio Investors (FPIs) investing solely in Indian Government Securities (G-secs) to simplify their onboarding process.
- SEBI has eased compliance norms for Foreign Portfolio Investors (FPIs) who invest exclusively in government securities (G-Secs) under the Fully Accessible Route (FAR).
- SEBI introduced a new framework for co-investments within the Alternative Investment Fund (AIF) structure
- SEBI has mandated minimum investment threshold or ticket size of Rs 1 crore for the issuance of Securitised Debt Instruments (SDIs) for the Reserve Bank of India (RBI)-regulated originators and unregulated entities engaged in securitization activities.
- SEBI launched the SWAGAT-FI (Single Window Automatic & Generalised Access for Trusted Foreign Investors) framework in September 2025 to simplify the entry and regulatory processes for certain foreign investors.
- SEBI launched the "SEBI Check" tool on October 1, 2025, to verify UPI IDs and bank accounts for payments to registered market intermediaries
- SEBI is working with the Unique Identification Authority of India (UIDAI) and the Reserve Bank of India (RBI) to create a remote, secure Know Your Customer (KYC) system for non-resident Indians (NRIs)
- SEBI has launched two new initiatives, Validated UPI Handles and the SEBI Check tool, to improve payment security for investors .

- Validated UPI handles include an exclusive “@valid” suffix and a visual indicator like a green “thumbs-up” icon to confirm authenticity.
- Walmart-owned fintech giant PhonePe has filed draft papers with SEBI for an IPO, expected to raise around ₹12000 crore.
- SEBI has tightened rules for intraday index options trading by introducing a new net position limit of ₹5,000 crore per entity, which is significantly higher than the previous end-of-day limit of ₹1,500 crore. The gross intraday position limit remains unchanged at ₹10,000 crore
- SEBI approves LIC's reclassification as a public shareholder in IDBI Bank, with voting rights capped at 10% and stake cut to 15% within two years.
- The government, which owns 45.48%, and LIC, which holds 49.24%, together plan to sell a 60.7% stake.
- Quant Mutual Fund received approval from the SEBI to launch India's first Specialised Investment Fund (SIF), named the QSIF Equity Long-Short Fund.
- SEBI detailing a mechanism for monitoring and enforcing the minimum ₹10 lakh investment threshold in Specialized Investment Funds (SIFs).
- SEBI, in collaboration with BSE, CDSL, NSDL, and KFintech, launched a Securities Market Hackathon at Global Fintech Fest 2025.
- SEBI has approved the use of the NPCI's e-KYC Setu system for registered intermediaries to perform Aadhaar-based digital KYC
- Investor Education and Protection Fund Authority (IEPFA) and SEBI to Launch Pilot 'Niveshak Shivir' in Pune to Empower Investors and Streamline Grievance Redressal and Unclaimed Dividend Claims.
- Securities and Exchange Board of India (SEBI):
 - It is the regulatory body for securities and commodity markets in India established in 1988.
 - It is the regulator of the Capital market and Commodities market in India.
 - The first SEBI chairman was Dr S A Dave (1988-90)

- ✓ The Appointments Committee of the Cabinet (ACC), chaired by Prime Minister (PM) Narendra Modi, has approved the proposal of Department of Financial Services (DFS), Ministry of Finance (MoF), for the appointment of Ravi Ranjan as Managing Director (MD) of State Bank of India (SBI), India's largest Public Sector Bank (PSB).
- ✓ Rajiv Ranjan, who was previously serving as Deputy MD (DMD) of SBI, succeeded Vinay M. Tonse whose tenure expired on November 30, 2025.
- ✓ the appointment of Ranjan as new MD of SBI with effect from December 15, 2025.
- ✓ As per the official notification, issued by DFS in exercise of powers under the State Bank of India (SBI Act, 1955), Ranjan will hold this post until his superannuation on September 30, 2028, or until further orders, whichever is earlier.
- ✓ After assuming charge as MD of SBI, Ranjan is now responsible for the risk management, compliance and Stressed Assets Resolution Group (SARG).
- ✓ Ranjan started his career as banker by joining the SBI as Probationary Officer (PO) in 1991.

- ✓ Former Indian Administrative Service (IAS) officer Raj Kumar Goyal was sworn in as the 13th Chief Information Commissioner of the Central Information Commission (CIC) for three years, with President Droupadi Murmu administering the oath of office and secrecy at Rashtrapati Bhavan, New Delhi, Delhi.
- ✓ Goyal succeeded Heeralal Samariya, who demitted office in September 2025.

- ✓ Following his swearing-in, Goyal administered the oath to eight newly appointed Information Commissioners (ICs), completing the Central Information Commission's full bench of one Chief Information Commissioner and ten ICs for the first time since 2016.
- ✓ The appointments were recommended by a three-member committee as mandated by the Right to Information (RTI) Act, 2005.
- ✓ The committee comprised Prime Minister (PM) Narendra Modi (Chairperson), Union Minister Amit Shah, Ministry of Home Affairs (MHA), and the Leader of Opposition in Lok Sabha, Rahul Gandhi.
- ✓ Eligibility: Candidates must be eminent professionals, free from political or profit-linked roles, and are ineligible for reappointment.
