- ✓ Pension Fund Regulatory and Development Authority (PFRDA) notified the PFRDA (Exits and Withdrawals under the NPS) (Amendment) Regulations, 2025, introducing major structural changes to enhance subscriber flexibility.
- ✓ The Pension Fund Regulatory and Development Authority (PFRDA) which works under the Ministry of Finance (MoF), notified 'PFRDA (Exits and Withdrawals under the National Pension System (NPS)) (Amendment) Regulations, 2025', amending the principal Regulations of 2015.
- ✓ **Key Amendments (2025)**
- ✓ **Lump Sum Withdrawal Limit:** Non-government subscribers can now withdraw up to 80% of their corpus as a lump sum at exit (previously 60%), with the mandatory annuity portion reduced to 20%.
- ✓ **Maximum Exit Age:** The age limit to stay invested or defer withdrawal has been extended from 75 to 85 years for both government and non-government sectors.
- ✓ **Full Withdrawal Threshold:** Subscribers with a total corpus up to ₹8 lakh can now withdraw the entire 100% as a lump sum (increased from ₹5 lakh).

- ✓ **Vesting Period (All Citizen Model):** Normal exit is now permitted after 15 years of subscription or upon reaching 60 years of age, whichever is earlier.
- ✓ **Lock-in Period Removal:** The mandatory 5-year lock-in for premature exit under the All Citizen Model has been completely removed.
- ✓ **Partial Withdrawals:** Before age 60, subscribers can now make up to 4 partial withdrawals (increased from 3), with a minimum 4-year gap between each.
- ✓ **New Payout Options:** Formal introduction of Systematic Lump sum Withdrawal (SLW) and Systematic Unit Redemption (SUR) to provide periodic retirement income.
- ✓ **Lien for Loans:** Subscribers can now use their NPS account to mark a lien for financial assistance from regulated institutions, up to 25% of their own contribution.
- ✓ Statement 3 is incorrect because the 5-year lock-in period for the All Citizen Model has been removed by the 2025 amendments to allow total exit flexibility.

- ✓ It has lowered the compulsory minimum annuity purchase requirement for non-government subscribers from 40% to 20% of the total Accumulated Pension Wealth (APW) in specified cases.

- ✓ **Security:** Enhanced security features such as device binding and UPI PIN authentication for secure transactions.
- ✓ **UPI Delegate (UPI Circle):** A feature allowing a primary account holder to authorize family members to make payments within a set monthly limit (e.g., up to ₹15,000 per month).
- ✓ **UPI Autopay:** Supports recurring payments for items like subscriptions, EMIs, SIPs, and utility bills.
- ✓ **UPI Lite:** Enables faster, low-value transactions, often without requiring a UPI PIN for each payment.

- ✓ The decommissioning ceremony was presided by Vice Admiral Krishna Swaminathan, Flag Officer Commanding-in-Chief (FOCINC) of Western Naval Command (WNC).
- ✓ Decommissioning: INS Sindhughosh was decommissioned in December 2025 at the Naval Dockyard in Mumbai after approximately 40 years of service.
- ✓ **Class Legacy:** It was the first of ten Kilo-class submarines India acquired from the Soviet Union/Russia between 1986 and 2000.
- ✓ **Transfers:** While INS Sindhughosh was decommissioned, a sister ship, INS Sindhuvir, was previously transferred to the Myanmar Navy.
- ✓ **New Inductions:** As of 2025, the Indian Navy is focusing on newer platforms like the Kalvari-class (Scorpene) and the future Project 75I.

INS IN NEWS 2025

- Indian Navy recently deployed INS Gharial and three other vessels as part of the ongoing Operation Sagar Bandhu for offering humanitarian assistance and relief to the cyclone-affected regions of Sri Lanka.
- Indian Navy has received the second indigenously built anti-submarine warfare-shallow watercraft INS Andorth.
- It draws its name from Androth Island in the Lakshadweep archipelago.
- It is the second of eight anti-submarine warfare-shallow watercraft (ASW-SWC) built by Garden Reach Shipbuilders and Engineers (GRSE), Kolkata.
- INS Tamal, the Indian Navy's newest stealth frigate, commissioned in Russia on 1 July 2025, concluded a three-day port visit to Casablanca, Morocco, from 6–9 August 2025.
- INS Himgiri (Yard 3022) was delivered to the Indian Navy at GRSE, Kolkata.
- It is the third ship of Nilgiri Class (Project 17A) and the first of the class built at Garden Reach Shipbuilders & Engineers (GRSE).
- INS Nistar is India's first indigenously designed and built Diving Support Vessel (DSV), commissioned by the Indian Navy at Visakhapatnam.
- Indian Navy's INS Sandhayak made her maiden port call at Port Klang, Malaysia, for hydrographic cooperation.
- It is the first of the indigenously designed and built Sandhayak-class hydrographic survey ship,

which was commissioned in February 2024.

- It was constructed at Garden Reach Shipbuilders & Engineers (GRSE), Kolkata.
- Yard 12652 (Udaygiri) being built at Mazagon Dock Shipbuilders Limited (MDSL), was delivered to the Indian Navy.
- It is the second among the seven Project 17A (P-17A) frigates under construction at Mazagon Dock Shipbuilders Limited (MDSL) in Mumbai and Garden Reach Shipbuilders and Engineers in Kolkata.
- Prime Minister Narendra Modi commissioned three frontline naval warships and submarines - INS Surat, INS Nilgiri and INS Vagsheer at the Mazagon Dock Shipbuilders Limited (MDL), Mumbai, Maharashtra on 15 January 2025.
- INS Nilgiri is a stealth frigate and is the lead ship of the Indian Navy's Project 17A, to develop stealth frigates .
- INS Surat is the last of the four guided missile destroyer class ships to be constructed under Project 15B and INS Vaghsheer is the the sixth and final submarine of the Kalvari class built under Project 75 of the Indian Navy
- Larsen & Toubro (L&T) launched the second multi-purpose vessel (MPV) INS Utkarsh for the Indian Navy.
- Mumbai based Mazagon Dock Shipbuilders Limited (MDL) marked a key milestone in India's defence capabilities with the delivery of the sixth and final Scorpene-class submarine, INS Vaghsheer, to the Indian Navy.
- It is the sixth submarine of the first batch of six Kalvari-class submarines for the Indian Navy.
- INS Nirdeshak is the second ship under the Survey Vessel (Large) Project of the Indian Navy. It is designed to conduct hydrographic surveys, assist in navigation and support maritime operations.
- It is built by Garden Reach Shipbuilders and Engineers (GRSE), Kolkata.
- Indian Navy is set to commission its latest multi-role stealth guided missile frigate, INS Tushil, at Kaliningrad, Russia
- Garden Reach Shipbuilders and Engineers (GRSE) Ltd delivered INS Nirdeshak to the Indian Navy. It is the second in a series of four Survey Vessels (Large) being built by the Garden Reach Shipbuilders and Engineers.

- ✓ India Achieves 20% Ethanol Blending with Petrol in November 2025 .
- ✓ Ministry of Petroleum & Natural Gas (MoPNG) announced that India achieved 20% ethanol blending in petrol in November 2025, achieving the target ahead of the original 2030 goal under the Ethanol Blended Petrol (EBP) Programme.
- ✓ **Ethanol Blending:** In November 2025, ethanol blending in petrol reached 20%, up from 19.97% in October, with PSU OMCs receiving 45.5 crore litres and 77.8 crore litres in storage.
- ✓ **Feedstock Allocation:** To support the 20% ethanol blending target by October 2026, the government approved 52 Lakh Tonnes(LT) of surplus Food Corporation of India (FCI) rice for ethanol production for Ethanol Supply Year(ESY)2024-25 and 2025-26, and 40 LT of sugar for ESY 2024-25.
- ✓ **Rapid Growth:** Ethanol blending in India increased from just 1.5% in 2014 to 20% in 2025.
- ✓ **Global Standing:** India is the third-largest ethanol producer in the world, following the USA and Brazil.
- ✓ **Vehicle Mandate:** The government mandated that all new vehicles manufactured from April 1, 2025, must be E20 certified.
- ✓ As of 2025, the approximate percentage of Goods and Services Tax (GST) levied on ethanol meant for the Ethanol Blended Petrol (EBP) Programme is 5%.

- ✓ Indian Space Research Organisation (ISRO) successfully completed qualification tests for the Drogue Parachutes of the Gaganyaan Crew Module at the Rail Track Rocket Sled (RTRS) facility in Chandigarh.
- ✓ The tests were conducted with the support and participation from ISRO's Vikram Sarabhai Space Centre (VSSC); DRDO's Aerial Delivery Research and Development Establishment (ADRDE) and TBRL.

- ✓ ISRO is expected to send 3-member Indian crew into Lower Earth Orbit (LEO) under the Gaganyaan Mission in 2027.
- ✓ The crew will travel at an altitude of 400 kilometers (kms) for a 3-day expedition and ensure safe re-entry and recovery in the Indian Ocean.

ISRO IN NEWS 2025

- ISRO successfully completed qualification tests for the Drogue Parachutes of the Gaganyaan Crew Module at the Rail Track Rocket Sled (RTRS) facility in Chandigarh.
- ISRO successfully launched the 4,410 kg multiband communication satellite CMS-03 from the Satish Dhawan Space Centre, Sriharikota, Andhra Pradesh.
- Satellite Weight: The satellite weighs about 4,410 kilograms.
- Launch Vehicle: It was launched by the LVM3-M5 rocket, often nicknamed the "Bahubali" rocket.
- Orbit: The satellite was placed into a Geosynchronous Transfer Orbit (GTO).
- NRSC/ ISRO signs MoU with BCCL and CMPDI on use of Satellite data for Surface Coal Fire & Land Subsidence Mapping in Jharia Coal Field
- ISRO has set a target to launch seven missions by the end of March 2026, including the first uncrewed flight for the Gaganyaan programme.
- ISRO has officially announced that the Mangalyaan-2 mission is set to launch in the year 2030.
- ISRO, NewSpace India Limited (NSIL), IN-SPACe, and Hindustan Aeronautics Limited (HAL) signed a landmark technology transfer deal on September 10, 2025, for ISRO's Small Satellite Launch Vehicle (SSLV).
- ISRO successfully completed its first Integrated Air Drop Test (IADT-1), which is an important milestone in the preparations for the country's first human spaceflight program, Gaganyaan, on August 24, 2025, at Sriharikota, Andhra Pradesh.
- ISRO to launch Block 2 BlueBird satellite in 3-4 months, following successful NISAR mission with NASA.
- About Bluebird Satellite
- It is an advanced American communications satellite.
- It was developed by the U.S.-based AST SpaceMobile.
- ISRO has inaugurated the Himalayan Outpost for Planetary Exploration (HOPE) space analog

- ISRO plans to launch three navigation satellites by 2026 as part of its Indian Regional Navigation Satellite System (IRNSS), also known as NavIC (Navigation with Indian Constellation).
- The new satellites, designated NVS-03, NVS-04, and NVS-05.
- NavIC is designed to be interoperable with other global navigation satellite systems (GNSS) like GPS (USA), GLONASS (Russia), Galileo (EU), and BeiDou (China).
- The Cabinet Committee approved \$3.2 billion for the SBS-III programme to develop next-generation satellites over the next decade. Under the programme, ISRO will manufacture and launch the first 21 satellites.
- ISRO's 63rd PSLV mission (PSLV-C61/EOS-09) failed due to a technical malfunction during the third stage of the PSLV rocket.
- Since its first flight, Polar Satellite Launch Vehicle (PSLV) has failed only twice - inaugural flight in 1993 and again in 2017.
- ISRO's 101st launch using PSLV-C61 failed mid-flight, due to a chamber pressure drop during the third stage. The mission aimed to place EOS-09 in Sun Synchronous Polar Orbit.
- ISRO has successfully developed an indigenous Stellite nozzle divergent for the PSLV's fourth stage, replacing the previously imported Columbian and significantly reducing import costs by 90%.
- ISRO achieved its historic 100th launch from the Satish Dhawan Space Centre (SDSC) in Sriharikota, Andhra Pradesh using the GSLV-F15 to deploy the NVS-02 satellite.
- NVS-02 is the 2nd satellite in the series of 2nd generation satellites of the Navigation with Indian Constellation (NavIC).
- The GSLV-F15 is the 17th GSLV flight, and 11th with an Indigenous Cryogenic stage.
- Union Cabinet approved the establishment of the Third Launch Pad (TLP) at Satish Dhawan Space
