- ✓ India will soon have over 100 tsunami-ready villages under the Tsunami Ready Recognition Programme in the Indian Ocean region.
- ✓ It is an international community-based programme developed by the Intergovernmental Oceanographic Commission (IOC) of the United Nations Educational, Scientific and Cultural Organization (UNESCO).
- ✓ The programme aims to build resilient coastal communities through tsunami awareness and preparedness.
- ✓ Its main objective is to reduce loss of life, livelihoods, and property during tsunamis.
- ✓ Communities must meet 12 indicators covering risk assessment, preparedness, and response.
- ✓ Tsunami-ready villages show hazard mapping, evacuation plans, public display boards, 24-hour warning systems, and regular mock drills

UNESCO IN NEWS 2025

- Deepavali has been inscribed on UNESCO's Representative List of the Intangible Cultural Heritage of Humanity during the 20th Session of the Intergovernmental Committee, held in New Delhi.
- India will host the 20th session of the UNESCO Intergovernmental Committee for Safeguarding of the Intangible Cultural Heritage from 8 to 13 December 2025 in New Delhi.
- Egypt's Khaled El-Enany was elected the 12th Director-General of UNESCO, beginning his four-year term
- UNESCO designated Lucknow a Creative City of Gastronomy in October 2025, recognizing its diverse and famous food heritage, particularly its Awadhi cuisine and intricate recipes
- On November 26, 2025, India celebrated Constitution Day with a significant international tribute — the unveiling of Dr. Bhimrao Ramji Ambedkar's bust at the UNESCO Headquarters in Paris

- UNESCO has adopted the world's first global ethical standards on neurotechnology, addressing privacy, human rights, and data protection amid the rapid rise of AI-driven brain-computer interfaces.
- Cold Desert Biosphere Reserve located in Himachal Pradesh has been included in UNESCO's World Biosphere Reserve Network.
- With this, now 13 biospheres in India have been listed in UNESCO's World Biosphere Reserve Network (WNBR).
- Ministry of Culture has started consultations to include Chhath Mahaparva in UNESCO's Representative List of the Intangible Cultural Heritage of Humanity.
- India has officially nominated the 'Ancient Buddhist Site, Sarnath' for the UNESCO World Heritage List under the 2025–26 nomination cycle.
- United States will again withdraw from the United Nations Educational, Scientific and Cultural Organization (UNESCO).
- The 'Maratha Military Landscape of India' has become the 44th property of India to be inscribed on the UNESCO World Heritage List.
- Uttar Pradesh's Salkhan Fossils Park, located in the Sonbhadra district, has made it to UNESCO's tentative list of World Heritage Sites.
- The Lakkundi group of monuments in Karnataka is being proposed for inclusion on UNESCO's tentative list of World Heritage Sites.
- Port Royal, Jamaica, is currently undergoing the nomination process to be inscribed on UNESCO's World Heritage List.
- The classical ancient Indian texts, Natyashastra and Shrimad Bhagavad Gita, have been inscribed in UNESCO's Memory of the World Register.
- La Prensa, a Nicaraguan newspaper, was indeed announced as the recipient of the UNESCO/Guillermo Cano World Press Freedom Prize for 2025.
- The Menhirs or standing stones of Mudumal in Telangana's Narayanpet district were included in India's tentative list for UNESCO World Heritage Sites in 2025.
- Two Indian heritage conservation projects—the Abathsahayeswarar Temple Conservation Project in Thukkatchi, Tamil Nadu, and the BJPCI Conservation Project of Mumbai, Maharashtra—have won UNESCO's Asia-Pacific Awards for Cultural Heritage Conservation 2024.

- UNESCO recently designated 16 new Global Geoparks, increasing the total number of geoparks in its network to 229 across 50 countries.
- UNESCO and the Indian Ministry of Electronics and Information Technology (MeitY) are collaborating on an AI Readiness Assessment (AI RAM) initiative in India.
- UNESCO has declared West Bengal as a top destination for heritage tourism.
- Kozhikode made history by becoming the first UNESCO City of Literature in India.
- India added 6 new properties to its UNESCO Tentative List, increasing the total count of tentative sites in the country to 62.

- India currently has 44 UNESCO World Heritage Sites. This includes 36 cultural sites, 7 natural sites, and 1 mixed site

- ✓ India will officially assume the chair of Kimberley Process Certification Scheme (KPCS), also known as Kimberley Process, a global initiative to remove conflict diamonds from the global supply chain, from January 01, 2026.
- ✓ This is for the 3rd time that India has been elected Chair of KP.
- ✓ India will take over the chairpersonship from the United Arab Emirates (UAE), the current Chair of the Kimberley Process (KP).
- ✓ Prior assuming the chairmanship, India officially took over as Vice Chair of KP from December 25, 2025.
- ✓ India will work closely with all participants and observer states, to ensure rule-based compliance and improve the credibility and effectiveness of the KP as an inclusive multilateral framework.
- ✓ The Gem & Jewellery Export Promotion Council (GJEPC) which works under the Ministry of Commerce & Industry (MoC&I) is the nodal agency for KP in India.

- ✓ **About Kimberley Process (KP).**
- ✓ KPCS, established in accordance with the United Nations (UN) resolution, came into force on January 01, 2003.
- ✓ KP is a tripartite initiative which involves governments, the global diamond industry, and civil society, aimed to curb trade in 'conflict diamonds' also known as rough diamonds, used by rebel groups to finance conflicts globally.
- ✓ At present, KP has 60 participants, representing 86 countries with the European Union (EU) and its member states considered as a single participant.
- ✓ Under the KP framework, the Vice-Chair automatically succeeds to the Chair in the subsequent year, with both roles appointed by consensus of the Plenary.
- ✓ **Kimberley Process (KP).**
- ✓ Founded : 2003
- ✓ Headquarters : Gaborone, Botswana

- ✓ Securities and Exchange Board of India (SEBI) doubled the monetary threshold for the simplified documentation procedure for issuing duplicate securities.
- ✓ This reform aims to reduce the compliance burden for investors and standardize practices across listed companies and Registrar and Transfer Agents (RTAs).
- ✓ **Key Highlights of the Reform**
- ✓ **Threshold Increase:** The monetary limit for availing simplified documentation has been increased from ₹5 lakh to ₹10 lakh.
- ✓ **Tiered Documentation:**
- ✓ **Up to ₹10,000:** Notarization is waived; investors can submit a simple undertaking on plain paper.
- ✓ **₹10,001 to ₹10 lakh:** Requires a standardized Affidavit-cum-Indemnity Bond on non-judicial stamp paper.
- ✓ **Above ₹10 lakh:** Additional documents such as an FIR, police complaint, or court order are required.
- ✓ **Mandatory Dematerialization:** All duplicate securities will now be issued strictly in demat form to encourage digital holdings.
- ✓ **Newspaper Advertisements:** For securities valued above ₹10 lakh, the listed company is responsible for publishing a weekly advertisement regarding the loss.

- ✓ **Key Changes Introduced by SEBI:**
- ✓ **Up to ₹10,000:** An undertaking on plain paper is sufficient (no notarization).
- ✓ **Up to ₹10 Lakh (previously ₹5 Lakh):** An Affidavit-cum-Indemnity Bond on appropriate non-judicial stamp paper is required, but notarization is dispensed with.

- ✓ **Exceeding ₹10 Lakh:** The standard affidavit, plus documents like an FIR, police complaint, or court order, and a newspaper advertisement are necessary.

SEBI IN NEWS 2025

- SEBI has suggested the exclusion of zero-coupon zero principal (ZCZP) bonds for determining the eligibility of basic services demat accounts (BSDA) of small investors.
- SEBI has overhauled RPT norms, shifting from a flat ₹1,000 crore limit to tiered, turnover-based thresholds capped at ₹5,000 crore, while easing disclosures for smaller transactions.
- The government has appointed Sandip Pradhan as a whole-time member of SEBI for three years, replacing Ashwani Bhatia.
- SEBI extended the deadline for the complete roll out of algorithm trading rules for retail investors to April 01, 2026.
- SEBI introduced special relaxations for Public Sector Undertakings (PSUs) in which the government already holds 90% or more equity.
- SEBI has revised the norms for InvITs, primarily by lowering the minimum investment for privately placed InvITs from ₹1 crore to ₹25 lakh
- SEBI was held in Mumbai, Maharashtra, where the board approved compliance relaxations for Foreign Portfolio Investors (FPIs) investing solely in Indian Government Securities (G-secs) to simplify their onboarding process.
- SEBI has eased compliance norms for Foreign Portfolio Investors (FPIs) who invest exclusively in government securities (G-Secs) under the Fully Accessible Route (FAR).
- SEBI introduced a new framework for co-investments within the Alternative Investment Fund (AIF) structure
- SEBI has mandated minimum investment threshold or ticket size of Rs 1 crore for the issuance of Securitised Debt Instruments (SDIs) for the Reserve Bank of India (RBI)-regulated originators and unregulated entities engaged in securitization activities.
- SEBI launched the SWAGAT-FI (Single Window Automatic & Generalised Access for Trusted Foreign Investors) framework in September 2025 to simplify the entry and regulatory processes for certain foreign investors.
- SEBI launched the "SEBI Check" tool on October 1, 2025, to verify UPI IDs and bank accounts for

payments to registered market intermediaries

- SEBI is working with the Unique Identification Authority of India (UIDAI) and the Reserve Bank of India (RBI) to create a remote, secure Know Your Customer (KYC) system for non-resident Indians (NRIs)
- SEBI has launched two new initiatives, Validated UPI Handles and the SEBI Check tool, to improve payment security for investors .
- Validated UPI handles include an exclusive “@valid” suffix and a visual indicator like a green "thumbs-up" icon to confirm authenticity.
- Walmart-owned fintech giant PhonePe has filed draft papers with SEBI for an IPO, expected to raise around ₹12000 crore.
- SEBI has tightened rules for intraday index options trading by introducing a new net position limit of ₹5,000 crore per entity, which is significantly higher than the previous end-of-day limit of ₹1,500 crore. The gross intraday position limit remains unchanged at ₹10,000 crore
- SEBI approves LIC's reclassification as a public shareholder in IDBI Bank, with voting rights capped at 10% and stake cut to 15% within two years.
- The government, which owns 45.48%, and LIC, which holds 49.24%, together plan to sell a 60.7% stake.
- Quant Mutual Fund received approval from the SEBI to launch India's first Specialised Investment Fund (SIF), named the QSIF Equity Long-Short Fund.
- SEBI detailing a mechanism for monitoring and enforcing the minimum ₹10 lakh investment threshold in Specialized Investment Funds (SIFs).
- SEBI, in collaboration with BSE, CDSL, NSDL, and KFinTech, launched a Securities Market Hackathon at Global Fintech Fest 2025.
- SEBI has approved the use of the NPCI's e-KYC Setu system for registered intermediaries to perform Aadhaar-based digital KYC
- Investor Education and Protection Fund Authority (IEPFA) and SEBI to Launch Pilot 'Niveshak Shivir' in Pune to Empower Investors and Streamline Grievance Redressal and Unclaimed Dividend Claims.

- ✓ President of India, Droupadi Murmu officially released the Constitution of India in the Santhali language using the Ol Chiki script during a function held at the Rashtrapati Bhavan in New Delhi, Delhi.
- ✓ The Santhali language was included in the 8th Schedule of the Constitution as one of the official languages through the 92nd Constitutional Amendment Act, 2003.
- ✓ At present, 22 Indian languages are recognised as official languages of India, listed under the 8th Schedule of the Constitution.
- ✓ The Santhali Language, one of the most ancient living languages in India, is spoken widely by a large tribal community across Jharkhand, Odisha, West Bengal and Bihar
- ✓ The event was held during the centenary year (100 years) of the Ol Chiki script, which was developed by Pandit Raghunath Murmu in 1925.
- ✓ **Statement 4 is incorrect:** While widely spoken in Jharkhand and Odisha, the language is also spoken by a significant population in West Bengal and Bihar.

- ✓ VoxelGrids, a Zoho-backed startup, developed and deployed India's first fully indigenous 1.5-tesla (1.5T) Magnetic Resonance Imaging (MRI) scanner at the Chandrapur Cancer Care Foundation, near Nagpur, Maharashtra.
- ✓ This MRI scanner is the culmination of a 12-year mission led by VoxelGrids Founder Arjun Arunachalam to design and build an MRI system domestically, reducing India's dependence on foreign imports.
- ✓ Uses a helium-free "dry magnet" design, eliminating the need for costly liquid helium coolant.
- ✓ The MRI scanner, developed under the National Biopharma Mission (NBM), showcases public-private collaboration in advanced medical technology and aligns with India's Aatmanirbhar Bharat initiative.

- ✓ Road Connectivity Project for Left Wing Extremism Affected Areas (RCPLWEA): Launched in 2016, was a targeted intervention aimed at strengthening infrastructure development in regions affected by Left Wing Extremism (LWE).
- ✓ It covered 44 of the most severely affected LWE districts and adjoining areas across nine States: Andhra Pradesh (AP), Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh (MP), Maharashtra, Odisha, Telangana, and Uttar Pradesh.
- ✓ Phase-III: Phase III of the programme, launched in 2019, is aimed at upgrading approximately 1,25,000 km of Through Routes and Major Rural Links.
