


- XED Executive Development Ltd has filed its Red Herring Prospectus (RHP) to raise approximately \$12 million (approx. ₹100 crore) through the first-ever equity IPO from India's GIFT City International Financial Services Centre (IFSC).
- The issue is expected to open for subscription in the first week of March 2026.
- **Key Facts about the XED IPO:**
- **Total Issue Size:** \$12 million, consisting of a \$9.6 million fresh issue and a \$2.4 million Offer for Sale (OFS) by promoter shareholders.
- **Listing Venue:** The shares will be dollar-denominated and listed on both NSE International Exchange (NSE IX) and India International Exchange (India INX).
- **Eligible Investors:** Participation is restricted to Non-Resident Indians (NRIs), Foreign Portfolio Investors (FPIs), and other overseas institutional investors; domestic Indian residents are generally not eligible to participate directly.
- **Unique IPO Duration:** Unlike domestic Indian IPOs that typically remain open for three days, this IFSC issue can stay open for up to 10 days.

GIFT CITY IN NEWS 2025-26

- First GIFT City IPO set to open in March as XED files RHP to raise \$12 million.
- Uday Kotak appointed Chairman of GIFT City.
- IIFL Capital Receives SEBI Nod for Setting up Subsidiary at GIFT IFSC.
- Gujarat government has granted in-principle approval to establish the Indian AI Research Organisation (IAIRO) in GIFT City (Gujarat International Finance Tec-City) near Gandhinagar.
- Infibeam Avenues Ltd (IAL) has received in-principle approval from the International Financial Services Centres Authority (IFSCA) to operate as a Payment Service Provider (PSP) at the Gujarat International Finance Tec-City (GIFT-IFSC).
- Finance Minister launched the Foreign Currency Settlement System (FCSS) at GIFT City's International Financial Services Centre (IFSC), enabling real-time settlement of global currency transactions.
- Bank of Baroda had received approval from the International Financial Services Centres Authority (IFSCA) to operate as a Trading - Cum Clearing member (TCM) on the India International Bullion Exchange IFSC Ltd (IIBX), at GIFT City.
- Standard Chartered Bank, CCIL IFSC Ltd, and IFSCA will launch a platform for real time settlement of US dollar denominated trades in GIFT City in Gandhinagar.
- State Bank of India has announced the listing of its regulations S bonds worth \$500 million on NSE-IX in GIFT City Gujarat.
- State bank of India and France's AFD have signed €100 mn line of credit at SBI's GIFT City branch to promote green financing in India.
- S&P Global Ratings Singapore PTE Ltd has become the biggest foreign credit rating agency to set up a base in GIFT City in Gujarat.
- Sanjay Kaul has been appointed as the new Managing Director and Group CEO of GIFT City, succeeding Tapan Ray.
- CTBC Bank, the largest privately owned bank in Taiwan, applied to the International Financial Services Authority (IFSCA) for setting up a IFSC Banking Unit (IBU) in GIFT City.
- UAE-based lender Mashreq has become the first from the country to receive in-principle approval from IFSCA to open a branch in Gujarat's GIFT City.

- **Reserve Bank of India (RBI)** released draft directions titled "Foreign Exchange Dealings of Authorised Persons" to provide greater operational flexibility and modernize the foreign exchange (FX) market.
- **Key Facts from the Draft Directions:**
- **Purpose:** To streamline inter-bank foreign exchange transactions, enhance hedging efficiency, and simplify reporting obligations.
- **Target Entities:** Primarily applies to Authorised Dealer (AD) Category-I banks and Standalone Primary Dealers (SPDs) authorised as AD Category-III.
- **Operational Freedom:** Dealers can now trade with each other for hedging exposures, balance sheet management, and proprietary positions.

- **Borrowing Limits:** AD Category-I banks are proposed to be allowed to borrow up to 100% of Tier-I capital or USD 10 million (whichever is higher) without prior RBI approval.
- **Market Access:** Dealers may trade on electronic trading platforms (ETPs) both in India and abroad, provided the overseas platform is in a Financial Action Task Force (FATF) member jurisdiction.
- **Gold Hedging:** Banks under the Gold Monetisation Scheme or permitted to offer forward gold contracts can now hedge gold price risks in overseas markets.
- **Consultation Period:** Stakeholders are invited to submit feedback on these draft directions by March 10, 2026.



RBI IN NEWS 2025-26

- ☞ Reserve Bank of India (RBI) launched Mission SAKSHAM (Sahakari Bank Kshamta Nirman) on February 6, 2026, as part of a comprehensive reform package for Urban Cooperative Banks (UCBs).
- ☞ Reserve Bank of India (RBI) will observe Financial Literacy Week (FLW) 2026 from February 9 to 13, 2026, with the theme “KYC – Your First Step to Safe Banking” (“KYC – सुरक्षित बैंकिंग की ओर पहला कदम”).
- ☞ Reserve Bank of India (RBI) is transitioning from a uniform flat-rate system to a Risk-Based Premium (RBP) framework for deposit insurance.
- ☞ Implementation Date: Effective from April 1, 2026.
- ☞ Premium Rates: The new range will be 8 paise to 12 paise per ₹100 of assessable deposits.
- ☞ Category A (Safest): 8 paise (approx. 33.3% discount).
- ☞ Category D (Riskiest): 12 paise (current flat rate).
- ☞ Assessment Models:
- ☞ Tier 1: Scheduled Commercial Banks (excluding RRBs), based on supervisory ratings and CAMELS parameters.
- ☞ Tier 2: Regional Rural Banks (RRBs) and Cooperative Banks, based on quantitative indicators.
- ☞ Exclusions: Payments Banks and Local Area Banks will continue to pay the flat 12 paise rate due to data limitations
- ☞ Depositor Impact: The insurance cover remains unchanged at ₹5 lakh per depositor per bank.
- ☞ Reserve Bank of India (RBI) on February 6, 2026, proposed exempting Type 1 NBFCs with an asset size of less than ₹1,000 crore from mandatory registration.
- ☞ Reserve Bank of India has announced plans to double the limit for collateral-free loans for MSMEs from Rs 10 lakh to Rs 20 lakh. These revised norms, effective April 1, 2026, aim to boost credit access for the micro, small, and medium sector.
- ☞ RBI has announced a one-time compensation of up to Rs 25,000 for victims of small-value digital frauds.
- ☞ RBI has approved Blackstone's acquisition of up to 9.99% stake in Federal Bank.
- ☞ Reserve Bank of India (RBI) approved the appointment of Vinay Muralidhar Tonse as the new Managing Director and CEO of YES Bank.

- ☞ The Reserve Bank of India (RBI) and the European Securities and Markets Authority (ESMA) signed a landmark Memorandum of Understanding (MoU) on January 27, 2026.
- ☞ Reserve Bank of India (RBI) approved the re-appointment of Kaizad Bharucha as the Whole-time Director (designated as Deputy Managing Director) of HDFC Bank on January 20, 2026.
- ☞ His renewed tenure is for a period of three years, effective from April 19, 2026, and will conclude on April 18, 2029.
- ☞ Reserve Bank of India (RBI) issued amendments to the Priority Sector Lending (PSL) – Targets and Classification Directions, 2025 to refine how banks compute Adjusted Net Bank Credit (ANBC) and align with updated prudential norms.
- ☞ Revised Sector Targets: The PSL target for Small Finance Banks (SFBs) has been adjusted from 75% to 60% of their Adjusted Net Bank Credit (ANBC).
- ☞ For RRBs, lending to medium enterprises, social infrastructure and renewable energy will count only up to 15% of ANBC.
- ☞ Reserve Bank of India (RBI) introduced the Integrated Ombudsman Scheme (RB-IOS), 2026 in January 2026 to enhance the grievance redressal mechanism for customers of regulated entities.
- ☞ Compensation Limits:
 - ☞ Financial Loss: Up to ₹30 lakh for actual consequential financial loss (increased from ₹20 lakh).
 - ☞ Non-Financial Loss: Up to ₹3 lakh for mental anguish, harassment, or loss of time (increased from ₹1 lakh).
- ☞ Reserve Bank of India (RBI) has announced a significant overhaul of foreign exchange regulations, with new Foreign Exchange Management (Export and Import of Goods and Services) Regulations, 2026, scheduled to take effect on October 1, 2026.



- Total bilateral trade surpassed \$100 billion in FY 2024–25, reaching this milestone five years earlier than the original 2030 deadline set under the 2022 Comprehensive Economic Partnership Agreement (CEPA).
- Achieving the \$200 billion target by 2032 requires an annual trade growth rate of approximately 9–10%.
- A sub-target aims for \$100 billion in non-oil, non-precious metals trade by 2030.
- Key initiatives supporting this goal include the Bharat Mart distribution hub in Dubai, a Virtual Trade Corridor using the MAITRI platform, a 10-year agreement for LNG supply from the UAE to India starting in 2028, and collaborative investment projects like the Dholera Special Investment Region and expansion of UAE firms in GIFT City

- The victory marks the first official Freestyle Chess World Championship recognised by FIDE, adding a new crown to Carlsen's extensive list of global honours.
- **Total Prize Pool:** The tournament featured a total fund of \$300,000, with the winner receiving \$100,000.

- **RBI** spells out norms to keep loan recovery agents on leash.
- Reserve Bank of India (RBI) issued the Commercial Banks – Responsible Business Conduct (Second Amendment) Directions, 2026, significantly tightening the rules for loan recovery to curb borrower harassment.
- **Key Facts:** RBI Recovery Guidelines 2026
- **Effective Date:** The new harmonised guidelines will come into force on July 1, 2026.
- **Mandatory Certification:** Recovery agents must now complete a certified training program through the Indian Institute of Banking and Finance (IIBF) before being hired.
- **Permissible Contact Hours:** Agents are restricted to contacting borrowers only between 8:00 AM and 7:00 PM.
- **Grievance Redressal:** Lenders cannot initiate recovery action through an agent if a borrower's grievance is pending, unless it is explicitly found to be frivolous.
- **Privacy Protection:** Agents are prohibited from contacting a borrower's family, friends, or colleagues for recovery purposes.
- **Prohibited Practices:** Agents cannot use abusive language, threaten borrowers, make excessive or anonymous calls, contact outside prescribed hours, or publicly humiliate borrowers or guarantors.
- **Definition of Harsh Methods:** Intimidation or harassment, whether verbal, physical, or reputational, towards borrowers, guarantors, or their relatives, friends, or co-workers will be treated as harsh recovery practices. False or misleading representations regarding the extent of debt or consequences of non-repayment are also prohibited.
- **Institutional Responsibility:** All banks must establish a formal policy on recovery of loans, engagement of recovery agents, and taking possession of security. The policy must include eligibility criteria, due diligence norms, a code of conduct, specified activities, and performance evaluation standards for recovery agents.




