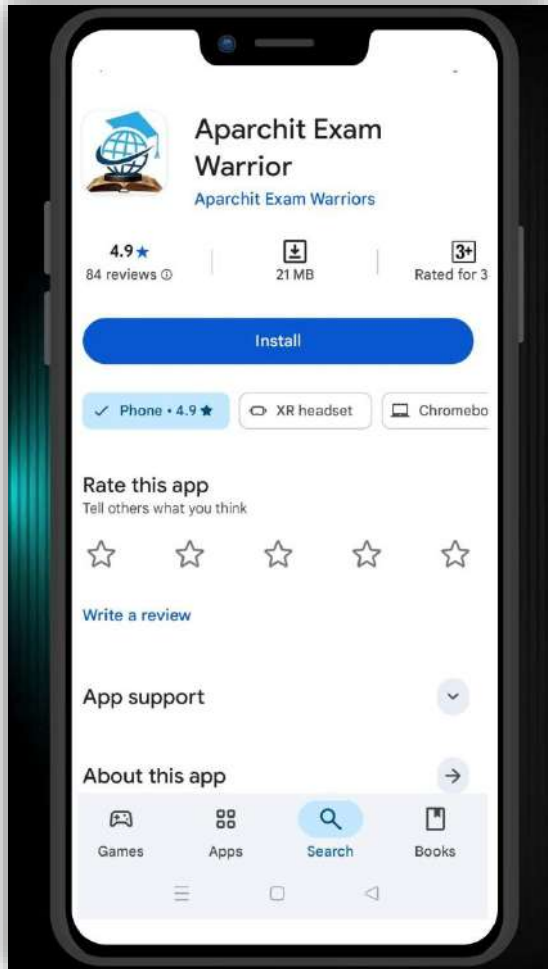

- **Front Runners:** These states maintain broadly sound finances but fall short of the top tier on one or more indicators;
- **Performers:** They occupy the middle ground, with mixed results across the five pillars.
- **Aspirational:** These states are those facing the most significant fiscal stress, characterised by persistent deficits, high debt, and limited revenue capacity..
- **Data Source:** The report utilizes verified data from the Comptroller and Auditor General (CAG).
- **Rankings Hierarchy:**
- **Achievers (Top 3):** Odisha (Rank 1, Score 73.1), Goa (Rank 2, Score 54.7), and Jharkhand (Rank 3, Score 50.5).

- According to the Fiscal Health Index (FHI) 2026 report released by NITI Aayog on March 11, 2026, Odisha retained its top position among 18 major states with an overall score of 73.1.
- Nidhi Chhibber was assigned the additional charge of Chief Executive Officer (CEO) of NITI Aayog on 24 February 2026.
- According to NITI Aayog, this sector is projected to reach \$300 billion by 2030, reflecting its economic and ecological potential.
- The "We Rise" initiative, a joint project by NITI Aayog's Women Entrepreneurship Platform (WEP) and DP World, aims to help women-led businesses in India expand globally.
- The second edition of the North Eastern Region (NER) District Sustainable Development Goals (SDG) Index Report (2023-24) was released in July 2025 by NITI Aayog.
- All districts in Mizoram, Sikkim, and Tripura are classified as "Front Runners".
- Hnahthial (Mizoram) was the best-performing district, with Longding (Arunachal Pradesh) having the lowest score.
- The report was developed in collaboration with the UNDP and the Ministry of Development of Northeast Region (MDoNER).
- India has surpassed Japan to become the world's fourth-largest economy, according to NITI Aayog CEO BVR Subrahmanyam, referencing IMF data.
- India is now a USD 4 trillion economy, trailing only the US, China, and Germany.
- Global Alliance for Mass Entrepreneurship (GAME) and NITI Aayog join hands to catalyse healthy entrepreneurship ecosystems across India.

- **RBI Issues Final Amendment Directions on Counterparty Credit Risk Framework.**
- Reserve Bank of India (RBI) issued the Reserve Bank of India (Commercial Banks – Prudential Norms on Capital Adequacy) Third Amendment Directions, 2026 on March 10, 2026.
- These amendments refine the Counterparty Credit Risk (CCR) framework to better align with international Basel III standards and clarify capital requirements for specific derivative transactions.
- **Facts: RBI CCR Amendment 2026:**
- **Objective:** To align India's Potential Future Exposure (PFE) calculation with Basel Committee on Banking Supervision (BCBS) standards and enhance transparency in risk measurement.
- **Target Entities:** Applies to Commercial Banks (including Small Finance and Payments Banks) and All India Financial Institutions.
- **Clearing Members:** Clarifies that banks acting as clearing members on SEBI-recognised exchanges for equity and commodity derivatives must maintain a capital charge for CCR.
- **Consolidated Reporting:** Banks must now include CCR exposures of all entities consolidated under the capital adequacy framework when computing capital at the group level.
- **Revised Add-on Factors:** Replaces Table 16 of the Master Direction, updating the "add-on factors" used to calculate PFE based on contract type and residual maturity.
- **Equities:** 6% (up to 1 year), 8% (1-5 years), and 10% (over 5 years).
- **Precious Metals (excl. Gold):** 7% (up to 1 year), 7% (1-5 years), and 8% (over 5 years).
- **Other Commodities:** 10% (up to 1 year), 12% (1-5 years), and 15% (over 5 years).
- **Interest Rate Floor:** Interest rate contracts with residual maturities over one year that reset periodically have a minimum add-on floor of 0.50% (reduced from the previous 1.0%).

- **Key Facts about the UIDAI Bug Bounty Programme:**
- **Launch Date:** The programme was officially announced and launched on March 11, 2026.
- **Core Objective:** To add a "defense in depth" layer by identifying hidden security risks in the Aadhaar system before they can be exploited.
- **Implementation Partner:** UIDAI is running the initiative in partnership with M/s ComOlho IT Private Limited, a cybersecurity solutions provider.
- **Target Digital Assets:** The researchers are tasked with probing:
  - The official UIDAI website.

- **Existing Security Measures:** This program complements UIDAI's current multi-layered security, which includes regular security audits, penetration testing, and continuous monitoring.

- **Confidentiality:** A primary objective is to maintain victim anonymity and ensure that complaints reach the designated committee without any intermediate delay.

- **Mandatory Requirement:** Farmers must complete their e-KYC on the official PM-KISAN portal to remain eligible for the payment.
- **About PM – KISAN:**
- The Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) scheme was launched by Prime Minister Narendra Modi on February 24, 2019, in Gorakhpur, Uttar Pradesh.
- Although launched in 2019, the scheme was made effective from December 1, 2018.
- **Purpose:** To provide direct income support of ₹6,000 per year to landholding farmer families.
- **Installments:** The amount is transferred in three equal installments of ₹2,000 every four months.
- **Funding:** It is a Central Sector Scheme with 100% funding from the Government of India.

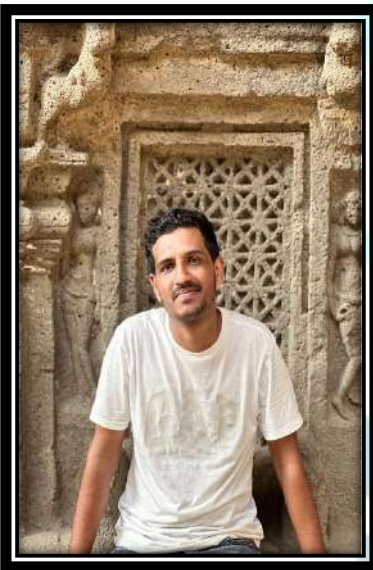

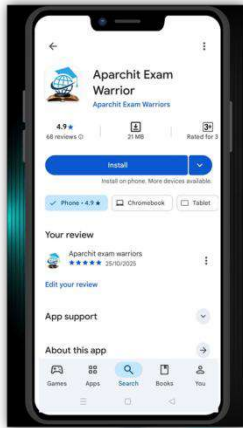
