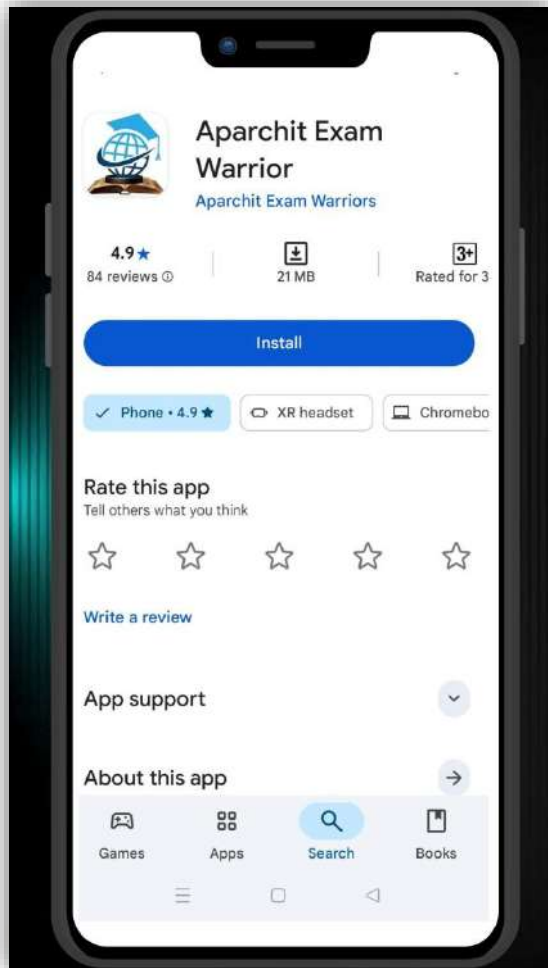

SEBI IN NEWS 2025-26

- SEBI has slashed the minimum investment threshold for individual investors in Social Impact Funds (SIFs), a sub-category of AIFs, from ₹2 lakh to ₹1,000.
- SEBI introduced Life Cycle Funds as a new mutual fund category.
- SEBI has suggested the exclusion of zero-coupon zero principal (ZCZP) bonds for determining the eligibility of basic services demat accounts (BSDA) of small investors.
- SEBI has overhauled RPT norms, shifting from a flat ₹1,000 crore limit to tiered, turnover-based thresholds capped at ₹5,000 crore, while easing disclosures for smaller transactions.
- The government has appointed Sandip Pradhan as a whole-time member of SEBI for three years, replacing Ashwani Bhatia.
- SEBI extended the deadline for the complete roll out of algorithm trading rules for retail investors to April 01, 2026.
- SEBI introduced special relaxations for Public Sector Undertakings (PSUs) in which the government already holds 90% or more equity.
- SEBI has revised the norms for InvITs, primarily by lowering the minimum investment for privately placed InvITs from ₹1 crore to ₹25 lakh.
- SEBI was held in Mumbai, Maharashtra, where the board approved compliance relaxations for Foreign Portfolio Investors (FPIs) investing solely in Indian Government Securities (G-secs) to simplify their onboarding process.
- SEBI has eased compliance norms for Foreign Portfolio Investors (FPIs) who invest exclusively in government securities (G-Secs) under the Fully Accessible Route (FAR).
- SEBI introduced a new framework for co-investments within the Alternative Investment Fund (AIF) structure.
- SEBI has mandated minimum investment threshold or ticket size of Rs 1 crore for the issuance of Securitised Debt Instruments (SDIs) for the Reserve Bank of India (RBI)-regulated originators and unregulated entities engaged in securitization activities.
- SEBI launched the SWAGAT-FI (Single Window Automatic & Generalised Access for Trusted Foreign Investors) framework in September 2025 to simplify the entry and regulatory processes for certain foreign investors.

- In March 2026, Bhupathiraju Anmish Varma was officially recognized by Guinness World Records for the fastest ascent of the Seven Volcanic Summits (male).
- A native of Visakhapatnam, Andhra Pradesh, he completed the grueling challenge in a record-breaking 92 days, 4 hours, and 45 minutes.
- Varma reached the summit of Mount Sidley in Antarctica on January 23, 2025, which marked the successful completion of his seven-continent volcanic challenge.
- **Fast Facts about the Record:**
- **Expedition Timeline:** The entire journey spanned from October 23, 2024, to January 23, 2025.
- **Official Verification:** The record was verified by Guinness World Records on February 6, 2026, and he received his certificate in Delhi in March 2026.
- **The Seven Peaks:** Varma climbed the highest volcano on each of the seven continents:
 - Mount Elbrus (Europe)
 - Mount Kilimanjaro (Africa)

- ☞ NHAI has successfully created four Guinness World Records on the under-implementation Bengaluru-Kadapa-Vijayawada Economic Corridor of NH-544G.
- ☞ Union Health Ministry has achieved three GUINNESS WORLD RECORDS™ titles under the nationwide "Swasth Nari, Sashakt Parivar Abhiyaan" (SNSPA) campaign, recognizing India's unparalleled commitment to preventive and women-centric healthcare.

- **Book Theme:** The book redefines compassion (Karuna) not as a "soft emotion," but as a dynamic, transformative force for solving global issues like inequality and conflict.
- **Official Launch:** It was launched at the Jaipur Literature Festival on 17 January 2026.
- **Nobel Legacy:** Kailash Satyarthi was awarded the Nobel Peace Prize in 2014 jointly with Malala Yousafzai for their struggle against the suppression of children and for the right of all children to education.
- **Grassroots Impact:** Satyarthi founded the Bachpan Bachao Andolan (Save the Childhood Movement) in 1980, which has liberated approximately 100,000 children from slavery and exploitation.
- **Other Works:** He recently released his autobiography titled "Diyaslai," which chronicles his life's journey and fight for child rights.

- From April 1, 2026, PAN card applications will no longer accept Aadhaar as the sole document, requiring mandatory additional proof of date of birth (e.g., birth certificate, passport) and a move to new application forms.

- The "Aadhaar-only" route ends on March 31, 2026.
- New applications must include a separate birth certificate, passport, voter ID, or Class 10 marksheet as proof of birth.

- The "Name" field will be strictly derived from Aadhaar to prevent discrepancies.

- **New Application Forms:**

- Current (old) PAN forms will be discontinued and no longer accepted.
- **Form No. 93:** For Indian individuals.
- **Form No. 94:** For Indian companies/entities.

- **Revised Transaction Thresholds:**

- **Cash Deposits:** PAN is required for aggregate annual deposits of ₹10 lakh or more (replacing the ₹50,000 daily limit).
- **Property:** Mandatory for deals above ₹20 lakh (previously ₹10 lakh).
- **Vehicles:** Only required for purchases exceeding ₹5 lakh (previously required for all motorized vehicles).
- **Hotels/Restaurants:** Required for cash payments above ₹1 lakh (up from ₹50,000)

- **Fact:** MyWAVES is a user-generated content (UGC) platform launched on the WAVES OTT service.

- **Set-Top-Box Free Access (DD Free Dish):**

- The 2026 Rules expand the 50% HRA exemption (previously limited to the four major metros: Delhi, Mumbai, Chennai, and Kolkata) to include four additional high-growth tech hubs: Bengaluru, Pune, Hyderabad, and Ahmedabad.
- **Key Facts of Income-tax Rules, 2026:**

- **Structural Simplification:** The total number of rules has been reduced from 511 to 333, aiming to decrease litigation and interpretational disputes.
- **Unified Terminology:** The confusing "Previous Year" and "Assessment Year" model is replaced by a single, unified "Tax Year".
- **Revised Allowance Limits:**
- **Children Education Allowance:** Increased from ₹100 to ₹3,000 per month per child.
- **Hostel Expenditure Allowance:** Raised from ₹300 to ₹9,000 per month per child.
- **Meal Vouchers:** The tax-exempt limit for employer-provided meals increased from ₹50 to ₹200 per meal.
- **New Digital Compliance:**
- **Smart Forms:** Legacy forms like Form 16 and 26AS are replaced by Form 130 and Form 168, respectively, featuring pre-filled data and automated reconciliation.

- **Filing Deadlines:** The ITR filing due date for non-audit business cases (ITR-3 and ITR-4) is extended to August 31 from the previous July 31.

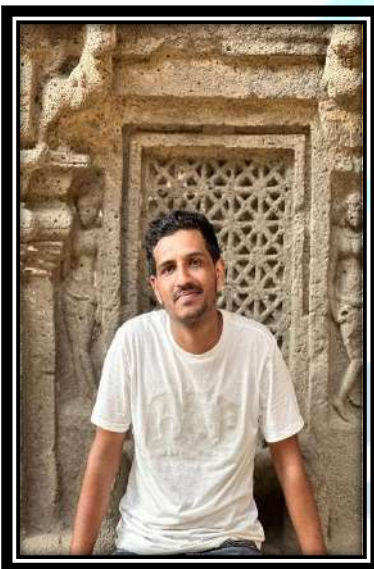

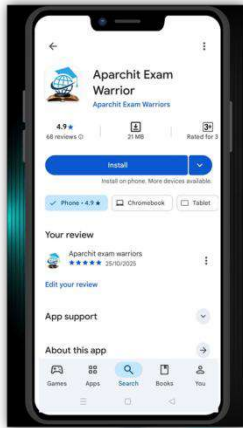
