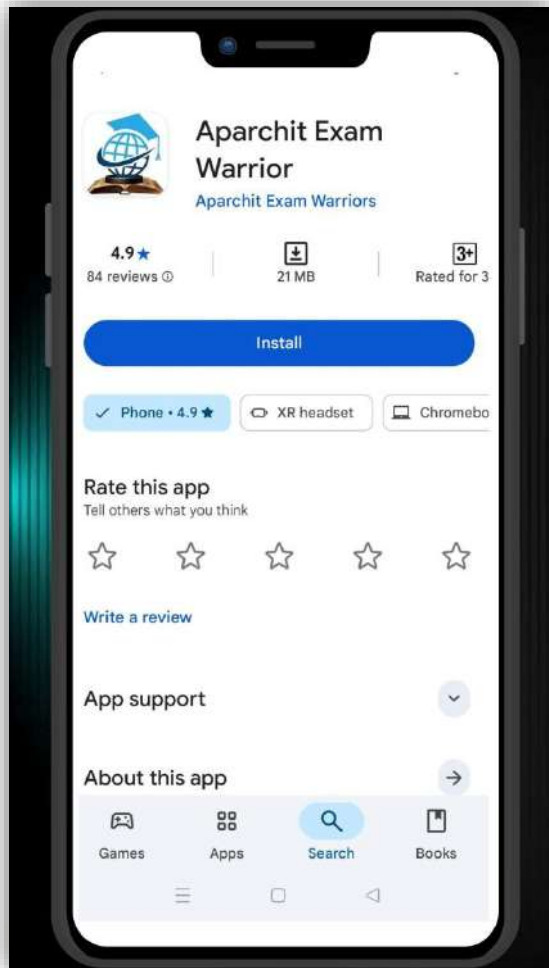

- His appointment followed the resignation of Gombojavyn Zandanshatar on March 27, 2026, amid legislative deadlocks and opposition boycotts.
- **Political Party:** He is a member of the ruling Mongolian People's Party (MPP) and currently serves as its Chairman.
- **Third PM in a Year:** Mongolia saw three Prime Ministers in just nine months—Oyun-Erdene, Zandanshatar, and now Uchral—highlighting significant political volatility.

- This initiative, organized under the DISHA (Designing Innovative Solutions for Holistic Access to Justice) scheme, aims to democratise access to legal services across India.
- 'Nyaya Setu' is a voice-first, multimodal, and multilingual AI-powered assistant designed to help citizens understand legal processes and rights in multiple Indian languages.
- It was built as a turnkey solution by the Digital India BHASHINI Division (DIBD).
- **Key Facts about Nyaya Setu and Dishika:**
- **Multilingual Support:** The chatbot supports 23 voice languages and 36 text-based languages, including regional and tribal dialects.
- **Technological Stack:** It integrates BHASHINI's Automatic Speech Recognition (ASR) and multilingual Natural Language Processing (NLP) to enable seamless, voice-led user journeys.
- **Legal Training:** The AI is trained on frameworks such as the Bharatiya Nyaya Sanhita (BNS) to ensure responses are safe, responsible, and context-aware.
- **Purpose of Dishika:** As a relatable digital mascot, 'Dishika' acts as a friendly interface to reduce the intimidation of the legal system and guide first-time users through complex procedures.
- **Wider Launch:** Along with the chatbot, the Vice President released the "Voice of Beneficiaries" Booklet 2025–26 and a series of legal awareness comic books developed with National Law University (NLU), Delhi

- **Fast Facts:** Skytrax World Airport Awards 2026
- **Global Top 5:** The top five airports for 2026 are all located in Asia: 1. Singapore Changi, 2. Seoul Incheon, 3. Tokyo Haneda, 4. Hong Kong International, and 5. Tokyo Narita.

- **The Reserve Bank of India (RBI)** tightened foreign exchange (FX) derivative norms on April 1, 2026, to curb extreme rupee volatility.
- The Reserve Bank of India (RBI) has issued a circular effective April 1, 2026, tightening foreign exchange (FX) derivative norms to curb rupee volatility following a 10% decline in the currency's value during FY26.
- These measures were introduced after the rupee hit record lows, breaching the ₹95 per dollar mark in March 2026 following geopolitical tensions in West Asia.
- Effective April 1, 2026, the RBI officially barred authorized dealers from offering non-deliverable derivative (NDD) contracts involving the INR to both resident and non-resident users.
- **Key Facts & Regulatory Updates (April 2026):**
- **NDF Prohibition:** Banks cannot offer non-deliverable forwards (NDFs). Deliverable contracts for genuine hedging are still allowed, provided users do not take offsetting NDF positions.
- **No Rebooking:** If a customer cancels an FX derivative contract after April 1, they are strictly prohibited from rebooking it.
- **Related Party Ban:** Authorized dealers are barred from undertaking any INR derivative transactions with their related parties (as defined by accounting standards like Ind AS 24).
- **Rupee Performance:** The INR was Asia's worst-performing currency in FY26, depreciating nearly 10% over the year.
- **Immediate Impact:** Following these announcements, the rupee saw its largest single-day gain in over 12 years, surging to roughly ₹93.14 - ₹93.59 against the dollar on April 2, 2026.

- Effective April 1, 2026, the Reserve Bank of India (RBI) mandated a new principle-based framework for Two-Factor Authentication (2FA) across all digital payment transactions, including UPI, debit/credit cards, and mobile wallets.
- **Key Facts about the 2026 2FA Mandate:**
- **Three Authentication Categories:** Factors must be drawn from different categories:
  - **Knowledge:** Something you know (e.g., PIN, password, passphrase).
  - **Possession:** Something you have (e.g., smartphone for OTP, hardware token, card).
  - **Inherence:** Something you are (e.g., fingerprint, facial recognition, or Aadhaar-based biometrics).
- **Issuer Liability:** If a bank or payment provider fails to comply with these 2FA norms and fraud occurs, the issuer is held fully liable to compensate the customer for the loss "without demur".
- **Risk-Based Approach:** Banks can implement higher security checks for "high-risk" transactions—such as large transfers or payments from unfamiliar locations—while keeping routine payments on trusted devices seamless.
- **International Transactions:** While domestic rules began April 1, 2026, the deadline for similar robust authentication for international card-not-present (CNP) transactions is October 1, 2026.
- **Privacy Compliance:** All authentication processes must adhere to the Digital Personal Data Protection Act, 2023.

- **Awards:** He is highly decorated, holding the Param Vishisht Seva Medal (PVSM) (2025), Uttam Yudh Seva Medal (UYSM) (2026), and Ati Vishisht Seva Medal (AVSM) (2022).

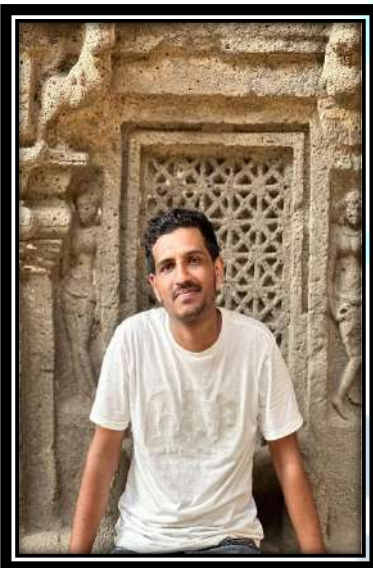

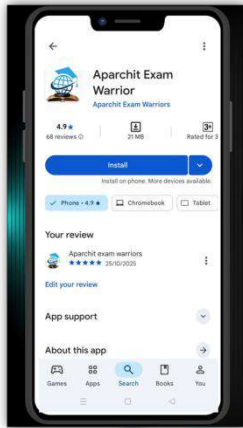
